5 WHEREAS, The ~~February-1998~~ TET festival celebrated the unique  
6 diversity of San Francisco; and,

7 WHEREAS, The TET festival, sponsored by the Vietnamese Community  
8 Center of San Francisco, is a celebration of the Vietnamese New Year,  
9 and presents the native culture of San Francisco's Vietnamese  
10 community; and,

11 WHEREAS, The holding of the TET festival requires the closure of  
12 streets within San Francisco; and,

13 WHEREAS, The Vietnamese Community Center is a non-profit  
14 organization and, due to financial hardship, is unable to pay these  
15 fees; and,

16 WHEREAS, The associated cost of the street closure for this  
17 festival is \$949.74; and,

18 WHEREAS, The Vietnamese Community Center did not benefit  
19 fiscally from holding the festival, but rather has aided the City by  
20 providing the opportunity to celebrate the diversity of San  
21 Francisco, and indeed subsidized the costs of the festival; now,  
22 therefore, be it

23 RESOLVED, That the Board of Supervisors hereby waives Police  
24 Department, Fire Department, and Department of Parking and Traffic




