WHEREAS, This Resolution requires expedited review by the Board of Supervisors to assure that documentation of specific grant funds can be provided to the State as early as possible in the funding year; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; now, therefore be it

RESOLVED, That the Board of Supervisors hereby approves the acceptance and expenditure by the San Francisco Department of Public Health of the State of California grants listed in the attached document, "Recurring FY 2003-2004 State Grants, Schedule A"; and, be it

FURTHER RESOLVED, That should the Department of Public Health receive more money or less money on any of the grants than is estimated in the attached document, that the Board of Supervisors hereby approves the acceptance and expenditure by the San Francisco Department of Public health of that additional or reduced money.
