16 WHEREAS, From 1995 until the summer of 2003, Mr. Moerschbaecher led the
17 Moscone Center Expansion Project in the development and construction of Moscone West,
18 the newest addition to the City's convention facilities; and,

19 WHEREAS, On September 29, 2003, Mr. Moerschbaecher will receive the 2003
20 Unsung Hero/Heroine Award from the Yerba Buena Alliance at its 12th anniversary reception;




