WHEREAS, This recognition will encourage self-esteem, pride, and self-awareness in American Indians, Alaska Natives and Native Hawaiians of all ages; and,

WHEREAS, By celebrating National American Indian Heritage month, we reaffirm our commitment to remember those contributions and to honor the unique heritage of our continent's first inhabitants; and,

WHEREAS, This special observance reflects the rich heritage and great influence that American Indians, Alaska Natives and Hawaiians have contributed to the nation's history and culture; now, therefore, be it
