

1 [Approval of Modification No. 1 of Lease and Operating Agreement L-99-0321 with Cathay  
2 Pacific Airways, Ltd., at San Francisco International Airport.]

4 **Resolution approving and authorizing the execution of Modification No. 1 of Lease and**  
5 **Operating Agreement L-99-0321 with Cathay Pacific Airways, Ltd., for office space in**  
6 **the International Terminal of San Francisco International Airport.**

8 WHEREAS, by Airport Commission Resolution No. 99-0321, the Airport Commission  
9 approved Lease and Operating Agreement L-99-0321 (the "Lease"), adopted on  
10 September 21, 1999, between Cathay Pacific Airways, Ltd., ("Cathay") and San Francisco  
International Airport; and

11 WHEREAS, pursuant to the Lease, Cathay occupies approximately 713 square feet of  
12 Category II Exclusive Use Space, 856 square feet of Category III Exclusive Use Space, and  
13 all Categories of Joint Use Space in the International Terminal in order to operate its air  
carrier business; and

14 WHEREAS, Cathay also occupies approximately 48 square feet of Category II  
15 Exclusive Use Space in the International Terminal pursuant to Airline Terminal Space or Use  
16 Permit 3640 (the "Permit"), dated April 1, 2003; and

17 WHEREAS, Cathay is increasing its flight activity at the Airport and requires additional  
18 administrative office space in the International Terminal; and

19 WHEREAS, Cathay wishes to expand into approximately 343 square feet of vacant  
20 Category II space located adjacent to its current space and consolidate the 48 square feet of  
21 Category II space it occupies under the Permit into its Lease pursuant to Modification No. 1;  
and

22 WHEREAS, cumulatively, Modification No. 1 will add 391 square feet of Category II  
23 Exclusive Use Space to the Lease and increase annual Lease revenues by \$46,846; and

1 WHEREAS, a copy of the form of Modification No. 1 is on file with the Clerk of the  
2 Board of Supervisors in File No. 071579, which is hereby declared to be a part of this  
3 resolution as if set forth fully herein; now, therefore, be it

4 RESOLVED, that this Board of Supervisors hereby approves and authorizes the  
5 execution of Modification No. 1 to Lease and Operating Agreement L-99-0321 between  
6 Cathay Pacific Airways, Ltd., and the City and County of San Francisco, acting by and through  
7 its Airport Commission.


