

1 [Affirming the categorical exemption issued for the 800-808 Lyon Street/1980-1988 Golden  
2 Gate Avenue project.]

4 **Motion affirming the determination by the Planning Department that the 800-808 Lyon**  
5 **Street/1980-1988 Golden Gate Avenue project is categorically exempt from**  
6 **environmental review under the California Environmental Quality Act.**

8 WHEREAS, On September 2, 2008, the Planning Department issued a memorandum  
9 stating that it had determined (the "determination") that the project located at 800-808 Lyon  
10 Street/1980-1988 Golden Gate Avenue (the "Project") was categorically exempt from  
11 environmental review under the California Environmental Quality Act ("CEQA"). A copy of  
12 said document is on file with the Clerk of the Board of Supervisors in File No. 081171, and is  
13 incorporated by reference herein; and,

14 WHEREAS, On September 3, 2008, Raquel Fox, on behalf of the Tenderloin Housing  
15 Clinic, Inc. ("Appellant") filed an appeal dated September 3, 2008, with the Clerk of the Board  
16 of Supervisors of the determination by the Planning Department; and,

17 WHEREAS, On October 7, 2008, this Board held a duly noticed public hearing to  
18 consider the appeal of the determination; and,

19 WHEREAS, This Board has reviewed and considered the determination, the appeal  
20 letter, the responses to concerns document that the Planning Department prepared, and  
21 public testimony; and,

22 WHEREAS, The determination files and all correspondence and other documents have  
23 been made available for review by this Board and the public. These files are available for  
24 public review by appointment at the Planning Department offices at 1660 Mission Street, and  
25 are part of the record before this Board by reference herein; now, therefore, be it

1 Moved, That this Board of Supervisors affirms the determination by the Planning  
2 Department that the Project is exempt/excluded from environmental review.


