[Affirm certification of 55 Laguna Street Mixed Use Project FEIR]

Motion affirming the certification by the Planning Commission of the Final Environmental Impact Report for the 55 Laguna Street Mixed Use Project.

WHEREAS, A. F. Evans Development, Inc. (the "Project Sponsor") is proposing to construct on the existing University of California extension site bounded by Laguna, Haight, Buchanan and Hermann Streets, seven (7) new buildings and adaptively reuse three (3) existing buildings to create approximately 330 dwelling units, a large institutional residential care facility to accommodate senior residents, approximately 12,000 square feet of community facility space, no more than 4,999 occupied square feet of commercial/retail space, approximately 310 off-street parking spaces, an approximately 25,000 square foot publicly-accessible park on the former Waller Street right-of-way and a community garden of approximately 10,000 square feet; and

WHEREAS, the Project Sponsor applied for a project permit and environmental review on August 4, 2004 (City Planning File No. 2004.0773E); and

WHEREAS, The Planning Department for the City and County of San Francisco (the "Department") determined that an Environmental Impact Report ("EIR") was required and provided public notice of that determination by publication in a newspaper of general circulation on May 6, 2006; and

WHEREAS, On January 27, 2007, the Department published the Draft Environmental Impact Report ("DEIR") for the Project; and

WHEREAS, On April 19, 2007, the Commission held a duly noticed public hearing on the DEIR, at which time opportunity for public comment was received on the DEIR, and written comments were received through May 2, 2007; and

WHEREAS, The Department prepared responses to comments received at the public hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text of the DEIR and published a Draft Summary of Comments and Responses on November 29, 2007; and

WHEREAS, A Final Environmental Impact Report ("FEIR") for the Project was prepared by the Department, consisting of the DEIR, any consultations and comments received during the review process, any additional information that became available and the Draft Summary of Comments and Responses, all as required by law; and

WHEREAS, On January 17, 2008, the Commission reviewed and considered the FEIR and, by Motion No. 17532, found that the contents of said report and the procedures through which the FEIR was prepared, publicized and reviewed complied with the provisions of the California Environmental Quality Act (CEQA), the State CEQA Guidelines and Chapter 31 of the San Francisco Administrative Code; and

WHEREAS, By Motion No. 17532, the Commission found the FEIR to be adequate, accurate and objective, reflected the independent judgment and analysis of the Department and the Commission and that the Summary of Comments and Responses contained no significant revisions to the DEIR, adopted findings relating to significant impacts associated with the Project and certified the completion of the FEIR in compliance with CEQA and the State CEQA Guidelines; and

WHEREAS, On January 17, 2008, by Motion Nos. 17533,, 17534 and 17537 and Resolution Nos. 17535 and 17536, the Commission took various approval actions related to the project; and

WHEREAS, On February 6, 2008, Cynthia Servetnick, on behalf of Save the Laguna Street Campus, filed an appeal of the FEIR with the Clerk of the Board of Supervisors; and

WHEREAS, The Board of Supervisors held a public hearing on March 4, 2008, to review the decision by the Planning Commission to certify the FEIR; and
