17 WHEREAS, The women's soccer team has left a positive and  
18 lasting impression particularly among young women and girls; and,

19 WHEREAS, The tournament and team proved that women's sports  
20 can draw large crowds and support from a cross section of our  
21 nation's population; and,

22 WHEREAS, No other US women's team has ever been equally  
23 embraced by the public; now, therefore, be it
