RESOLUTION NO. 741-99

AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND PREVENTION DIVISION, TO ENTER RETROACTIVELY INTO A SUBCONTRACT IN THE AMOUNT OF \$87,864 WITH THE UNIVERSITY OF CALIFORNIA INSTITUTE OF HEALTH POLICY STUDIES, THE PRIMARY CONTRACTOR, TO SUPPORT RESEARCH ACTIVITIES TO EVALUATE THE IMPACT OF TREATMENT ON DEMAND POLICIES, WHICH DOES NOT INCLUDE PATENT INFRINGEMENT INDEMNIFICATION AND FALSE CLAIMS CLAUSES; PROVIDING FOR RATIFICATION OF ACTION PREVIOUSLY TAKEN.

WHEREAS, The University of California Institute of Health Policy Studies has awarded a subcontract to The Department of Health, City and County of San Francisco in the amount of \$87,864 to support the activities of Alice Gleghorn, Ph.D., to evaluate the impact of treatment on demand policies; and,

WHEREAS, This is a collaborative project of the University of California, Institute for Health Policy Studies and the Department of Health, Community Substance Abuse Services, for a project entitled, "Drug Abuse Treatment on Demand Impacts in San Francisco"; and,

WHEREAS, As a condition of receiving the funds, the University of California requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 991305 ; and,

WHEREAS, The University of California has indicated that it will not agree to any modification to the form of the Agreement; and,

WHEREAS, The Agreement does not contain certain provisions described below, which are required under the Administrative Code unless waived by the Board of Supervisors; now, therefore, be it

RESOLVED, That the San Francisco City and County Department of Public Health is hereby authorized to enter into a subcontract in the amount of \$87,864 with the University of California Institute of Health Policy Studies, the Primary Contractor; retroactive to January 1, 1999; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it


1 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement

3 indemnification of the City by The Regents of the University of California for the infringement of patent

5 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement
6 contained in Section 6.57(c) of the Administrative Code that the Agreement include a paragraph reciting
7 the false claim provisions contained in Section 6.57(a) of the Administrative Code; and, be it

8 FURTHER RESOLVED, That although the City has incurred no legal obligation, the Board of
9 Supervisors does hereby ratify the action previously taken; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Public Health
11 to enter into similar agreements with the University of California if the contract recurs or is renewed; and, be
12 it

13 FURTHER RESOLVED, The Controller should be urged to designate the position
14 RECOMMENDED: created under the grant as a APPROVED:
15 "G" or grant-funded position,
16 which would terminate when the grant
17 expires.




