2 CONCURRING WITH THE GENERAL RECOMMENDATIONS OF THE PARK AND OPEN
3 SPACE FUND FOR FISCAL YEAR 1999-2000, RESERVING APPROVAL OR
4 DISAPPROVAL ON SPECIFIC ACQUISITIONS.

6 WHEREAS, The Charter of the City and County of San Francisco,
7 Section 16.107, established a Park and Open Space Fund, to be
8 administered by the Recreation and Park Commission; and,

9 WHEREAS, Charter Section 16.107(d) states that the Recreation
10 and Park Commission and City Planning Commission shall hold at least
11 one joint public meeting annually and shall at such time receive a
12 report from the General Manager of the Recreation and Park Department
13 on the implementation of the Park and Open Space Program; and,

14 WHEREAS, The report of the San Francisco Park and Open Space
15 Program, Fiscal Year 1999-2000, was approved and adopted by both the
16 Recreation and Park Commission and the City Planning Commission,
17 meeting jointly on May 13, 1999; now, therefore, be it

18 RESOLVED, That pursuant to Charter Section 16.107(d), the Board
19 of Supervisors of the City and County of San Francisco hereby concurs
20 with the recommendations of the Acting General Manager of the
21 Recreation and Park Department, including any recommended
22 reallocations and rescission of allocations, which recommendations
23 were approved by the Recreation and Park Commission and the City
24 Planning Commission jointly on May 13, 1999; and, be it

7 private sources that can be devoted to King Pool in excess of the
8 amount required to complete its construction, those funds would be
9 used to replace funds reprogrammed from Esprit Park.
