12	Section 1. The San Francisco Administrative Code is hereby amended by amending Section 10.100-18,		
13	to read as follows:		
14	SEC. 10.100-18. AIRPORT TERMINAL 2 CAPITAL IMPROVEMENT PROMOTION AND		
15	<u>EVENT</u> FUND.		
16	(a) Establishment of the Airport Terminal 2-Capital Improvement Promotion and Event		
17	Fund. Airport Terminal 2 Capital Improvement Promotion and Event Fund is hereby established		
18	as a category six fund for the purpose of receiving all donations of money, property and		
19	personal services which may be offered to the City and County of San Francisco through the		
20	Airport for the uses described in subsection (b).		
21	(b) Use of the Airport Terminal 2 Capital Improvement Promotion and Event Fund. Money		
22	property and personal services comprising the Fund shall be used and expended for such		
23	purposes as will be determined in the sole discretion of the Airport Commission to assist in		
24	promotional events and community outreach activities associated with the opening of the newly		

renovated Terminal 2capital improvements of the San Francisco International Airport. The Fund

1	shall have a separate accounting for each capital improvement project as determined by the Airport		
2	Commission.		
3	(c) Exceptions to Fund Category. Money, property and personal services comprising		
4	the Airport Terminal 2 Capital Improvement Promotion and Event Fund shall be expended for to		
5	promote the capital improvement project for which the donation was made, such purposes as will be		
6	determined in at the sole discretion of the Airport Commission. Any unexpended balances		
7	remaining in the Fund when it expires on December 31, 201123 shall be deposited in the		
8	City's General Fund.		
9	(d) Administration of Fund. The Airport Director shall submit to the Board of Supervisors and the Budge		
10	Analyst on a bi monthly quarterly basis written reports of revenues to and expenditures from the Airport Terminal		
11	<u>Capital Improvement</u> Promotion <u>and Event</u> Fund during the <u>bi monthly quarterly</u> period covered by the report. This		
12	fund shall expire on December 31, 20 <i>11</i> 23.
