3	Resolution approving and authorizing the execution of Lease No. L13-0071 for a
4	portion of the SuperBay Hangar and appurtenant land to be occupied by American
5	Airlines, Inc., at Plot 40 at the San Francisco International Airport for \$4,355,869
6	annually for a term of three-years with two one-year options to commence upon final
7	approval.
8	
9	WHEREAS, American Airlines, Inc. ("American") occupies a portion of the SuperBay
10	Hangar and appurtenant land at Plot 40 for aircraft maintenance, aircraft and employee
11	parking, ground service equipment ("GSE") maintenance and related activities pursuant to
12	Lease L04-0221, approved by Commission Resolution No. 04-0221, adopted on November 2
13	2004, and Board of Supervisors' Resolution No. 57-05, adopted January 25, 2005; and,
14	WHEREAS, The aforementioned lease has a term a four and one/half years that
15	expired on June 30, 2009 and is currently on hold over status; and
16	WHEREAS, American wishes to enter into a new lease to continue its aircraft
17	maintenance, GSE maintenance and related activities; and
18	WHEREAS, Airport staff and American have negotiated a lease with a term of three-
19	years with two (2) one-year options for approximately one hundred sixty six thousand eight
20	hundred (166,800) square feet of hangar space and twenty three and fifty eight one
21	hundredths (23.58) acres of land, and eleven thousand five hundred (11,500) square feet of
22	GSE space at Plot 40 (the "Lease") at a rent of \$4,355,869.00 per annum; and
23	WHEREAS, On April 2, 2013, pursuant to Resolution No. 13-0071, the Airport
24	Commission approved the Lease with American. A copy of the form of the Lease is on file

1	with the Clerk of the Board of Supervisors in File No. 130777, which is hereby declared to be
2	a part of this resolution as is set forth fully herein; now, therefore, be it
3	RESOLVED, That this Board of Supervisors hereby approves the three (3) year Lease
4	with two one-year options for a portion of the SuperBay Hangar and appurtenant land at Plot
5	40 between American Airlines and the City and County of San Francisco, acting by and
6	through its Airport Commission, and, be it
7	FURTHER RESOLVED, That within thirty (30) days of the lease being fully executed
8	by all parties, the Director of the Airport shall provide the final lease to the Clerk of the Board
9	for inclusion into the official file.
