Resolution amending the terms of existing Local Agency Formation Commission (LAFCo) positions by expanding the scope of services for the Senior Program Officer, extending the term of employment for an additional three years, and utilizing the existing LAFCo budget to continue funding this position.

[Terms of Existing Local Agency Formation Commission Positions]

WHEREAS, Under Ordinance 0146-07, the Board of Supervisors directed the San Francisco LAFCo to assist with the startup of the Community Choice Aggregation (CCA) program and to advise the Board of Supervisors, San Francisco Public Utilities Commission (SFPUC), and other agencies regarding all aspects of development, implementation, operation, and management of the CCA program; and

WHEREAS, By adopting Resolution number 2007-01 on September 28, 2007, LAFCo accepted responsibility to provide monitoring and advice to the Board of Supervisors, SFPUC, and other agencies regarding the CCA Program; and

WHEREAS, In March 2009, the Board of Supervisors passed Ordinance No. 141-08, amending the Annual Salary Ordinance to include additional staff positions for LAFCo, including a 9775 Senior Community Development Specialist II position, a classification which allows for all duties currently performed by the Interim Executive Officer, and a 9770 Community Development Assistant to support the development and implementation of the CCA program; and

WHEREAS, In August 2012, the Interim Executive Officer recommended and the Commission approved a one-year extension of LAFCO staff positions through June 30, 2013; and

WHEREAS, These positions were initially established as short-term positions, to advise

the Board of Supervisors, SFPUC, and other agencies regarding all aspects of development, implementation, operation, and management of the CCA program; and

WHEREAS, The current stage of the CCA program does not require the same level of LAFCo staff time for monitoring and assistance, allowing staff and the Commission to pursue LAFCo projects and other special projects, including research and reporting on various studies of regional operations and policies; and

WHEREAS, A change in the LAFCo staffing structure would reflect the changing needs of the commission members and would be more cost effective; and

WHEREAS, On June 28, 2013, LAFCo unanimously passed a resolution urging the Board of Supervisors to make amendments to the terms of existing LAFCo positions; and

WHEREAS, The LAFCo staff time for CCA, LAFCo projects, and other special projects will be tracked and reported as billable hours to allow the correct funding source to pay for actual work hours; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby amends the terms of existing LAFCo positions by expanding the scope of services of the 9775 Senior Community Development Specialist II position to include all duties currently performed by the Interim Executive Officer, extends the term of the 9775 Senior Community Development Specialist II position for an additional three years through June 30, 2016, and utilizes the funding currently available in the LAFCo budget for these purposes.
