MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Child Care Planning and Advisory Council, pursuant to the provisions of the Administrative Code, Section 5.200, and California Education Code, Sections 8499-8499.8, for the terms specified:

Melinda Kanter-Levy, seat 2, residency requirement waived, succeeding herself, term expired, must be a nominee of District 2 Supervisor, and a consumer or a child care provider, for the unexpired portion of a three-year term ending March 19, 2016.

Lourdes Alarcon, seat 8, succeeding herself, term expired, must be a nominee of District 8 Supervisor, and a consumer or a child care provider, for the unexpired portion of a three-year term ending March 19, 2016.

FURTHER MOVED, That the Board of Supervisors makes the following findings:
