2	Ordinance amending San Francisco Administrative Code, Section 10.100-18, to
3	establish a special fund to receive donations and authorize expenditures for the
4	purpose of holding events to promote the opening of major capital improvement
5	projects at the San Francisco International Airport; and deleting obsolete provisions.

10	Be it ordained by the People of the City and County:
11	Section 1. The San Francisco Administrative Code is hereby amended by amending
12	Section 10.100-18, to read as follows:
13	SEC. 10.100-18. AIRPORT TERMINAL 2 CAPITAL IMPROVEMENT PROMOTION AND
14	<u>EVENT</u> FUND.
15	(a) Establishment of the Airport Terminal 2 Capital Improvement Promotion and Even
16	Fund. Airport Terminal 2 Capital Improvement Promotion and Event Fund is hereby
17	established-as a category six fund for the purpose of receiving all donations of money,
18	property and personal services which may be offered to the City and County of San Francisco
19	through the Airport for the uses described in subsection (b).
20	(b) Use of the Airport Terminal 2 Capital Improvement Promotion and Event Fund.
21	Money, property and personal services comprising the Fund shall be used and expended for
22	such purposes as will be determined in the sole discretion of the Airport Commission to assis
23	in promotional events and community outreach activities associated with the opening of the
24	newly renovated Terminal 2 capital improvements of the San Francisco International Airport.

1	I he Fund shall have a separate accounting for each capital improvement project as
2	determined by the Airport Commission.
3	(c) Exceptions to Fund Category. Money, property and personal services comprising
4	the Airport <i>Terminal 2 Capital Improvement</i> Promotion <i>and Event</i> Fund shall be expended <i>for</i>
5	to promote the capital improvement project for which the donation was made, such purposes
6	as will be determined in at the sole discretion of the Airport Commission. Any unexpended
7	balances remaining in the Fund when it expires on December 31, 20-11-23 shall be deposited
8	in the City's General Fund.
9	(d) Administration of Fund. The Airport Director shall submit to the Board of
10	Supervisors and the Budget Analyst on an bi-monthlyquarterly annual basis written reports of
11	revenues to and expenditures from the Airport Terminal 2 Capital Improvement Promotion and
12	Event Fund during the bi-monthly quarterly annual period covered by the report. This fund
13	shall expire on December 31, 20-11-23. Acceptance of donations of \$100,000 or greater shall
14	require Board of Supervisors approval by resolution.
