Due to structural underfunding in the budget and ACC's Open Door Shelter policy, which requires the agency to take in all animals regardless of budget and operational capacity, the Department is not able to fully perform all of its responsibilities. Since 2007, ACC has seen an almost 50% increase in the number of dogs taken in. Dogs are the most resource-intensive animals the ACC handles. The number of animal cruelty cases (which require investigations, hearings, and care for the animals) has doubled in the last year. Due to underfunding, ACC does not have the budget for the full number of Animal Control Officers (ACOs) needed to perform the Department's functions in the field.
