Resolution approving Amendment No. 2 of the Rental Car Center Operations Lease Agreements with The Hertz Corporation, Avis Budget Car Rental, LLC, EAN-Northern California, LLC, DTG Operations, Inc., and Fox Rent A Car, Inc. for the period of January 1, 2014, through December 31, 2018.

WHEREAS, The Airport Commission adopted Resolution Nos. 08-0153, 08-0154, 08-0155, 08-0156, and 08-0157, on August 19, 2008, awarding the Rental Car Center Operations Leases (the "Leases") to The Hertz Corporation; Avis Budget Car Rental, LLC; EAN-Northern California, LLC; DTG Operations, Inc.; and Fox Rent A Car, Inc. (collectively, the "Tenants"), respectively; and

WHEREAS, The Board of Supervisors approved and adopted the Leases on December 16, 2008 by Board of Supervisors Resolution No. 509-08; and

WHEREAS, The Airport issued Amendment No. 1 to the Leases, correcting the actual square feet allotted to each Tenant and the associated Space and Structure Rents, which did not require Airport Commission and Board of Supervisors approval; and

WHEREAS, The Airport Commission adopted Resolution Nos. 13-0088 through 13-0092, on April 16, 2013, approving Amendment No. 2 to the Leases (1) allowing for the early termination of the Leases under certain circumstances; (2) approving the co-location of family brands during the 2014 reallocation of space; (3) approving the exclusion of toll collection charges from the definition of Gross Revenues; (4) revising the Space and Structure Rent calculations; and (5) authorizing the Airport Director to approve subleasing requests between on-Airport operators at his or her discretion; now, therefore, be it

Airport Commission BOARD OF SUPERVISORS RESOLVED, That this Board of Supervisors approves Amendment No. 2 to the Rental Car Center Lease Agreements, with The Hertz Corporation; Avis Budget Car Rental; LLC, EAN-Northern California, LLC; DTG Operations, Inc.; and Fox Rent A Car, Inc., copies of which are on file with the Clerk of the Board of Supervisors in File No. <u>130778</u> and is hereby declared to be a part of this resolution as if set forth fully herein; and, be it
