[Approving Waiver, Adjustment or Reduction of Condominium Conversion Fee - 273A-29th Street]

Motion approving a waiver, adjustment or reduction of the condominium conversion fee in Subdivision Code Section 1396.4(j) for 273A-29th Street.

WHEREAS, On August 16, 2013, Appellants Jasmine Oberste and Michele Smart submitted an application for condominium conversion under Subdivision Code Section 1396.4(j) for the building located at 273A-29th Street, Assessor's Block No. 6633, Lot No. 025; and

WHEREAS, On September 26, 2013, the Appellants filed a timely appeal to the Board of Supervisors for a reduction, adjustment or waiver of the fee requirements based upon the absence of any reasonable relationship or nexus between the impact of development and the amount of the fee charged; and

WHEREAS, On November 19, 2013, this Board held a duly noticed public hearing to consider the appeal filed by the Appellants; and

WHEREAS, This Board has reviewed and considered all documents submitted by the Appellants and all other written records before the Board of Supervisors, and heard testimony and received public comment regarding the appeal. Said documents and testimony are incorporated herein by reference; now, therefore, be it

MOVED, That the Board concludes that the Appellants have met the burden of presenting substantial evidence to support the appeal, including comparable technical information to support the Appellants' position that there is no reasonable relationship or nexus between the impact of development and the amount of the fee charged; and be it

FURTHER MOVED, That the Board approves the Appellants' request to waive, adjust or reduce the fee, and hereby waives the fee (or) adjusts the fee to \$16,000 pursuant to

Clerk of the Board BOARD OF SUPERVISORS Subdivision Code Section 1396.4(j). This waiver, adjustment or reduction shall not be valid if the use or scope of the project changes in any way, and in that event, the Appellants shall pay the full fee required under Section 1396.4(j) unless the Board waives, reduces or adjusts that fee; and be it

FURTHER MOVED, That the Board directs the Clerk of the Board to promptly transmit to the Treasurer and the Department of Public Works notice of the Board's decision in this appeal.
