Resolution approving re-designation of one selling space on Leavenworth Street, west side, at Jefferson Street, for six months for street artists certified by the Arts Commission, City and County of San Francisco; exempting said space from the regulations of Police Code, Section 2405(c)(6) and (11), prohibiting selling within ten feet from the outer edge of any entrance to any building and prohibiting selling within five feet of the display of any other street artist.

[Street Artist Space - Leavenworth Street at Jefferson Street]

WHEREAS, The Street Artists Ordinance adopted by the voters of San Francisco as Proposition "L" at the election held on November 4, 1975, authorizes the Board of Supervisors, by resolution, to designate sales areas where any street artist or craftsperson previously certified may sell art or craft items; and

WHEREAS, The Board of Supervisors by Resolution No. 572-77 previously designated ten (10) spaces on Leavenworth Street, west side, Jefferson to Beach streets, as a street artist sales area; and

WHEREAS, In the 1980's the creation of a doorway in The Cannery building adjacent to the first two of the above described ten spaces rendered the first two spaces in violation of Police Code Section 2405(c)(6) which prohibits street artists from selling, offering for sale, or soliciting offers to purchase on any sidewalk within ten (10) feet from the outer edge of any entrance to any building measured in each direction parallel to the building line and thence at a 90-degree angle to the curb; and

WHEREAS, Ordinance No. 388-83 authorizes the Board of Supervisors in a resolution designating or re-designating spaces in a street artist sales area to exempt the area from one or more of the regulations set forth in subsection (c) of Police Code Section 2405 if the Board

finds that the exemption will not be inconsistent with or interfere with the purposes of the regulation from which the area is exempted; and

WHEREAS, The Board of Supervisors by Resolution No. 629-89 and Resolution No.407-90 re-designated for one (1) year the above-described first two spaces, known as space "Leavenworth-1" and space "Leavenworth-2", by exempting them from the regulation of Police Code Section 2405(c)(6); and

WHEREAS, The Arts Commission in a review of a proposal to request re-designation of one of the two spaces determined that a prohibition of street artists from selling in the above-described space "Leavenworth-2" represents a severe hardship for artists, especially those artists who have sold their wares in the spaces since 1977; and

WHEREAS, The Arts Commission on December 3, 2012 unanimously approved a request to the Board of Supervisors to re-designate for a trial period of six (6) months space "Leavenworth-2" only and subject to its exemption from the regulations of Police Code Section 2405(c)(6) and its exemption from Police Code Section 2405(c)(11) which prohibits a street artist from selling within five (5) feet of the display of any other street artist; and

WHEREAS, The Board of Supervisors in Resolution No. 053-13 approved the redesignation for a trial period of six (6) months space "Leavenworth-2" and its exemption from Police Code Section 2405(c)(6) and (c)(11); and

WHEREAS, The Arts Commission on October 7, 2013 unanimously approved a request to the Board of Supervisors to re-designate for a trial period of six (6) months space "Leavenworth-2" and subject to its exemption from the regulations of Police Code Section 2405(c)(6) and (c)(11);

WHEREAS, The Board of Supervisors finds that space "Leavenworth-2" on Leavenworth Street, west side, Jefferson to Beach streets, will not be inconsistent with or

interfere with the purpose of the adjacent entrance of the store in The Cannery building; now, therefore be it

RESOLVED, That the following selling space is hereby re-designated for six (6) months for street artists certified by the Arts Commission:

Spaces:

1 – Leavenworth Street (space "Leavenworth-2"), Jefferson to Beach streets.

FURTHER RESOLVED, That space "Leavenworth-2" is hereby exempt from the provision of Police Code Section 2405(c)(6) which prohibits street artists from selling within ten (10) feet of the outer edge of any entrance to any building including, but not limited to, doors, driveways, emergency exits measured in each direction parallel to the building line and thence at a 90-degree angle to the curb; and be it

FURTHER RESOLVED, That said space is hereby exempt from the provision of Police Code Section 2405(c)(11) which prohibits a street artist from selling within five (5) feet of the display of any other street artist.

Subject: Resolution approving re-designation for 6 months 1 temporary selling space on Leavenworth Street, west side, at Jefferson Street, for street artists certified by Arts Commission; exempting space from Police Code Section 2405 relating to artists selling near an entrance and near each other

Dear Ms. Calvillo:

On behalf of the Arts Commission and its licensed street artists, we are respectfully requesting that you please submit to the Board the enclosed resolution approving re-designation for six (6) months one (1) temporary street artist selling space on Leavenworth Street, west side, at Jefferson Street.

The space was one of ten street artist spaces on the west side of Leavenworth Street at Jefferson Street previously approved by the Board of Supervisors in 1977 in Resolution No. 572-77. In the 1980's the creation of a doorway in the adjacent Cannery building rendered the first two spaces in violation of Police Code Section 2405(c)(6) which prohibits street artists from selling within ten feet from the outer edge of an entrance of a building. Subsequently, the Board of Supervisors in Resolution Nos. 629-89 and 407-90 re-designated for one year only the two spaces, known as "Leavenworth-1" and "Leavenworth-2", by exempting them from the Police Code regulation.

On December 3, 2012, the Arts Commission, after hearing a proposal from its staff and representatives of the street artists and The Cannery, unanimously voted to request the Board of Supervisors to re-designate for six months the one space known as "Leavenworth-2" subject to its exemption from Police Code Section 2405(c)(6), which prohibits artists from selling within ten feet of an entrance, as well as its exemption from Police Code Section 2405(c)(11) which prohibits a street artist from selling within five feet of another street artist (it was recommended that the space be relocated four feet from the next space, "Leavenworth-3"). Subsequently, the Board of Supervisors in Resolution No. 053-13 approved the redesignation of space "Leavenworth-2" for a trial period of six months with its exemption from Police Code Section 2405(c)(6) and (c)(11).

On October 7, 2013, the full Arts Commission unanimously voted to request the Board of Supervisors to redesignate the space for another six months with the same exemption.

We would greatly appreciate your submitting the enclosed resolution to the Board for its referral to the Land Use Committee.


