8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Thomas Cooke, III, et al. v. City and
11 County of San Francisco, San Francisco Superior Court, Case No. CGC-11-515143 by the
12 payment of \$650,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 August 31, 2011, and the following parties were named in the lawsuit: Plaintiff: Thomas
15 Cooke, III; Defendant: City and County of San Francisco.
