11	Be it ordained by the People of the City and County of San Francisco:		
12	Section 1. The Planning Department has determined that the actions contemplated in		
13	this ordinance comply with the California Environmental Quality Act (California Public		
14	Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the		
15 16	Board of Supervisors in File No. 131087 and is incorporated herein by reference.		
17	Section 2	2. The Park Code is hereby amended by revising Section 7.15, and adding	
18	Section 7.15-1, to read as follows:		
19	SEC. 7.15. PERMITS— RIGHTS GRANTED EVENTS OPEN TO THE PUBLIC.		
20	<u>(a) </u> Any p	person possessing a valid permit, which states that an area <u>or facility</u> has been	
21	reserved for such person's use other than for an event covered by Section 7.15-1, has the exclusive		
22	right to use the area or facility specified designated in the permit for the time specified.		
23	(b) It shall be unlawful for any person to refuse to leave an area or facility which has been		
24	reserved by a valid permit when asked to do so by the person or party displaying such permit, by a		
25	Recreation and Park Department employee, by a police officer, or by a member of the Park Patrol, and		

1	nN operson shall in any manner disturb or interfere with any person or party occupying the
2	area or facility under a permit described in subsection (a), nor with the belongings of such
3	person or party.
4	(c) It shall be unlawful for a person who violates subsection (b) to refuse to leave an area or
5	facility that has been reserved by a valid permit when asked to do so by the person or party displaying
6	such a permit, by a Recreation and Park Department employee, by a police officer, or by a member of
7	the Park Patrol.
8	(d) This Section shall not be used to impinge upon the lawful exercise of constitutionally
9	protected rights of freedom of speech or assembly.
10	SEC. 7.15-1. PERMITS – EVENTS CLOSED TO THE PUBLIC.
11	(a) Any person possessing a valid permit, which states that an area or facility has been
12	reserved for such person's use to conduct an event that is not open to the general public, such as a
13	ticketed or guest-list event or an event limited to the members of an organization and their invitees, has
14	the exclusive right to use the area or facility designated in the permit for the time specified.
15	(b) It shall be unlawful for any person to refuse to leave an area or facility under a permit as
16	described in subsection (a) when asked to do so by the person or party displaying such a permit, by a
17	Recreation and Park Department employee, by a police officer, or by a member of the Park Patrol.
18	(c) This Section shall not be used to engage in conduct otherwise prohibited by law, including
19	but not limited to anti-discrimination laws.
20	
21	Section 3. Effective Date. This ordinance shall become effective 30 days after
22	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
23	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
24	of Supervisors overrides the Mayor's veto of the ordinance.

1	Section 4. In enacting this ordinance, the Board intends to amend only those words
2	phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts,
3	diagrams, or any other constituent parts of the Park Code that are explicitly shown in this
4	ordinance as additions, deletions, Board amendment additions, and Board amendment
5	deletions in accordance with the "Note" that appears under the official title of the ordinance.
