WHEREAS, On November October 29, 2013, Supervisor Wiener introduced legislation amending the Planning Code to expand the definition of "bona fide eating place" to include a definition based on food sales per occupant; and making environmental findings, and findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1. A copy of said legislation is on file with the Clerk of the Board of Supervisors in File No. 131064 and is incorporated herein by reference; and
