Motion appointing John Austin and Rebecca Delgado Rottman, terms ending April 10, 2015, to the Graffiti Advisory Board.

MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Graffiti Advisory Board, pursuant to the provisions of Administrative Code, Section 5.170 et seq., for the terms specified:

John Austin, seat 12, succeeding Michael Grgich, resigned, must represent youth groups who provide services for juveniles involved in alternative programs for graffiti diversion, for the unexpired portion of a two-year term ending April 10, 2015.

Rebecca Delgado Rottman, seat 16, succeeding herself, term expired, must represent private schools or art schools who operate in San Francisco, for the unexpired portion of a two-year term ending April 10, 2015.

Business and/or professional experience:

As a vice president of community and government relations, Rebecca Delgado Rottman reaches out to various communities in San Francisco, assesses their needs as well as develop partnership opportunities that result in win-win outcome for all parties. Non-Profit organizations and City Agencies who have limited finances benefit from partnering with private organizations like the Academy of Art University. Students from the University also benefit by having the opportunity to work in real-world projects and are able to give-back to their community.

In spring of 2013, the stude rts from the School of Fine Art at the Academy of Art painted a 30 x 13-fi. mural on the wall of the old historic building, Bristol Hotel in the Tenderloin to revive and beautify the neighborhood. In fail of 2013, the students completed the largest public art mural, 116 ft, wide and 50 ft, high on the wall of 150 Hayes which was dedicated to the failen America's Cup Sailor, Andrew Bart Simpson. The Academy students from the School of Advertising and Graphic Design collaborated with the City's SFMTA and SFPD to design a "Crime Prevention" campelain. In spring of 2012, the students from the School of Landscape Architecture collaborated with Aquatic Park Neighbors, North Beach Neighbors, Russian Hill Improvements Association and Russian Hill Neighbors to design programs and uses for the public open space at Francisco Reservoir which was presented to the neighborhood community meetings. And last but not least, in spring 2012, the students from the School of Landscape Architecture partnered with Fisherman's Whart CBD to re-design Doseph Cornad Park on Beach at Columbus to beautify the park.

Rebecca Delgado Rottman developed the education scholarship initiative and partnered with the SFUSD wherein 100 Scholarships to the Pre-College Summer Art Program were provided by the Academy of Art University to low-income families, At-Risk Youth, Youth In-Judicial Court Transition, inner-city youth as well as youths being served by non-profit organizations. The youth are exposed in a college environment and taught professional skills in art and design. The ultimate goal is to provide the youth opportunities, Inspiration and motivation to succeed in their academic and personal endeavors.

Civic Activities:

Under the tutelage of Rebecca Delgado Rottman, in 2004, the Academy of Art University established two program partnerships with SF DPW, specifically the Grafifd Watch Program and Community Clean Team. The Academy of Art adopted 18-city blocks: Post, Sutter, Bush & Pine Streets from Mason to Leavenworth. Through Ms. Delgado Rottman's guidance, the University's Kappa Sigma Fratemity babte grafifd on public properties and pick-up street litters every other weekend or seventeen times (17 x) a year when school is nession. Meanwhile, the Academy students residing in Academy's student housing volunteer consistently ten times (10 x) a year to DPW's Community Clean Team. The students paint over grafifd, plant trees, work in community gardens, as well as sweep and clean streets in different supervisional districts. The Academy budients roluteer consistently with DPW's Community Clean Team for about ten years now. In summer 2013, the University's Kappa Sigma Fraternity picked-up over 6,000 cigarette butts off several streets downtown.

For over seven years, Rebecca Delgado Rottman has been participating in the Grafifti Advisory Board, attending its monthly meetings and contributing to the board since 2007. She has served in the capacity of "Chain" to the Education Sub-Committee in 2008. In this capacity, she was involved in the research and development of the "best practices" of different anti-grafifti programs in partnership with SFUSD and SF Arts Commission. The Education Committee recommended Grafifti Hurts' curriculum for 5th grade teachers as a best practice, and reviewed the Arts Commission's "Where Art Lives' Curriculum. Ms. Delgado Rottman also served in the "Steering Committee" for the second anti-grafifti Super Huddle in 2009. She project maraged and co-produced the video, "Zero Graffit for a Beautiful City", see youtube link here https://www.youtube.com/watch?v=hWVn6FZOSUD or https://www.youtube.com/watch?v=1.z31dA5Q8U. The estimated volunteer value provided by individual students who dedicate their time, talents, and energy to making a difference, as organized by Rebecca Delgado Rottman at the Academy of Art University in year 20 13 was approximately \$500,000.00.

Board Qualifications:

The Graffiti Advisory Board consists of twenty-five (25) voting members who shall be appointed as follows:

A) One (1) member shall be the Mayor or his/her designee;

B) Eleven (11) persons appointed by individual members of the Board of Supervisors, to serve a term of two years, at the pleasure of the appointing Supervisor (these appointments shall be effective when written notice of the appointment is received by the Clerk of the Board of Supervisors); and

C) The Board of Supervisors shall appoint the following members, who shall serve a term of two years:

> One (1) member representing youth groups who provide services for juveniles involved in alternative programs for graffiti diversion;

> One (1) member representing nonprofit organizations that provide services related to the City's beautification and neighborhood cleanup programs;

> Two (2) members representing businesses who operate in San Francisco, one of which must be a property owner;

> One (1) member representing private schools or art schools who operate in San Francisco; and > One (1) member representing the contracting agency for Municipal Railway shelters; and

D) The following officials and organizations shall each appoint one (1) member to serve on the Advisory Board:

> The General Manager of the Municipal Railway,

> The Director of Public Works,

> The Executive Director of the Department of Parking and Traffic,

> The General Manager of the Recreation and Park Department,

> The District Attorney

> The Chief of Police

> The Board of Education of the San Francisco Unified School District may appoint one member. If the Board of Education fails to appoint a member within 60 days of a vacancy, the Board of Supervisors shall appoint a student, teacher, or member of the San Francisco Unified School District academic branch.

Reports: (a) Prepare and submit a report to the Board of Supervisors and the Mayor every six months on graffiti, as it affects neighborhoods and the downtown area of San Francisco, which shall include a review and evaluation of the services and programs in place to respond to graffiti, prevention strategies, recommendations, and plans for a consolidated program of public and private efforts;

(b) Advise about the coordination of information, activities and goals among existing programs funded by the City and County and privately sponsored programs; and

(c) Advise about improving the efficiency in the provision of graffiti enforcement, prevention, and clean-up services.
