24	When	never used in this Chapter, the following words and phrases shall have the

(a) "Activity expenses" means any expense incurred or payment made by a
lobbyist or a lobbyist's client at the behest of the lobbyist, or arranged by a lobbyist or a
lobbyist's client at the behest of the lobbyist, which benefits in whole or in part any: officer of

17	SEC. 2.110. REGISTRATION AND DISCLOSURES; FEES; TERMINATION OF
18	REGISTRATION.
19	(a) REGISTRATION OF LOBBYISTS REQUIRED. Lobbyists shall register with the
20	Ethics Commission and comply with the disclosure requirements imposed by this Chapter.
21	Such registration shall occur no later than five business days of qualifying as a lobbyist, but
22	the lobbyist shall register prior to making any additional contacts with an officer of the City and
23	County of San Francisco.
24	(b) REGISTRATION. At the time of initial registration each lobbyist shall report to the
25	Ethics Commission the following information:

1 (1) The name, business address, e-mail address, and business telephone number of 2 the lobbvist: 3 (2) The name, business address, and business telephone number of each client for whom the lobbyist is performing lobbyist services; 4 (3) The name, business address, and business telephone number of the lobbyist's 5 6 employer, firm or business affiliation; and 7 (4) Any other information required by the Ethics Commission consistent with the 8 purposes and provisions of this Chapter. 9 (c) LOBBYIST DISCLOSURES. For each calendar month, each lobbyist shall submit the following information no later than the fifteenth calendar day following the end of the 10 month: 11 12 (1) The name, business address and business telephone number of each person from 13 whom the lobbyist or the lobbyist's employer received or expected to receive economic 14 consideration to influence local legislative or administrative action during the reporting period; 15 (2) The name of each officer of the City and County of San Francisco with whom the 16 lobbyist made a contact during the reporting period; 17 (3) The date on which each contact was made; 18 (4) The local legislative or administrative action that the lobbyist sought to influence, 19 including, if any, the title and file number of any resolution, motion, appeal, application, 20 petition, nomination, ordinance, amendment, approval, referral, permit, license, entitlement, or 21 contract, and the outcome sought by the client; 22 (5) The client on whose behalf each contact was made; 23 (6) The amount of economic consideration received or expected by the lobbyist or the

lobbyist's employer from each client during the reporting period;

1 (7) All activity expenses incurred by the lobbyist during the reporting period, including 2 the following information: 3 (A) The date and amount of each activity expense; (B) The full name and official position, if any, of the beneficiary of each activity 4 5 expense, a description of the benefit, and the amount of the benefit; 6 (C) The full name of the payee of each activity expense if other than the beneficiary; 7 (D) Whenever a lobbyist is required to report a salary of an individual pursuant to this 8 Subsection, the lobbyist need only disclose whether the total salary payments made to the 9 individual during the reporting period was less than or equal to \$250, greater than \$250 but 10 less than or equal to \$1,000, greater than \$1,000 but less than or equal to \$10,000, or greater than \$10,000. 11 12 (8) All political contributions of \$100 or more made or delivered by the lobbyist or the 13 lobbyist's employer, or made by a client at the behest of the lobbyist or the lobbyist's employer 14 during the reporting period to an officer of the City and County, a candidate for such office, a 15 committee controlled by such officer or candidate, or a committee primarily formed to support 16 or oppose such officer or candidate, or any committee primarily formed to support or oppose a 17 ballot measure to be voted on only in San Francisco. This report shall include such political 18 contributions arranged by the lobbyist, or for which the lobbyist acted as an agent or 19 intermediary. 20 The following information regarding each political contribution shall be submitted to the 21 **Ethics Commission:** 22 (A) The amount of the contribution; 23 (B) The name of the contributor; (C) The date on which the contribution was made; 24

(D) The contributor's occupation;

1	(E) The contributor's employer, or if self-employed, the name of the contributor's
2	business; and
3	(F) The committee to which the contribution was made.
4	(9) For each contact at which a person providing purely technical data, analysis, or
5	expertise was present, as described in $\frac{Section\ 2.105(d)(1)(K)}{2.106(ab)(10)}$ , the name, address,
6	employer and area of expertise of the person providing the data, analysis or expertise.
7	(10) Any amendments to the lobbyist's registration information required by Subsection
8	(b).
9	(11) Any other information required by the Ethics Commission consistent with the
10	purposes and provisions of this Chapter.
11	(d) REGISTRATION AND FILING OF DISCLOSURES BY ORGANIZATIONS. The
12	Ethics Commission is authorized to establish procedures to permit the registration and filing of
13	lobbyist disclosures by a business, firm, or organization on behalf of the individual lobbyists
14	employed by those businesses, firms, or organizations.
15	(e) FEES; TERMINATION OF REGISTRATION.
16	(1) At the time of registration each lobbyist shall pay a fee of \$500. On or before every
17	subsequent February 1, each registered lobbyist shall pay an additional fee of \$500.
18	(2) Failure to pay the annual fee by February 1 shall constitute a termination of a
19	lobbyist's registration with the Ethics Commission. The Ethics Commission is also authorized
20	to establish additional processes for the termination of a lobbyist's registration.
21	(3) The Ethics Commission shall waive all registration fees for any full-time employee
22	of a tax-exempt organization presenting proof of the organization's tax-exempt status under
23	26 U.S.C. Section 501(c)(3) or 501(c)(4).
24	(4) The Ethics Commission shall deposit all fees collected pursuant to this Section in

the General Fund of the City and County of San Francisco.

(c) On an annual basis, the Executive Director shall initiate audits of one or more lobbyists selected at random. At the request of the Executive Director, the Controller shall may assist in conducting these audits. This requirement shall not restrict the authority of the Executive Director or the Ethics Commission to undertake any other audits or investigations of a lobbyist authorized by law or regulation. Within ten business days of a request by the Ethics Commission, a lobbyist or anyone required to register as a lobbyist shall provide the Ethics Commission with any documents required to be retained under this Section.

## SEC. 2.136 FALSE INFORMATION; DUTY TO COOPERATE AND ASSIST.

(a) Prohibition. No person shall knowingly and intentionally furnish false or fraudulent evidence, documents, or information to the Ethics Commission, District Attorney or City Attorney, or knowingly and intentionally misrepresent any material fact, or conceal any evidence, documents, or information relevant to an investigation by the Ethics Commission, District Attorney or City Attorney of an alleged violation of this Chapter.

(b) Duty to Cooperate and Assist. The Ethics Commission, District Attorney or City Attorney may request and shall receive from every City officer and employee cooperation and assistance with an investigation into an alleged violation of this Chapter.

## SEC. 2.145. ADMINISTRATIVE AND CIVIL ENFORCEMENT AND PENALTIES.

(a) If any lobbyist fails to submit any information required by this Chapter after any applicable deadline, the Ethics Commission shall, in addition to any other penalties or remedies established in this Chapter, impose a late filing fee of \$50 per day after the deadline until the information is received by the Ethics Commission. The Executive Director of the Ethics Commission may reduce or waive a late filing fee if the Executive Director determines that the late filing was not willful and that enforcement will not further the purposes of this

- Chapter. If such reduction or waiver equals or exceeds \$500, the Executive Director shall notify the Commission of his or her determination. Thereafter, any two or more members of the Commission may cause the reduction or waiver to be calendared for consideration by the full Commission in open session at the next Commission meeting occurring no sooner than ten days from the date the Executive Director informs the Commission of the Executive Director's recommendation. A Commissioner's request that a reduction or waiver be calendared must be received by the Executive Director no fewer than five days prior to the date of the meeting, so that the Executive Director may comply with the applicable notice and agenda requirements. The Ethics Commission shall deposit funds collected under this Section in the General Fund of the City and County of San Francisco.
  - (b) Any person who knowingly or negligently violates this Chapter, including but not limited to, by providing inaccurate or incomplete information regarding lobbying activities, may be liable in an administrative proceeding before the Ethics Commission pursuant to Charter Section C3.699-13. In addition to the administrative penalties set forth in the Charter, the Ethics Commission may issue warning letters regarding potential violations of this Chapter both to the lobbyist and the person who pays or employs the lobbyist.
  - (c) Any person or entity which knowingly or negligently violates this Chapter may be liable in a civil action brought by the City Attorney for an amount up to \$5,000 per violation, or three times the amount not properly reported, or three times the amount given or received in excess of the gift limit, whichever is greater.
  - (d) In investigating any alleged violation of this Chapter the Ethics Commission and City Attorney shall have the power to inspect all documents required to be maintained under this Chapter. This power to inspect documents is in addition to other powers conferred on the Ethics Commission and City Attorney by the Charter or by ordinance, including the power of subpoena.

1	(e) <u>Joint and Several Liability.</u>
2	(1) Should two or more persons be responsible for any violation under this
3	Chapter, they may be jointly and severally liable.
4	(2) The client or employer of a lobbyist shall be jointly and severally liable for all
5	violations of this Chapter committed by the lobbyist in connection with acts or omissions undertaken on
6	behalf of that client or employer.
7	(3) If a business, firm or organization registers or files lobbyist disclosures on
8	behalf of its employees pursuant to Section 2.110(d), the business, firm or organization may
9	be held jointly and severally liable for any failure to disclose its employees' lobbying activities.
10	(f) The City Attorney may also bring an action to revoke for up to one year the
11	registration of any lobbyist who has knowingly violated this Chapter.
12	
13	Section 2. The Campaign and Governmental Conduct Code is hereby amended by

16	(a) On or before April 10th of each year, every filing officer shall submit a written

19	report stating that all such persons have filed.
20	(b) On or before April 10th of each year, the Ethics Commission shall prepare a report setting
21	forth the names of those persons who are required to file an annual statement with the Ethics
22	Commission under this Chapter but have failed to do so, or a report stating that all such persons have
23	filed. On or before May 10th of each year, the Ethics Commission shall prepare a supplemental report
24	setting forth the names of any persons who are required to file an annual statement with the Ethics
25	Commission under this Chapter but have failed to do so by May 1st, or a report stating that all such

1	persons have filed. The Ethics Commission shall make these reports publicly available, including by
2	posting the reports on its website.
3	
4	Section 3. The Campaign and Governmental Conduct Code is hereby amended by
5	adding Section 3.302, to read as follows:
6	SEC. 3.302. PUBLIC GUIDE FOR CONTRIBUTORS.
7	The Ethics Commission shall prepare and distribute a public guide regarding campaign
8	contributions. The guide shall include a summary of local law regarding contribution limits, required
9	reporting by contributors and committees, and rules regarding who may contribute to committees. The
10	guide shall be for informational purposes only, and shall not have the force or effect of law or
11	regulation.
12	
13	Section 4. The Campaign and Governmental Conduct Code is hereby amended by
14	adding Sections 3.405, and 3.410, and 3.415 to read as follows:
15	SEC. 3.405. DEFINITIONS.
16	"Contact" means any communication, oral or written, including communication made through
17	an agent, associate or employee.
18	"Client" means the person for whom permit consulting services are performed by a permit
19	<u>consultant.</u>
20	"Permit consultant" is any individual who receives or is promised compensation to provide
21	permit consulting services. This includes any employee who receives compensation attributable to time
22	spent on permit consulting services. This does not include:
23	(1) The licensed architect or engineer of record for construction activity allowed or
24	contemplated by the permit, or an employee of the architect or engineer;

1	(2) The contractor who will be responsible for all construction activity associated with
2	the requested permit; or
3	(3) The employee or agent of an organization with tax exempt status under 26 United
4	States Code Section 501(c)(3) communicating on behalf of that organization regarding the development
5	of a project for that organization.
6	"Permit consulting services" means any contact with the Department of Building Inspection,
7	the Entertainment Commission, the Planning Department, or the Department of Public Works to help a
8	permit applicant obtain a permit.
9	
10	SEC. 3.410. PERMIT CONSULTANT REGISTRATION AND DISCLOSURES.
11	(a) REGISTRATION OF PERMIT CONSULTANTS REQUIRED. Permit consultants shall
12	register with the Ethics Commission and comply with the disclosure requirements imposed by this
13	Chapter. Such registration shall occur no later than five business days after providing permit
14	consulting services, but the permit consultant shall register prior to providing any further permit
15	consulting services.
16	(b) REGISTRATION. At the time of initial registration each permit consultant shall report
17	to the Ethics Commission the following information:
18	(1) The name, business address, e-mail address, and business telephone number of the
19	permit consultant;
20	(2) The name, business address, e-mail address, and business telephone number of
21	each client for whom the permit consultant is performing permit consulting services;
22	(3) The name, business address, e-mail address, and business telephone number of the
23	permit consultant's employer, firm or business affiliation; and
24	(4) Any other information required by the Ethics Commission consistent with the
25	purposes and provisions of this Chapter.

1	(c) PERMIT CONSULTANT DISCLOSURES. Each permit consultant shall file four
2	quarterly reports, according to the following schedule: The permit consultant shall file a report on
3	April 15 for the period starting January 1 and ending March 31; on July 15 for the period starting
4	April 1 and ending June 30; on October 15 for the period starting July 1 and ending September 30; and
5	on January 15 for the period starting October 1 and ending December 31. Each quarterly report shall
6	contain the following:
7	(1) The name, business address, e-mail address, and business telephone number of
8	each person from whom the permit consultant or the permit consultant's employer received or expected
9	to receive economic consideration for permit consulting services during the reporting period, and the
10	amount of economic consideration the permit consultant received or expected to receive;
11	(2) For each contact with the Department of Building Inspection, the Entertainment
12	Commission, the Planning Department, or the Department of Public Works in the course of providing
13	permit consulting services during the reporting period:
14	(A) The name of each officer or employee of the City and County of San
15	Francisco with whom the permit consultant made contact;
16	(B) A description of the permit sought or obtained, including the application
17	number for the permit; and
18	(C) The client on whose behalf the contact was made.
19	(3) All political contributions of \$100 or more made by the permit consultant or the
20	permit consultant's employer during the reporting period to an officer of the City and County, a
21	candidate for such office, a committee controlled by such officer or candidate, a committee primarily
22	formed to support or oppose such officer or candidate, or any committee primarily formed to support
23	or oppose a ballot measure to be voted on only in San Francisco.
24	(4) Any amendments to the permit consultant's registration information required by
25	Subsection (b).

1	(5) Any other information required by the Ethics Commission consistent with the
2	purposes and provisions of this Chapter.
3	
4	SEC. 3.415. PENALTIES AND ENFORCEMENT.
5	(a) If any permit consultant fails to submit any information required by this Chapter
6	after any applicable deadline, the Ethics Commission shall, in addition to any other penalties
7	or remedies established in this Chapter, impose a late filing fee of \$50 per day after the
8	deadline until the information is received by the Ethics Commission. The Executive Director of
9	the Ethics Commission may reduce or waive a late filing fee if the Executive Director
10	determines that the late filing was not willful and that enforcement will not further the purposes
11	of this Chapter. The Ethics Commission shall deposit funds collected under this Section in the
12	General Fund of the City and County of San Francisco.
13	(b) Any person who knowingly or negligently violates this Chapter may be liable in an
14	administrative proceeding before the Ethics Commission pursuant to Charter Section C3.699-
15	13. In addition to the administrative penalties set forth in the Charter, the Ethics Commission
16	may issue warning letters regarding potential violations of this Chapter to the permit
17	consultant.
18	(c) Any person or entity which knowingly or negligently violates this Chapter may be
19	liable in a civil action brought by the City Attorney for an amount up to \$5,000 per violation.
20	
21	Section 5. The Campaign and Governmental Conduct Code is hereby amended by
22	adding Article 3, Chapter 5, consisting of Sections 3.500, 3.510, and 3.520, to read as follows:

24	CHAPTER 5, DEVELOPER DISCLOSURES
25	Sec. 3.500 Findings

4	SEC 3.500. FINDINGS.	
5	The Board of Supervisors finds that public disclosure of the donations that developers make to	<u>)</u>
6	nonprofit organizations that may communicate with the City and County regarding major development	<u>1t</u>
7	projects is essential to protect public confidence in the fairness and impartiality of City and County	
8	land use decisions. The Board further finds that disclosure is essential to allow the public to fully and	<u>l</u>
9	fairly evaluate the City and County's land use decisions. It is the purpose and intent of this Chapter to	<u>o</u>
10	impose reasonable disclosure requirements on developers to provide the public with information abou	<u>ut</u>
11	these donations.

13	SEC 3.510. DEFINITIONS	
14	"Affiliate" shall mean any individual or entity that directly or indirectly controls, is controlled	
15	by or is under common control with, another entity, and for these purposes "control" means the power	<u>r</u>
16	to direct the affairs or management of another entity, whether by contract, operation of law or	
17	otherwise.	
18	"CEQA" shall mean the California Environmental Quality Act (Public Resources Code Section	<u>n</u>
19	21,000 et seq.), the CEQA Guidelines (California Code of Regulations, Title 14, Division 6, Chapter 3	<u>3,</u>
20	Section 15000 et seq.), and Chapter 31 of the San Francisco Administrative Code, as any of them may	<u>/</u>
21	<u>be amended.</u>	
22	"Developer" shall mean the individual or entity that is the project sponsor responsible for filing	<u>ng</u>
23	a completed Environmental Evaluation Application with the Planning Department (or other lead	
24	agency) under CEQA for a major project. For any project sponsor that is an entity, "Developer" sha	<u>:ll</u>
25	include all of its constituent individuals or entities that have decision-making authority regarding any	,

1	of the entity's major decisions or actions. By way of example and without limitation, if the project
2	sponsor is a limited liability company, each of its members is considered a developer for purposes of
3	the requirements of this Chapter, and similarly if the project sponsor is a partnership, each of its
4	general partners is considered a developer for purposes of the requirements of this Chapter. If the
5	owner or agent that signs and submits the Environmental Evaluation Application will not be
6	responsible for obtaining the entitlements or developing the major project, then for purposes of the
7	requirements of this Chapter the developer shall be instead the individual or entity that is responsible
8	for obtaining the entitlements for the major project.
9	"Donation" shall mean any gift of money, property, goods or services.
10	"EIR" shall mean an environmental impact report prepared under CEQA. For purposes of this
11	Chapter, an EIR shall also include, without limitation, any CEQA determination that the Planning
12	Department or Planning Commission (or other appropriate lead agency) makes to allow consideration
13	of approval of a major project to proceed under an EIR, a previously certified program EIR, master
14	EIR or staged EIR.
15	"Entity" shall mean any partnership, corporation (including, but not limited to, any business
16	trust or nonprofit corporation), limited liability company, joint stock company, trust, unincorporated
17	association, joint venture or any other organization or association. "Entity" shall not include any state
18	or local government agency.
19	"Major project" shall mean a real estate development project located in the City and County
20	for which the City's Planning Commission (or any other local lead agency) has certified an EIR under
21	CEQA and which has estimated construction costs exceeding \$1,000,000. As used in the preceding
22	sentence, the term "real estate development project" includes any project involving construction of one
23	or more new structures or an addition to one or more existing structures, change of use within one or
24	more existing structures, or substantial rehabilitation of one or more existing structures, where, in any
25	such instance, the structure includes any occupiable floor area, excluding only a residential

1	development project with four or fewer dwelling units. Estimated construction costs shall be calculated
2	in the same manner used to determine building permit fees under the Building Code.
3	"Nonprofit organization" shall mean any corporation formed under California Corporations
4	Code Section 5000 et seq. for any public or charitable purpose, or any organization described in 26
5	United States Code Section 501(c), that, in either instance, has attempted to influence City and
6	County legislative or administrative action since the date one year before the Environmental
7	Evaluation Application for the major project was filed.
8	"Structure" shall have the same meaning as the Planning Code defines such term.
9	
10	SEC 3.520. REQUIRED DISCLOSURE
11	(a) Any developer of a major project shall, within 30 days of the date the Planning Commission
12	(or any other local lead agency) certifies the EIR for that project or, for a major project relying on a
13	program EIR, within 30 days of the date that the Planning Department, Planning Commission, or any
14	other local lead agency adopts a final environmental determination under CEQA, report the following
15	information to the Ethics Commission:
16	(1) The name, business address, business e-mail address and business telephone
17	number of the developer, as well as those of any affiliates that made donations subject to this Chapter.
18	(2) The EIR case number and a description of the major project.
19	(3) The date the Planning Commission (or other local lead agency) certified the EIR or
20	adopted the final environmental determination.
21	(4) The name, business address, business e-mail address, business telephone number
22	and website of any nonprofit organization: (1) to whom the developer or any affiliate of the developer
23	has made cumulative donations of \$5,000 or more since the date one year before the Environmental
24	Evaluation Application for the major project was filed; and (2) that has attempted to influence City
25	and County legislative or administrative action with regard to the developer's major project.

1	(5) For each nonprofit organization reported under Subsection (a)(4), the date and
2	amount of each donation the developer or affiliate made to the nonprofit during the reporting period.
3	(6) Any other information required by the Ethics Commission consistent with the
4	purposes and provisions of this Chapter.
5	(b) After a developer files a report required by Subsection (a), the developer shall file a total of
6	four additional quarterly reports, according to the following schedule: The developer shall file a
7	report on April 15 for the period starting January 1 and ending March 31; on July 15 for the period
8	starting April 1 and ending June 30; on October 15 for the period starting July 1 and ending September
9	30; and on January 15 for the period starting October 1 and ending December 31. Each quarterly
10	report shall include:
11	(1) The name, business address, business e-mail address, and business telephone
12	number of the developer and any affiliates that made donations subject to this Chapter.
13	(2) The EIR case number and a description of the major project.
14	(3) The date the Planning Commission (or other local lead agency) certified the EIR or
15	adopted the final environmental determination.
16	(4) The name, business address, business e-mail address, business telephone number
17	and website of any nonprofit organization to which the developer has made cumulative donations of
18	\$5,000 or more since the date one year before the Environmental Evaluation Application was filed.
19	(5) For each nonprofit organization reported under Subsection (b)(4), the date and
20	amount of each donation the developer made to the nonprofit during the reporting period.
21	(6) Any other information required by the Ethics Commission consistent with the
22	purposes and provisions of this Chapter.
23	(e) At the time of filing the initial report required by subsection (a), the developer shall pay a
24	<u>fee of \$500.</u>

1	SEC. 3.530. PENALTIES AND ENFORCEMENT.
2	(a) If any developer fails to submit any information required by this Chapter after any
3	applicable deadline, the Ethics Commission shall, in addition to any other penalties or remedies
4	established in this Chapter, impose a late filing fee of \$50 per day after the deadline until the
5	information is received by the Ethics Commission. The Executive Director of the Ethics Commission
6	may reduce or waive a late filing fee if the Executive Director determines that the late filing was not
7	willful and that enforcement will not further the purposes of this Chapter. The Ethics Commission shall
8	deposit funds collected under this Section in the General Fund of the City and County of San
9	<u>Francisco.</u>
10	(b) Any person who knowingly or negligently violates this Chapter, including but not limited to,
11	by providing inaccurate or incomplete information, may be liable in an administrative proceeding
12	before the Ethics Commission pursuant to Charter Section C3.699-13. In addition to the administrative
13	penalties set forth in the Charter, the Ethics Commission may issue warning letters regarding potential
14	violations of this Chapter.
15	(c) Any person or entity which knowingly or negligently violates this Chapter may be liable in a
16	civil action brought by the City Attorney for an amount up to \$5,000 per violation, or three times the
17	amount not properly reported, whichever is greater.
18	(d) In investigating any alleged violation of this Chapter the Ethics Commission and City
19	Attorney shall have the power to inspect all documents required to be maintained under this Chapter.
20	This power to inspect documents is in addition to other powers conferred on the Ethics Commission
21	and City Attorney by the Charter or by ordinance, including the power of subpoena.
22	(e) Should two or more persons be responsible for any violation under this Chapter, they may
23	be jointly and severally liable.
24	

1	Section 6. Effective Date. This ordinance shall become effective 30 days after
2	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4	of Supervisors overrides the Mayor's veto of the ordinance.
5	
6	Section 7. In enacting this ordinance, the Board intends to amend only those words,
7	phrases, paragraphs, subsections, sections, articles, numbers, punctuation, charts, diagrams,
8	or any other constituent part of the Campaign and Governmental Conduct Code that are
9	explicitly shown in this ordinance as additions, deletions, Board amendment additions, and
10	Board amendment deletions in accordance with the "Note" that appears under the official title
11	of the ordinance.
