MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated person to serve as a member of the SRO Task Force, pursuant to the provisions of Board of Supervisors Resolution Nos. 459-06, 457-09, and 9-13, for the term specified:

Bruce Burge (residency requirement waived), seat 3, succeeding himself, term expired, must be a private SRO owner/operator, for the unexpired portion of a three-year term ending December 31, 2015.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the SRO Task Force has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Bruce Burge, reappointment, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the SRO Task Force.
- 3. The SRO Task Force has attempted to fill the position, for which Bruce Burge was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but have been unable to do so at this time. The Rules Committee has certified that Bruce Burge is qualified to serve on the SRO Task Force.
- 4. After exercising due diligence, the Board of Supervisors concludes that there are no other possible representatives, who are residents of San Francisco and who have
