Bruce Burge (residency requirement waived), seat 3, succeeding himself, term expired, must be a private SRO owner/operator, for the unexpired portion of a three-year term ending December 31, 2015.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the SRO Task Force has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Bruce Burge, reappointment, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the SRO Task Force.
- 3. The SRO Task Force has attempted to fill the position, for which Bruce Burge was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but have been unable to do so at this time.
