[Settlement of Lawsuit - Stantec Consulting Services Inc. - City to Receive \$15,285,000]

Ordinance authorizing settlement of the lawsuit filed by the City and County of San Francisco against Stantec Consulting Services Inc. and Stantec Architecture Inc. for \$15,285,000; the lawsuit was filed on December 12, 2011, in Alameda County Superior Court, Case No. RG13679711; entitled <u>City and County of San Francisco v. Stantec</u> Consulting Services Inc., et al.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>City and County of San Francisco v.</u> <u>Stantec Consulting Services Inc., et al.</u>, Alameda County Superior Court, Case No. RG13679711, by the payment of \$14,000,000 to the City by defendants, and release of all claims by defendants against the City for an unpaid contract balance of \$1,285,000. All parties will execute a mutual release of current claims against one another, excluding a release of defendants' liability for latent defects, and defendants' claims against various third parties subject to defendants' obligation to defend, indemnify, and hold the City harmless for future lawsuits arising from such claims.
