Third Amendment

THIS AMENDMENT (this "Amendment") is made as of June 3, 2014, in San Francisco, California, by and between **Parsons Brinckerhoff, Inc.** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission or the Commission's designated agent, hereinafter referred to as "Commission."

RECITALS

WHEREAS, City and Contractor have entered into the Agreement (as defined below); and

WHEREAS, Commission adopted Resolution Number 12-0190 on August 28, 2012 which authorized the award of said Agreement for the period of October 1, 2012 through October 31, 2013; and

WHEREAS, Commission adopted Resolution Number 13-0210 on October 1, 2013 which authorized the award of the First Contract Amendment for a new end date of April 30, 2014; and

WHEREAS, Commission adopted Resolution Number 14-002 on January 29, 2014 which authorized the award of the Second Contract Amendment for a new end date of July 31, 2014; and

WHEREAS, Commission authorized this Third Amendment pursuant to Resolution Number 14-0110 on June 3, 2014 to increase the Agreement amount and extend the Agreement through June 30, 2015; and

WHEREAS, pursuant to San Francisco Charter Section 9.118, the Board of Supervisors by its Resolution No. [insert resolution number], adopted [insert date], approved the contract with Contractor; and

WHEREAS, City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to increase the contract amount and extend the contract for eleven (11) months through June 30, 2015; and

WHEREAS, approval for this Amendment was obtained when the Civil Service Commission approved Contract number PSC #4098-10/11 on January 6, 2014; and

NOW, THEREFORE, Contractor and the City agree as follows:

1. **Definitions.** The following definitions shall apply to this Amendment:

a. **Agreement.** The term "Agreement" shall mean the Agreement dated August 28, 2012 between Contractor and City references as Contract 9230.9, as amended by the:

**First Amendment dated October 1, 2013**

**Second Amendment dated January 29, 2014**

b. **Other Terms.** Terms used and not defined in this Amendment shall have the meanings assigned to such terms in the Agreement.



2. **Section 2. Term of the Agreement** is hereby amended to extend the term of the contract for an additional eleven (11) months for a new ending date of June 30, 2015.

3. **Section 5. Compensation** is hereby amended to increase the total compensation payable by an amount not to exceed **Four Million Eight Hundred Twenty Thousand Dollars (\$4,820,000)** for a new total not to exceed amount of **Fourteen Million Seven Hundred Thousand Dollars (\$14,700,000)**.

4. **Effective Date.** Each of the modifications set forth in Section 2 shall be effective on and after June 3, 2014.

5. **Legal Effect.** Except as expressly modified by this Amendment, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
