WHEREAS, A problem in San Francisco's Citywide Formula Retail Use controls has been identified in the Castro Street (NCD) in that, despite the fact that once the City has determined that a proposed use is a Formula Retail Use the Planning Code puts the burden

WHEREAS, The Planning Department has determined that the actions contemplated in this Resolution are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.) and the Board hereby affirms that determination. FURTHER RESOLVED, That upon imposition of these interim controls for the Castro Street NCD, the Planning Department shall conduct a study of the contemplated zoning proposal and propose permanent legislation to address the issues of manipulation of the Formula Retail Use features and disagreements between the Planning Department and project sponsors as to whether a proposed use is a Formula Retail Use; and, be it

FURTHER RESOLVED, That these interim controls for the Castro Street NCD shall remain in effect for a period of 18 months unless extended in accordance with Planning Code, Section 306.7(h), or until permanent controls are adopted; and, be it
