Rodney A. Fong is a native San Franciscan and a third generation operator/owner of the world famous Wax Museum at Fisherman's Wharf, where had served as President. He is also the President of Fong Real Estate Co., LLC, overseeing leasing and tenant concerns for the family properties, such as the 100,000 square foot Wax Museum building in the heart of historic Fisherman's Wharf and 2001 Broadway Apartments.

Rodney has been working in the family owned tourist attraction and learning the business since he was a child. He always loved the family's fascinating business and decided early on to build his career within the organization. When he left college, he devoted himself full time to learning all phases of the family enterprises, beginning with the daily operations and management technique at the Wax Museum, a world-renowned tourist attraction.
