3 **Resolution changing the name of Lech Walesa Street in the Civic Center area to "Dr.**
4 **Tom Waddell Place," in recognition of Dr. Tom Waddell's contributions to the City and**
5 **County of San Francisco.**

6
7 WHEREAS, Dr. Tom Waddell was born in 1937 in Paterson, New Jersey and was
8 adopted by Gene and Hazel Waddell, former vaudeville acrobats who encouraged Waddell to
9 excel in athletics, including gymnastics; and

10 WHEREAS, In 1965, after obtaining his medical degree and completing his medical
11 internship Dr. Waddell joined the civil rights movement in Selma, Alabama; and

12 WHEREAS, Dr. Waddell was drafted into the U.S. Army in 1966 and became a
13 preventive-medicine officer and paratrooper and subsequently, a conscientious objector upon
14 being notified that he was to be deployed to Vietnam; and

15 WHEREAS, He was then sent to train as a decathlete for the 1968 Olympics where he
16 placed 6th among 33 competitors and set five personal records in the ten events; and

17 WHEREAS, Dr. Waddell moved to San Francisco and established his private practice
18 in the Castro neighborhood and founded the Gay Games, a gay sporting event modeled on
19 the Olympics that was founded on the principle of inclusion, with all athletes being welcome,
20 regardless of sexual orientation, gender, race, religion, nationality, ethnic origin, political
21 belief(s), age, or health status; and

22 WHEREAS, The first Gay Games took place in 1982 in San Francisco and celebrated
23 sportsmanship, personal achievement, and inclusiveness; and

24 ///

1 WHEREAS, On July 11, 1987 at the age of 49, in San Francisco, Dr. Tom Waddell died
2 of AIDS, leaving behind his daughter Jessica Waddell Lewinstein and legal wife, lesbian
3 athlete Sara Lewinstein; and

4 WHEREAS, Dr. Tom Waddell worked as a physician at the City Clinic in San
5 Francisco to provide medical care to the city's most underserved and marginalized
6 communities; and

7 WHEREAS, The City Clinic where Dr. Tom Waddell was employed as a physician was
8 renamed the Tom Waddell Health Center, is now the only physical facility located on Lech
9 multidisciplinary Walesa in the Civic Center neighborhood, and continues to provide the city's
10 residents with services to respond to a wide range of medical, psychological, and social
11 needs, including, but not limited to, a transgender clinic, substance abuse programs, and HIV
12 testing and treatment; and

13 WHEREAS, Throughout his lifetime, Dr. Tom Waddell strove to excel as an individual,
14 whether it was as a world-class athlete, a doctor serving the most vulnerable individuals, a
15 founder of an international sporting event that celebrates equality for all, or as a loving father
16 and partner; and

17 WHEREAS, The City of San Francisco celebrates the tolerance and inclusiveness that
18 Dr. Tom Waddell advocated throughout his life and strongly refutes the hate speech against
19 the LGBTQ community expressed recently by Lech Walesa; and

20 WHEREAS, The Board of Supervisors recognizes that the Department of Public
21 Works, on behalf of the City, has taken all necessary actions to effect this name change,
22 including fully complying with regulations regarding street name changes under California
23 Streets and Highways Code Section 970.5, Public Works Code Section 423, California
24 Government Code Section 34091.1, and California Streets and Highways Code Sections
25 970.5 and 5026; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby changes the name of Lech Walesa
2 Street to "Dr. Tom Waddell Place," in recognition of his valued contributions to the City of San
3 Francisco; and, be it

4 FURTHER RESOLVED, The Board of Supervisors, in accordance with Transportation
5 Code Section 2.2, directs the Municipal Transportation Agency to prepare street signs
6 indicating both the new and the former names of the street, with the new name "Dr. Tom
7 Waddell Place" in large letters, and the old name "Lech Walesa Street" in smaller letters
8 above or beneath the new name; and, be it

9 FURTHER RESOLVED, That both of the street names shall remain posted on street
10 signs for five years, and then the street signs shall be replaced with signs indicating only the
11 new street name, "Dr. Tom Waddell Place;" and, be it

12 FURTHER RESOLVED, That in adopting this legislation, the Board of Supervisors
13 does not intend to effectuate any change in City department jurisdictional control over the
14 subject portion of "Lech Walesa Street" to be known as "Dr. Tom Waddell Place"; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board
16 to promptly forward a copy of this Resolution to the County Surveyor in accordance with
17 California Streets and Highways Code Section 5026.

Re: Recommendation to change the street name, pursuant to California Streets and Highways Code Sections 970.5 and 5026, California Government Code section 34091.1, and Section 423 of the San Francisco Public Works Code, of Lech Walesa Street to "Dr. Tom Waddell Place". Lech Walesa Street is generally bounded by Van Ness Avenue to the west, Polk Street to the east, and Assessor's Block 0811 to the north and south.

WHEREAS, On March 25, 2014 the Board of Supervisors requested that the Department of Public Works (the Department) perform an investigation into the official renaming of Lech Walesa Street ; and

WHEREAS, On April 25, 2014 the Department sent notice of the proposed street name change to the Planning Department, the Municipal Transportation Agency, and the Fire Department. All agencies reported that they did not find conflicts with the proposed street name and therefore did not object to the name change; and

WHEREAS, On April 25, 2014 the Department sent notice of the proposed street name change to the seven property owners adjacent to Lech Walesa Street. The Department received one letter of support and no objections from the adjacent property owners; and

WHEREAS, On June 12, 2014, as required by California Streets and Highways Code Section 970.5 the department posted 3 notices along Lech Walesa Street providing the date, time and location of the public hearing for the official street name change.: and

WHEREAS, The Director of Public Works for the City and County of San Francisco has determined the following:

1. The street name change is being carried out pursuant to the California Streets and Highways Code sections 970.5 and 5026.
2. The street name change is being carried out pursuant to section 423 of the San Francisco Public Works Code.
3. The Department made reasonable attempts to notify and obtain consent from all property owners adjacent to Lech Walesa Street.



NOW THEREFORE BE IT RECOMMENDED THAT,

The Director recommends the Board of Supervisors move forward with the legislation to officially change the name of Lech Walesa Street to Dr. Tom Waddell Place.

The Director further recommends the Board of Supervisors authorize the Mayor, Clerk of the Board, the Municipal Transportation Agency, the County Surveyor, and the Director of Public Works to take any and all actions which they or the City Attorney may deem necessary or advisable in order to effectuate the purpose and intent of this Resolution.
