children and youth with serious emotional disturbances, adults and older adults with serious mental illnesses; and

WHEREAS, The County's performance contract, a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>140056</u>, as required by Welfare and Institutions Code, Sections 5650(a), 5847, and Title 9, California Code of Regulations (CCR), Section 3310, sets forth conditions and requirements that County must meet in order to receive this funding; and

WHEREAS, The Director of Community Behavioral Health Services is designated to sign this Agreement and any and all amendments in the future including increases to add other components on behalf of the Department of Public Health (DPH); now, therefore, be it

RESOLVED, That DPH is hereby retroactively authorized to enter into a performance contract agreement with DHCS; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby designates the Director of CBHS to sign said agreement on behalf of DPH; and, be it

FURTHER RESOLVED, That the Director of Community Behavioral Health Services is designated to sign any and all amendments to this agreement; and, be it

FURTHER RESOLVED, That within thirty (30) days of the performance contract being fully executed by all parties the Director of Community Behavioral Health Services shall provide the performance contract to the Clerk of the Board for inclusion into the official file.
