Operationally, Mr. Ghanma will not change anything except add the convenience of selling moderately priced fine wines and beer, as well as distilled spirits.

It should be noted that during the application process, notification date for the 500' mailer was on February 27, 2014. The Notice to the Public was re-posted on June 7, 2014. Mr. Ghanma was incorrectly advised that he did not need a PCN hearing. Therefore, Mr. Ghanma reposted in June.
