ORDINANCE

Ordinance authorizing settlement of the lawsuit filed by Earl Brown Sr., Helen Brown, and the Estate of Earl Brown Jr., against the City and County of San Francisco for \$175,000; the lawsuit was filed on May 2, 2011, in United States District Court, Case No. C11-02162 LB; entitled <u>Earl Brown Sr., Helen Brown, and the Estate of Earl Brown Jr. v.</u> <u>City and County of San Francisco, et al.</u>

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Earl Brown Sr., Helen Brown, and the Estate of Earl Brown Jr. v.
