

It has come to our attention that Khaled Ghanma, the owner of All States Best Foods at $1607\ 20^{th}$ St. in San Francisco, has applied for a license to sell alcoholic beverage. The application number is 542262. We are regular customers at All States Best Foods, as well as Dave's Food Store, a convenience store which also sells beer, wine and liquor next door at $1601\ 20^{th}$ St. We know the owners of both business from having been customers since we moved into the neighborhood about three years ago.

A few weeks ago, while separately visiting Dave's Food Store a few days apart, we were asked to sign a petition against another liquor being opened in the neighborhood. This was described to us as a new full liquor store "somewhere in the neighborhood." The rationale for the petition against it was that it would cater to lower-cost beverages and thus "attract the wrong crowd." He went on to say it would force Dave's to start carrying lower-end products and thus that crowd would also be at Dave's.

Ignoring the social generalizations underlying this argument, we really just signed this petition in support of a convenient business we've come to value even though alcohol prices are elevated, and because we are not in favor of a "new" liquor store in the neighborhood. We now realize this was a premature action on our part and we regret signing this petition. We would like to have our names removed from this petition if possible.

The reason for this change is that we feel like we were misled. We have since learned that the business applying for a license is All States Best Foods, the business next door. We felt duped and frankly stupid for not having pushed to get more details prior to signing the petition. As we've learned from Khaled and his brother, All States Best Foods is looking to carry a limited amount of alcohol in line with the types of products they already carry. They are not trying to convert to a full liquor store, and no one is attempting open a new liquor store. As a consumer, this is great,

Greetings,

I am writing to you as a fairly long-term resident of Potrero Hill (18-1/2 years) and a long time customer of All States Best Foods. I have always known Khaled and Mueen to be exceptionally gracious, informed, honest, fair, etc. It's always been my habit to patronize several stores in the neighborhood. I buy organic foods at Good Life, hummus and fresh made sandwiches at Chiotras, paper goods and detergents and cheese and frozen foods at All States, and I also shop at Whole Foods and Rainbow Grocery. For years I have also been a customer at Dave's.

When I first arrived in the neighborhood I went to Dave's all the time. I remember the deli there, and if I remember correctly I bought spanokopita. I would shop there because I liked several of their items, and because the owners then were especially friendly. But I became especially loyal to All States once the present owners took over that location, most of all because I enjoyed interacting with Khaled and Mueen and other family members that worked there. When Salah bought Dave's, I went there also. He taught me about Jacob's Creek and other brands of wine. Isam and his son have also been good shopkeepers, and I would still go there on occasion, but I just don't buy the items that I used to get from them.

So I'm writing to you as some one who would like to see all local shops do well and prosper. I love running into people I know in all these locations, and I value supporting small business. While I do shop at larger stores, I try small businesses first.

And through many conversations on dozens of topics including but not limited to store merchandise, I have gotten to know Khaled and Mueen as honorable, respectful, and honest. Therefore I am very much inclined to believe Khaled telling me that approximately half a dozen customers who shop at both stores have been informing Khaled that they have been given very misleading information at Dave's when asked to sign the petition at Dave's against All States being allowed to purchase the available liquor license. Customers have been informing Khaled that the word at Dave's is that the petition is to oppose a whole new liquor store. Again, if this is true, and if Khaled is simply passing along to me what customers tell him I believe it probably is true, this is very destructive and to me would invalidate all the signatures on the petition at Dave's. Because to alarm the community in a way that implies some sleazy, late-night, entirely new liquor store entity is on its way, and that they'd better sign the petition to stop that, when that is not at all the situation, is harmful to every one by being both dishonest and alarmist.

On the other hand, I have every reason to believe Khaled's solemn promise that the focus at All States Best Foods will be on quality liquor, beer and wine, and that their hours will remain as they are now, open to 9 pm 7 days a week. I have also heard customers come into All States many times asking for such items, and whoever is at the counter at All States has always cheerfully referred them to Dave's.
