Thank you for considering me for Seat 8 for the Citizen's Advisory Committee for the Central Market and Tenderloin Area, and for affording me the opportunity to speak about my credentials.

This seat requires that someone have expertise on homelessness, transitional age youth, or supportive housing, and familiarity with the Central Market Street and Tenderloin area. This is a perfect fit for my background, as it has led me to develop significant experience in all of those areas. 17 years ago, I cofounded At The Crossroads, an organization that provides disconnected homeless youth and young adults with the support they need to move beyond the streets and build outstanding lives. I have been there ever since, and am the Executive Director. We focus on the young people who get kicked out of other programs or never set foot in them, prioritizing those who are the hardest to reach, who have fallen through the cracks. Homeless youth are my life's passion. Running At The Crossroads has been the biggest privilege of my life.

ATC has two primary neighborhoods of focus, the Tenderloin and the Mission. In these neighborhoods, we walk the streets at nighttime, reaching out to homeless youth in their teens and twenties on their own turf. We have reached more than 7,000 homeless youth over our 17 years. During that time, I have walked the streets of the Tenderloin doing counseling-based street outreach more than 1,000 times. I know Market Street like the back of my hand; it truly feels like home to me. I have personally worked with more than 3,000 of our clients. Our program is often held up as a model for reaching the most challenging youth, and engaging them in counseling relationships. We have been asked to speak all around the country on our model of youth development. We have a \$1,100,000 budget, 14 staff members, and are 100% privately funded, having made the choice to not take government support.

I also have strong knowledge of supportive housing. Since we opened, we have helped hundreds of youth navigate the complicated system of getting into permanent supportive housing. In the last year alone, we have helped 25 of our youth get into permanent supportive housing, including the new developments Fifth Street and Edward II. I was also the chair of the Community Services committee on Mayor Newsom's Transitional Age Youth Task Force, spearheading the recommendation to develop 400 new units of TAY housing. This recommendation was adopted by the Mayor's Office of Housing, where I served on the advisory committee that oversaw the creation of a plan to develop this housing.

This leads into the next realm of experience I possess that I hope would serve the committee well: my experience working on teams involving different constituencies. As mentioned, I served on the TAY Task Force from 2006-2008 in a leadership position. I was then a member of the TAYSF steering committee. I am now the co-

I love being part of a team, either in a leadership position or as an active member, and believe in the importance of getting a diverse group of individuals working together for a common cause.

It seems that another key component of being a good candidate for this committee is to bel ieve that San Francisco must be a healthy city for all, and that business can play a key role in developing this, not just for their employees and customers, but for the entire community. This is what I am most excited about. The feeling of divide that is developing in this city is really depressing to me. I hate the way that it feels like everyone is taking sides and drawing lines. Bridges need to be built between the poor and the wealthy, nonprofits and businesses, the homeless and the housed. I'm hoping that being on this committee is an opportunity to bridge the needs of the community and the interests of local businesses, rather than pitting them against each other.

I have lived in San Francisco for the last 18 years, and I love this city. I, like many others, am concerned that certain ways in which it is changing will lead to an increased homogeneity of its residents, will push out both individuals and nonprofits who can no longer afford it, or no longer feel like it represents their values and cultures. We must do everything we can to prevent the outflow of diversity, and to make sure that San Francisco is a home for people of all backgrounds, races and economic classes. The local business community and its employees have so much to offer, and it is important that we help them do so in a thoughtful, meaningful way that targets those most deeply in need, fueling positive change in the Mid-Market and Tenderloin.

It would be my honor to serve on this committee. I would do so with passion, inclusiveness, thoughtfulness and integrity.

I believe that Rob's years of experience as founder and leader of ATC, as well as ATC's singular philosophy, make Rob uniquely suited to this role; I feel his contributions would be integral to the committee's ultimate success.

I have known Rob professionally since he and a colleague founded ATC in 1997, when I was working as an outreach worker with homeless youth for the Haight Ashbury Free Clinics' Youth Outreach Team. We have remained friends for many years as I moved on to found the Drug Overdose Prevention and Education (DOPE) Project in San Francisco, obtain a master's degree at Johns Hopkins University, analyze policies affecting persons returning from prisons and jails to the community with the Council of State Governments Justice Center and with the Ella Baker Center for Human Rights, and serve in my current role at the California Department of Public Health.

From the start, ATC identified and chose to serve those youth in the Mission and Mid-Market Districts who were not visibly homeless-- specifically African American and Latino youth who were couch-surfing with friends and family--but who needed support as much as visibly homeless youth "street punks" and who needed a different model of service delivery. Under Rob's leadership, ATC tailored its program design to serve the previously unidentified and unmet needs of youth of the Mission and Mid-Market by providing outreach late at night and materials beyond those focused solely on disease (read: HIV) prevention. Since that time ATC has maintained and strengthened this commitment, serving as a foundation of stability and hope for its participants. Rob's leadership has also influenced ATC's funders and colleagues by articulating and communicating clearly the value inherent in youth's lives and the importance of supporting youth in defining their own goals and in embodying their own potential.

#### **CIVIC ACTIVITIES:**

Starting in 2011, I cofounded a neighborhood watch group along with my neighbor Adam Leising, in conjunction with SF Safe, and Captain Garrity and the other Officers of the San Francisco Tenderloin Station. Through our efforts and information provided by the neighborhood watch group to local District SFPD, SFPD was able to arrest and the SF DA's Office convict over 45 cases of crack dealing and/or gang related charges. While this took considerable effort and time donated by myself, I never ceased to remain involved with helping my community in various ways. After the SFPD had cleared the 300 Block of Hyde of the infestation of crack dealing gang bangers which had previously held an entire block of local residents as hostage prisoners in their own homes out of fear, I began to notice another element in my neighborhood which didn't sit well with my personal standards of decent human behavior. The thing I saw that disturbed me was a high level of pimping and pandering, being inflicted upon the "victim class offenders or collateral offenders" (According to the prosecution guidelines and policies set by Pamela Harris) prostitutes.

Using guidelines created and broadcast on line by "San Francisco and East Bay Harm Reduction Website," I was able to help and aid at least five to ten various prostitutes to either leave their captor pimps or quit prostitution as a career entirely. The results were different, and many had drug issues. However, with the information found on line at <u>http://harmreduction.org/</u> and methods and tactics created by myself, I was able to get several young prostitution victim women into drug treatment and housing placement programs, back to their families, or at the very least away from the leach like pimps whom take and steal the money from young women whom do the things they do because of lack of realistic available options to earn the needed income simply to survive. These efforts frustrated, annoyed, and even put several local pimps out of the "Pimping and Pandering" business. For the sake of my own security and that of those whom I have helped, I will not divulge any more information other than that which I just have. The only reason I do mention it, is to show the level of commitment and civic activities I have undertaken to ensure my neighborhood is a safe and happy one.

In 2012, my engagement with my civic activities caused me to receive an invitation to a round table on community engagement in regards to whether San Francisco would permit "Party Buses" into the city, and whether it should be illegal to allow alcohol on "party buses." The community focus group, which included several SFPD, San Francisco City Leaders, Community Leaders, Night Club Interests, as well as several members of the press, was convened to gauge community sentiment as to the passage of a state wide law banning drinking on party buses. I was asked at that point to attend and represent the interests of my community, and so I did. I shared at the meeting quite extensively, and argued that the amount of business the "party buses"

bring into those neighborhoods with nightlife activities far outweighs any unsubstantiated costs in accidents, crimes, or problems which could possibly go wrong. I believe my opinions were well received, and that I did add to the group of civic and community leaders through my participation.

Finally, I would like to point out that while Elite Agents Immigration Group, Inc. isn't a volunteer company, it is a non-profit corporation dedicated to the civic need for supplying local immigrants with low cost immigration law services. In fact, Elite Agent Immigration Group is a public benefit corporation, as by the very call of its articles of incorporation one of the companies stated purposes is to help alleviate the burden of local, state, and federal governments. The companies' legal address of operation is within the stated district, and does directly benefit the immediate local community. For this reason I would again ask that my formation and operation of the corporation does receive the proper weight of consideration such a corporation and undertaking rightfully deserves.

# San Francisco BOARD OF SUPERVISORS

The Rules Committee of the Board of Supervisors shall nominate each Citizen's Advisory Committee member and the appointment of each nominee shall be confirmed by the full Board of Supervisors.

The members of the Citizen's Advisory Committee shall be appointed for a term of four years; provided, however, that members first appointed shall, by lot at the first meeting, classify their terms so that three shall serve for a term of two years and four shall serve for a term of four years.

The Citizen's Advisory Committee shall be an advisory body whose purpose is to make recommendations to the Mayor, Board of Supervisors and City Administrator on policies and programs that mitigate the effects of development, bolster economic development, local employment, and community sustainability and seek to stabilize and protect existing tenants, community based organizations and small businesses in and around the Central Market Street and Tenderloin Area.

Report: Provide a report every six months to the Board of Supervisors regarding the implementation and execution of the Community Benefit Agreements called for under the Central Market Street and Tenderloin Area Payroll Expense Tax Exclusion.

Sunset Clause: The provisions of this ordinance and the operation of the Citizen's Advisory Committee shall expire upon expiration of the Central Market Street and Tenderloin Area Payroll Expense Tax Exclusion under Section 906.3 of this Article.
