1 [Administrative Code - Requiring City Contractors to Submit an Equal Pay Report and  
2 Establishing an Equal Pay Advisory Board]

3 **Ordinance amending the Administrative Code to require certain City contractors and**  
4 **subcontractors with 20 or more employees to submit an Equal Pay Report regarding**  
5 **compensation paid to employees; and establishing the Equal Pay Advisory Board to**  
6 **analyze and recommend the best methods of data collection that will identify wage**  
7 **gaps, and setting forth the membership and duties of the Advisory Board.**

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. The Administrative Code is hereby amended by revising Section 12B, to  
17 read as follows:

18 **SECTION 12B.2. NONDISCRIMINATION PROVISIONS.**

19 Every contract and property contract for or on behalf of the City shall incorporate by  
20 reference and require the contractor to comply with the provisions of Section 12B.2. In  
21 addition, all contractors must incorporate by reference in all subcontracts and require  
22 subcontractors to comply with the requirements set forth in Sections 12B.2(a) and 12B.2(c)  
23 through 12B.2(k), and failure to do so shall constitute a material breach of contract.

24 In the performance of a contract the contractor agrees as follows:

25 (a) The contractor or subcontractor will not discriminate against any employee, City  
and County employee working with such contractor or subcontractor, or applicant for

1 employment with such contractor or subcontractor on the basis of the fact or perception of that  
2 person's race, color, religion, ancestry, national origin, age, sex, sexual orientation, gender  
3 identity, domestic partner status, marital status, disability, weight, height, AIDS/HIV status, or  
4 association with members of classes protected under this chapter or in retaliation for  
5 opposition to any practices forbidden under this chapter. Discrimination on the basis of sex  
6 includes sexual harassment as defined in Section 16.9-25(b) of this Code. The contractor or  
7 subcontractor will take action to ensure that applicants are employed, and that employees are  
8 treated equally during employment, without regard to the fact or perception of their race, color,  
9 creed, religion, ancestry, national origin, age, sex, sexual orientation, gender identity,  
10 domestic partner status, marital status, disability or AIDS/HIV status. Such action shall  
11 include, but not be limited to, the following: Employment, upgrading, demotion or transfer;  
12 recruitment or recruitment advertising; layoff or termination; rate of pay or other forms of  
13 compensation; and selection for training, including apprenticeship. Nothing in this Chapter  
14 shall require or prohibit the establishment of new classifications of employees in any given  
15 craft. The provisions of this Section with respect to age shall not apply to (1) termination of  
16 employment because of the terms or conditions of any bona fide retirement or pension plan,  
17 (2) operation of the terms or conditions of any bona fide retirement or pension plan which has  
18 the effect of a minimum service requirement, and (3) operation of the terms or conditions of  
19 any bona fide group or insurance plan. The contractor or subcontractor agrees to post in  
20 conspicuous places, available to employees and applicants for employment, notices in such  
21 form and content as shall be furnished or approved by the awarding authority setting forth the  
22 provisions of this Section.

23 (b) The prime contractor shall state that the prime contractor does not, and will not  
24 during the term of the contract discriminate in the provision of bereavement leave, family  
25 medical leave, health benefits, membership or membership discounts, moving expenses,

1 pension and retirement benefits or travel benefits as well as any benefits other than  
2 bereavement leave, family medical leave, health benefits, membership or membership  
3 discounts, moving expenses, pension and retirement benefits or travel benefits between  
4 employees with domestic partners and employees with spouses, and/or between the domestic  
5 partners and spouses of such employees, where the domestic partnership has been  
6 registered with a governmental entity pursuant to State or local law authorizing such  
7 registration, subject to the following conditions. In the event that the contractor's actual cost of  
8 providing a certain benefit for the domestic partner of an employee exceeds that of providing it  
9 for the spouse of an employee, or the contractor's actual cost of providing a certain benefit for  
10 the spouse of an employee exceeds that of providing it for the domestic partner of an  
11 employee, the contractor shall not be deemed to discriminate in the provision of benefits if the  
12 contractor conditions providing such benefit upon the employee agreeing to pay the excess  
13 costs. In addition, in the event a contractor is unable to provide a certain benefit, despite  
14 taking reasonable measures to do so, the contractor shall not be deemed to discriminate in  
15 the provision of benefits if the contractor provides the employee with a cash equivalent. The  
16 Director shall be the final arbiter of a contractor's or property contractor's compliance or  
17 substantial compliance with this Chapter and the Director's determination shall not be  
18 appealable to the Commission. Contractors shall treat as confidential to the maximum extent  
19 allowed by law or the requirements of contractor's insurance provider any request by an  
20 employee or applicant for employment for domestic partner or spousal benefits or any  
21 documentation of eligibility for domestic partner or spousal benefits submitted by an employee  
22 or applicant for employment.

23 In adopting this Section 12B.2(b), the intent of the Board of Supervisors is to  
24 equalize to the maximum extent legally permitted the total compensation between similarly  
25 situated employees with spouses and employees with domestic partners.

1 In particular, consistent with the severability clause set forth in Section 12B.6  
2 below, the Board of Supervisors intends that if a court or agency of competent jurisdiction  
3 finds that a State or federal law, rule or regulation invalidates (1) the application of this Section  
4 to any business, person, type of compensation or benefit, or location; or (2) any other  
5 requirement of this Section, then the court or agency should sever the invalid clause and  
6 leave in effect the remainder of this Section.

7 (c) The contractor or subcontractor shall provide reasonable accommodation for  
8 qualified disabled applicants for employment and for qualified disabled employees. Said  
9 contractor or subcontractor need not provide reasonable accommodation if such would  
10 present an undue hardship. An undue hardship may include but not be limited to more than a  
11 de minimus cost, violation of the seniority rights of other co-workers as established by a bona  
12 fide seniority system, or a health or safety risk to the employee or co-employees. The burden  
13 of establishing an undue hardship rests on the employer.

14 (d) The contractor or subcontractor will in all solicitations or advertisements for  
15 employees placed by or on his or her behalf, state that qualified applicants will receive  
16 consideration for employment without regard to the fact or perception of their race, creed,  
17 religion, color, ancestry, national origin, age, sex, sexual orientation, gender identity, domestic  
18 partner status, marital status, disability, weight, height or AIDS/HIV status.

19 (e) The contractor or subcontractor will send to each labor union or representative of  
20 workers with which he or she has a collective bargaining agreement or other agreement or  
21 understanding, a notice, in such form and content as shall be furnished or approved by the  
22 awarding authority, advising the said labor union or workers' representative of the contractor's  
23 or subcontractor's commitments under this Section, and shall post copies of the notice in  
24 conspicuous places available to employees and applicants for employment.

25 (f) The contractor or subcontractor shall:

1           (1) ~~will~~ Permit access to its records of employment, employment advertisements,  
2 application forms, and other pertinent data and records by the Commission, the City's  
3 awarding authority or the Fair Employment and Housing Commission, for the purposes of  
4 investigation to ascertain compliance with the nondiscrimination provisions of this Chapter,  
5 and upon request shall provide evidence that the contractor has complied or will comply with  
6 the nondiscrimination provisions of this Chapter.

7           (2) Submit an Equal Pay Report if the contractor or subcontractor has at least 20 employees  
8 worldwide and, for a contract or subcontract, the agreement has a value equal to or in excess of the  
9 Threshold Amount set forth in Administrative Code Chapter 6 or the Minimum Competitive Amount set  
10 forth in Administrative Code Chapter 21, as applicable, or, for a grant, the agreement has a value  
11 equal to or in excess of \$50,000.

12           (A) The Equal Pay Report shall provide summary information on compensation paid to  
13 employees identified by sex, race, sex and race, and data points the Commission has adopted by  
14 regulation.

15           (B) Each contractor or subcontractor shall file a complete and accurate Equal Pay  
16 Report with the Commission commencing on a date set by the Commission but no later than September  
17 30, 2015.

18           (C) The Equal Pay Report requirements of this Subsection (f)(2) shall apply to all  
19 qualifying contracts, subcontracts and grants first advertised for bid, request for qualification or  
20 proposal is issued, or initiated on a date set by the Commission but no later than September 30, 2015.

21           (g) A contractor or subcontractor shall be deemed to have breached the  
22 nondiscrimination provisions of this Chapter upon:

23           (1) A finding by the Director or such other official who may be designated by the  
24 Commission, that the contractor or subcontractor has willfully violated such nondiscrimination  
25 provisions; or

1 (2) A finding by the California Fair Employment and Housing Commission that a  
2 contractor or subcontractor has violated any provision of the California Fair Employment and  
3 Housing Act or the nondiscrimination provisions of this Chapter, provided that the California  
4 Fair Employment and Housing Commission has issued a final order pursuant to Section  
5 12970 of the Government Code, or has obtained a judgment and order enforcing the final  
6 order pursuant to Section 12973 of the Government Code; provided further, that for the  
7 purposes of these provisions, an order or injunction shall not be considered final during the  
8 period within which (1) appeal may be taken, or (2) the same has been stayed by order of  
9 court, or (3) further proceedings for vacation, reversal or modification are in progress before a  
10 competent administrative or judicial tribunal.

11 (3) Upon such finding by the Director or other official designated by the  
12 Commission, or the California Fair Employment and Housing Commission, the awarding  
13 authority shall notify the contractor or subcontractor that unless the contractor or  
14 subcontractor demonstrates to the satisfaction of the Director or other official designated by  
15 the Commission, within such reasonable period as the Commission shall determine, that the  
16 violation has been corrected, action will be taken as set forth in Subparagraphs (h) and (i)  
17 hereof.

18 (4) The Commission shall, within 10 days of the date of issuance of any finding by  
19 the Director or other official designated by the Commission for the enforcement of this  
20 Chapter, mail to any person or persons affected by said finding, a copy of said finding,  
21 together with written notice of the right to appeal such finding. Notice of appeal must be filed  
22 in writing with the Chairperson of the Commission within 20 days of the date of mailing said  
23 copy and notice.

24 (5) For purpose of appeal proceedings under this Section, a quorum shall consist  
25 of eight members of the Commission. The vote of the majority of the full Commission shall be

1 necessary to affirm, reverse or modify such decisions, order or other action rendered  
2 hereunder. Should a member of the Commission be designated under Section 12B.2(g)(1) of  
3 this Chapter, that Commissioner may not participate in an appeal under this Section except as  
4 a witness.

5 (6) The presiding officer of the Commission shall have the power to administer  
6 oaths to witnesses in appeals before the Commission under this Section. In the event that any  
7 person shall fail or refuse to appear as a witness in any such proceeding after being  
8 requested to do so, and if it shall appear to the Commission that his or her testimony, or  
9 books, records, documents or other things under his or her control are material and relevant  
10 as evidence in the matter under consideration by the Commission in the proceeding, the  
11 presiding officer of the Commission may subpoena such person, requiring his or her presence  
12 at the proceeding, and requiring him or her to bring such books, records, documents or other  
13 things under his or her control.

14 (7) All appeals to the Commission shall be open to the public. Records and  
15 minutes shall be kept of such proceedings and shall be open to public inspection. Upon  
16 reaching a decision in any appeal, the Commission shall give written notice thereof to the  
17 Director or other official designated by the Commission, and the appellant or appellants. The  
18 decision of the Commission shall be final unless within 15 days of the filing and service of  
19 written notice thereof appropriate legal proceedings are filed in a court of competent  
20 jurisdiction by any party to the contract, property contract or subcontract.

21 (8) If any contractor or subcontractor shall fail to appear at an appeal proceeding  
22 of the Commission after having been given written notice to appear, such failure to appear  
23 shall be grounds for termination of the contract, property contract or subcontract and such  
24 contractor or subcontractor shall be deemed to have forfeited all rights, benefits and privileges  
25 thereunder.



1 (9) The Commission shall promulgate rules and regulations for the implementation  
2 of the nondiscrimination provisions of this Chapter.

3 (h) The awarding authority may deduct from the amount payable to the contractor or  
4 subcontractor by the City under any contract or property contract subject to this Chapter, or  
5 may impose upon the contractor or subcontractor, a penalty of \$50 for each person for each  
6 calendar day during which such person was discriminated against in violation of the provisions  
7 of this Chapter. In addition to any other penalties provided for the violation of the  
8 nondiscrimination provisions of this Chapter or for the failure of any contractor or  
9 subcontractor to abide by the rules and regulations of the Commission, the contract, property  
10 contract or subcontract may be terminated or suspended, in whole or in part, by the awarding  
11 authority upon the basis of a finding as set forth in Section 12B.2(g) that the contractor has  
12 discriminated contrary to the provisions of this Chapter, and all moneys due or to become due  
13 hereunder may be forfeited to, and retained by, the City.

14 (i) A breach of the nondiscrimination provisions in the performance of a contract,  
15 property contract or subcontract shall be deemed by the City to be material breach of contract  
16 and the basis for determination by the awarding authority that the contractor or subcontractor  
17 is an irresponsible bidder as to all future contracts or property contracts for which such  
18 contractor or subcontractor may submit bids. Such contractor or subcontractor shall not for a  
19 period of up to two years thereafter, or until it shall establish and carry out a program in  
20 conformity with the nondiscrimination provisions of this Chapter, be allowed to act as a  
21 contractor or subcontractor under any contract or property contract.

22 (j) If a finding of discrimination is made by either the Director or the Commission, the  
23 contract awarding department shall submit a report to the Board of Supervisors, the Mayor's Office,  
24 and the Commission that provides details of what actions, if any, the contract awarding department  
25 undertook under this Chapter.

1            (k) The Commission shall provide an annual report to the Board of Supervisors summarizing  
2 the effectiveness of the information obtained from the Equal Pay Reports, recommendations for  
3 legislative change if needed, and a summary of the investigations, if any, that stem from the Equal Pay  
4 Reports. The Commission's recommendations shall include drafts of one or more ordinances if  
5 legislative change is necessary or desirable to implement the recommendations.

6            (~~l~~) Nothing contained in this Chapter shall be construed in any manner so as to  
7 prevent the City from pursuing any other remedies that may be available at law, equity or  
8 under any contract or property contract.

9            (~~m~~) The contractor or subcontractor will meet the following standards for compliance:

10            (1) If the contractor or subcontractor has been held to be an irresponsible bidder  
11 under Section 12B.2(i) hereof, the contractor or subcontractor shall furnish evidence that it  
12 has established and is carrying out a program in conformity with the nondiscrimination  
13 provisions of this Chapter.

14            (2) The contractor or subcontractor may be required to file with the Commission a  
15 basic compliance report, which may be a copy of the federal EEO-1, or a more detailed report  
16 as determined by the Commission. Wilful false statements made in such reports shall be  
17 punishable as provided by law. No contractor or subcontractor shall be held in noncompliance  
18 for not filing such a report with the Commission unless it has been specifically required to do  
19 so in writing by the Commission.

20            (3) Personally, or through its representatives, the contractor or subcontractor  
21 shall, through negotiations with the unions with whom it has collective bargaining or other  
22 agreements requiring the contractor or subcontractor to obtain or clear its employees through  
23 the union, or when the contractor or subcontractor otherwise uses a union as an employment  
24 resource, attempt to develop an agreement which will:

1 (A) Define and outline responsibilities for nondiscrimination in hiring, referral,  
2 upgrading and training;

3 (B) Otherwise implement a nondiscrimination program in terms of the unions'  
4 specific areas of skill and geography, such as an apprenticeship program, to the end that  
5 minority workers will be available and given an equal opportunity for employment.

6 (4) The contractor or subcontractor shall notify the awarding authority of opposition to  
7 the nondiscrimination provisions of a contract by individuals, firms or organizations during the  
8 term of the contract.

9 Section 2. The Administrative Code is hereby amended by revising Section 12B, to  
10 add Sections 12B.2-1, 12B.2-2, 12B.2-3, 12B.2-4, 12B.2-5, and 12B.2-6, to read as follows:

11 **SECTION 12B.2-1. EQUAL PAY ADVISORY BOARD.**

12 (a) There is hereby established an Equal Pay Advisory Board ("Advisory Board") consisting of  
13 seven voting members, who shall be appointed as follows:

14 (1) three persons appointed by the Board of Supervisors;

15 (2) two persons appointed by the Mayor; and

16 (3) two persons appointed by the Commission on the Status of Women.

17 (b) Appointing authorities shall appoint members within 60 days of the effective date of this  
18 Section 12B.2-1. If the appointing authority fails to act within the aforementioned 60 days, or if at any  
19 subsequent time there has been a vacancy on the Advisory Board for more than 60 days, the Director of  
20 the Human Rights Commission shall have the power to make an appointment to fill any such vacancy.  
21 But so long as the Director of the Human Rights Commission has not made such an appointment, the  
22 appointing authority retains the power to fill the vacancy.

23 (c) The members of the Advisory Board shall be broadly representative of the diversity of San  
24 Francisco. All members of the Advisory Board shall be residents of the City and County of San  
25 Francisco. In making appointments to the Advisory Board, the appointing authorities shall appoint

1 persons from varying backgrounds who have demonstrated abilities, skills, or experience or expertise  
2 in at least one of the following areas: women's studies or history, discrimination or employment law,  
3 equal pay advocacy, or working in an industry where wage discrimination according to sex and/or race  
4 is common.

5 (d) All members of the Advisory Board serve at the pleasure of their appointing authority.  
6 Even if a member has been appointed by the Director of the Human Rights Commission under  
7 subsection (b), the member serves at the pleasure of the member's appointing authority; provided,  
8 however, that the appointing authority may remove a member appointed by the Director of the Human  
9 Rights Commission only if the appointing authority replaces that member with another person.

10 **SECTION 12B.2-2. ORGANIZATION AND MEETINGS.**

11 (a) The initial meeting of the Advisory Board shall be held within 30 days from the date the  
12 Board of Supervisors completes its appointments, provided that a majority of all the members of the  
13 Advisory Board have been appointed. There shall be ten days' public notice of the inaugural meeting  
14 of the Advisory Board. Such notice shall be posted on the City's website, at a minimum on the website  
15 of the Human Rights Commission and the Commission on the Status of Women, and also filed at the  
16 Main Branch of the Public Library. Such notice need not include a detailed agenda, which must be  
17 published at least three days before the meeting, in accordance with the requirements of the Brown Act  
18 and the Sunshine Ordinance. For purposes of this subsection (a), completion of the Board of  
19 Supervisors' appointments includes appointments made by the Director of the Human Rights  
20 Commission in the event of a vacancy lasting more than 60 days, as specified in Section 12B.2-1(b).

21 (b) The members of the Advisory Board shall designate the Chair of the Advisory Board.

22 **SECTION 12B.2-3. POWERS AND DUTIES.**

23 (a) The Advisory Board shall analyze and recommend the best method or methods of data  
24 collection that will identify wage gaps between men and women of the same or different races and  
25 among members of different races, and that will minimize the burden on City contractors and

1 subcontractors in providing the data. The Advisory Board shall also analyze and recommend data  
2 points that may include but are not limited to employees' education, years of work experience, and  
3 specialized skills, that would aid in the analysis of wage disparities. The Advisory Board's  
4 recommendations shall include drafts of one or more ordinances if legislative change is necessary or  
5 desirable to implement the recommendations.

6 (b) The Advisory Board shall make its recommendation to the Human Rights Commission  
7 within six months of its inaugural meeting. Thereafter, the Advisory Board shall meet at least once  
8 every four months to evaluate the effectiveness of the data collection methods used and make further  
9 recommendations as appropriate.

10 **SECTION 12B.2-4. COMPENSATION.**

11 Members of the Advisory Board shall not be compensated, nor shall they be reimbursed for  
12 expenses, if any.

13 **SECTION 12B.2-5. STAFFING.**

14 (a) The Human Rights Commission shall provide in-kind professional and administrative staff  
15 to the Advisory Board.

16 (b) All City officials and departments, boards, and commissions, including but not limited to  
17 contracting departments, shall cooperate with the Advisory Board in the performance of its duties.

18 **SECTION 12B.2-6. SUNSETTING.**

19 (a) The Advisory Board and sections pertaining thereto (Sections 12B.2-1 through 12B.2-6)  
20 shall expire by operation of law on October 1, 2017, unless the Board of Supervisors adopts an  
21 ordinance continuing the existence of the Advisory Board.


22 (b) The Advisory Board shall submit a report to the Board of Supervisors by May 1, 2017  
23 recommending whether the Advisory Board should continue to operate, and if so, whether the Board of  
24 Supervisors should consider legislative changes that would enhance the capacity of the Advisory Board  
25 to achieve its goals.

1            (c) Upon expiration of the Advisory Board as specified in subsection (a), the City Attorney shall  
2 cause Sections 12B.2-1, 12B.2-2, 12B.2-3, 12B.2-4, 12B.2-5, and 12B.2-6 to be removed from the  
3 Municipal Code.

4            Section 3. Effective Date. This ordinance shall become effective 30 days after  
5 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
6 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
7 of Supervisors overrides the Mayor's veto of the ordinance.

8            Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
9 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
10 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal

## LEGISLATIVE DIGEST

[Administrative Code - Requiring City Contractors to Submit Equal Pay Report - Establishing Equal Pay Advisory Board]

**Ordinance amending the Administrative Code to require certain City contractors and subcontractors with 20 or more employees to submit an Equal Pay Report regarding compensation paid to employees; and establishing the Equal Pay Advisory Board.**

### Existing Law

There is no law that requires City contractors or subcontractors to affirmatively provide the City with a report that provides information on its employees' compensation identified by sex and race.

### Amendments to Current Law

This legislation will require City contractors and subcontractors to annually submit an Equal Pay Report that provides information on compensation paid to employees identified by sex, race, sex and race, and data points the Human Rights Commission has adopted by regulation. Relevant data points may include but are not limited to employees' education, years of work experience, specialized skills, and any other factor that would aid in the analysis of wage disparities. The Human Rights Commission may use the information contained in the Equal Pay Report as an investigative tool to investigate wage disparities based on race and gender.

This legislation also creates the Equal Pay Advisory Board for the purposes of analyzing and recommending the best method or methods of data collection that will identify wage gaps between men and women of the same or different races and among members of different races. The Advisory Board will also analyze and recommend data points that will aid in the analysis of wage disparities. The Advisory Board shall make its recommendations to the Human Rights Commission.

### Background Information

Currently, City contractors and subcontracts are prohibited from discriminating against any employee, City and County employee working with such contractor or subcontractor, or applicant for employment with such contractor subcontractor on the basis of fact or perception of that person's race, color, religion, ancestry, national origin, sex, and other protected categories. For purposes of investigation and to ascertain compliance with the City's nondiscrimination laws, City contractors and subcontractors must permit access to its records. This legislation adds another tool to the menu of options the Human Rights Commission may use to investigate allegations of wage disparities among gender and race.
