[Support Goals for Federal Funding - Community Development Block Grant, Emergency Solutions Grant, and Housing Opportunities for Persons With AIDS Programs]

Resolution supporting FY2015-2016 Community Development Block Grant, Emergency Solutions Grant and Housing Opportunities for Persons With AIDS Consolidated Plan Goals.

WHEREAS, Under Title I of the Housing and Community Development Act of 1974 as amended, the McKinney-Vento Homeless Assistance Act as amended by the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act of 2009, the AIDS Housing Opportunity Act and related federal regulations, the City and County of San Francisco is eligible to apply for and receive Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG) and Housing Opportunities for Persons With AIDS (HOPWA) funding from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, The City and County of San Francisco anticipates receiving approximately \$16,600,000 in CDBG, \$1,300,000 in ESG and \$8,200,000 in HOPWA Funds from HUD in FY 2015-2016; and

WHEREAS, On behalf of the City and County of San Francisco, the Mayor's Office of Housing and Community Development (MOHCD) and the Office of Economic and Workforce Development (OEWD) are preparing to release a Request for Proposals (RFP) for the 2015-2016 CDBG, ESG and HOPWA Programs; and

WHEREAS, The RFP is in concert with San Francisco's proposed 2015-2019 Consolidated Plan; and

WHEREAS, The 2015-2019 Consolidated Plan will be submitted for HUD approval in May 2015; and

Mayor's Office of Housing and Community Development BOARD OF SUPERVISORS WHEREAS, The Consolidated Plan details the three goals for the CDBG, ESG and HOPWA Programs: 1) Families and individuals are stably housed; 2) Communities have healthy physical, social and business infrastructure; and 3) Families and individuals are resilient and economically self-sufficient; now, therefore, be it

RESOLVED, That the Board of Supervisors supports the CDBG, ESG and HOPWA Consolidated Plan goals, and the related 2015-2016 Request for Proposals to achieve these goals.
