| 16 | Section 1. The Police Code is hereby amended by adding Article 33G, consisting of |
| 17 | Sections 3300G.1 through 3300G.18, to read as follows: |
| 18 | |
| 19 | ARTICLE 33G: PREDICTABLE SCHEDULING AND FAIR TREATMENT |
| 20 | FOR FORMULA RETAIL EMPLOYEES |
| 21 | <u>SEC. 3300G.1. TITLE.</u> |
| 22 | This Article shall be known as the "Predictable Scheduling and Fair Treatment for Formula |
| 23 | <u>Retail Employees Ordinance."</u> |

1 <u>SEC. 3300G.2. FINDINGS AND PURPOSE.</u>

| 2 | (a) Formula retail establishments are a major employment base in the City and County of San |
|----|---|
| 3 | Francisco ("City"). As of September 2014, there were approximately 1,250 formula retail |
| 4 | establishments in the City, accounting for 12% of all retailers. There are approximately 35,000 |
| 5 | persons employed by these formula retail establishments in the City, accounting for approximately 5 to |
| 6 | 6% of the City's total wage and salary employment. The City has a strong interest in ensuring that the |
| 7 | jobs these formula retail establishments provide allow employees to meet their basic needs and achieve |
| 8 | economic security. |
| 9 | (b) Erratic and on-call scheduling practices have become pervasive in formula retail |
| 10 | establishments, particularly in stores and restaurants and bars, which together represent 83% of |
| 11 | formula retail establishments in the City. Nationally, almost two-thirds of food service employees and |
| 12 | half of formula retail store employees receive their work schedules one week or less in advance. The |
| 13 | majority of these employees experience significant fluctuations in their work hours from week to week |
| 14 | and month to month. According to a recent survey of employees at chain stores and large stores, only |
| 15 | 40% of those surveyed have consistent minimum hours per week, one quarter of the employees are |
| 16 | scheduled for on-call shifts, and the vast majority find out from a supervisor if they are needed for the |
| 17 | on-call shift only two hours before the shift starts. |
| 18 | (c) Many formula retail establishments use computer software that automatically generates |
| 19 | work schedules for their employees. The schedules generated by such software are frequently erratic |
| 20 | and unpredictable, and provide employees with minimal notice of their upcoming shifts. Companies |
| 21 | seldom encourage managers to adjust those schedules to accommodate the needs of their employees. A |
| 22 | recent national study shows that although companies could use the software to provide predictable |
| 23 | schedules and greater notice to their employees, few have done so. An August 2014 New York Times |
| 24 | article described how Starbucks Coffee uses this software to create the schedules of its 130,000 |
| 25 | baristas, often resulting in an unpredictable and erratic work schedule for employees. Soon after the |

| 1 | article's publication, Starbucks announced that it planned to change its policy to give employees more |

| 2 | advance notice of their work schedules and give managers more latitude to accommodate the needs of |
| 3 | employees. |
| 4 | (d) Many employees of San Francisco formula retail establishments are impacted by |
| 5 | unpredictable scheduling practices such as frequent and last-minute changes to their work schedules |
| 6 | and use of "on-call" scheduling. In a recent survey of food retail employees in four regions of |
| 7 | <u>California – including the San Francisco Bay Area – 25% of employees reported employers requiring</u> |
| 8 | availability for on-call shifts, and almost half of employees reported having little or no input on their |
| 9 | work schedules. Unpredictable scheduling practices and last-minute work schedule changes cause |
| 10 | workers who are already struggling with low wages to live in a constant state of insecurity about when |
| 11 | they will work or how much they will earn on any given day. |
| 12 | (e) Unpredictable work scheduling practices are detrimental to San Francisco employees and |
| 13 | their families because they (1) lead to income instability, making it hard for employees to plan their |
| 14 | finances and obtain economic security; (2) create work-family conflicts that make it difficult for |
| 15 | employees to plan their child care, care giving duties, and transportation; and (3) prevent part-time |
| 16 | employees from pursuing educational opportunities or holding a second or third job that such workers |
| 17 | may need to make ends meet. Retail industry research in New York City found that more than half of |
| 18 | family caregivers in the retail industry must be available for on-call shifts, forcing them to arrange for |
| 19 | child or elder care at the last minute. Women are more likely than men to work part-time and |
| 20 | experience unpredictability in their work schedules; one study found that women were 64% of the |
| 21 | frontline part-time workforce among retail workers. |
| 22 | (f) As of September 2014, according to the Bureau of Labor Statistics, there were 7.3 million |
| 23 | <i>"involuntary part-time workers" in the United States. These individuals were working part-time</i> |
| 24 | because their hours had been cut back or because they were unable to find a full-time job. According |
| 25 | to Census data, since 2006, the number of "involuntary part-time employees" in California nearly |

- 2 *workforce nationwide works full time, and the number of those working fewer than 20 hours per week*
- 3 *has grown by 14% in the past decade. In 2012, nearly 111,000 employees in the City approximately*
- 4 <u>23% of the City's workforce were employed part-time</u>. Employers sometimes treat part-time
- 5 *employees less favorably than full-time employees. For example, the majority of full-time employees*
- 6 *<u>nationally earn more per hour than their part-time counterparts.</u>*
- 7 (g) Half of formula retailers in the City each have more than 1,000 locations nationwide,
- 8 whereas only 5% of formula retailers in the City have less than 20 locations nationwide. Given the
- 9 <u>number of employees working for formula retail establishments in the City, these businesses are well</u>
- 10 *positioned to implement fair and predictable scheduling practices for their employees. Even some*
- 11 *small local businesses in the City that do not meet the definition of "formula retail" have implemented*
- 12 *predictable scheduling practices such as giving employees 14 days' advance notice of their schedules.*
- 13 (h) The purpose of this Article 33G is to provide formula retail employees with more
- 14 *predictable, stable work schedules that are essential to their ability to earn a living and ensure a*
- 15 *healthy and decent life for themselves and their families, and to ensure that part-time employees in*
- 16 *formula retail establishments are treated fairly and equally compared to their full-time counterparts.*

18 <u>SEC. 3300G.3. DEFINITIONS.</u>

- 19 *For purposes of this Article 33G, the following definitions apply:*
- 20 <u>"Agency" shall mean the City's Office of Labor Standards Enforcement.</u>
- 21 <u>"City" shall mean the City and County of San Francisco.</u>
- 22 <u>"Employee" shall have the same meaning as the definition of "Employee" in Section 12R.3 of</u>
- 23 *the Minimum Wage Ordinance (Administrative Code Chapter 12R), as amended from time to time,*
- 24 *except that Employee shall also mean any Person who, in a particular week, is scheduled for an On-*

- 3 "Employer" shall mean any Person that owns or operates a Formula Retail Establishment with 20 one or more Employees in the City, including corporate officers or executives, who directly or 4 5 indirectly or through an agent or any other person, including through the services of a temporary 6 services or staffing agency or similar entity, employs or exercises control over the wages, hours, or 7 working conditions of any individual. For the purpose of calculating the 20-employee threshold 8 referenced herein, Employees performing work in other Formula Retail Establishments in the 9 City that are owned or operated under the same trade name by the same Employer shall be counted. Notwithstanding the foregoing definition, "Employer" does not include a Nonprofit 10 11 *Corporation or governmental entity.* 12 "Formula Retail Establishment" shall mean a business located in San Francisco that falls 13 under the Planning Code's definition of "Formula Retail Use," as amended from time to time. "Full-time" shall mean 35 or more hours of work in each work week. 14 "On-Call Shift" shall mean any shift for which an Employee must, less than 24 hours in 15 16 advance of the start of the shift, either contact the Employer or wait to be contacted by the Employer to 17 learn whether the Employer requires the Employee to report to work for the shift. 18 "Person" shall mean an individual, proprietorship, corporation, partnership, limited 19 partnership, limited liability partnership or company, trust, business trust, estate, association, joint 20 venture, agency, instrumentality, or any other legal or commercial entity, whether domestic or foreign. 21 "Part-time" shall mean fewer than 35 hours of work in each work week. "Property Services Contractor" shall mean any contractor or subcontractor of an 22 23 Employer that provides janitorial and/or security services to the Employer at a Formula Retail Establishment in San Francisco covered by this Article 33G. 24 25

1 <u>SEC. 3300G.4. ADVANCE NOTICE OF WORK SCHEDULES AND CHANGES IN WORK</u>

2 <u>SCHEDULES.</u>

3 (a) Initial Estimate of Minimum Hours. 4 (1) Prior to the start of employment, an Employer shall provide a new Employee with a 5 good faith estimate in writing of the Employee's expected minimum number of scheduled shifts per 6 month, and the days and hours of those shifts. The estimate shall not include On-Call Shifts. The 7 estimate shall not constitute a contractual offer and the Employer shall not be bound by the estimate. 8 (2) Prior to the start of employment, the Employee may request that the Employer 9 modify the proposed work schedule provided under subsection (a)(1) of this Section 3300G.4. The Employer shall consider any such request, and in its sole discretion may accept or reject the request, 10 11 provided that the Employer shall notify the Employee of its determination prior to the start of 12 *employment*. 13 (b) Two Weeks' Notice of Work Schedules. 14 An Employer shall provide its Employees with at least two weeks' notice of their work schedules 15 by doing one of the following at least every 14 days (on a "Biweekly Schedule"): (1) posting the work 16 schedule in a conspicuous place at the workplace that is readily accessible and visible to all 17 Employees, or (2) transmitting the work schedule by electronic means, so long as all Employees are 18 given access to the electronic schedule at the workplace. For new Employees, an Employer shall 19 provide the new Employee on his or her first day of employment with an initial work schedule that runs 20 through the date that the next Biweekly Schedule for existing Employees is scheduled to be posted or distributed; thereafter, the Employer shall include the new Employee in an existing Biweekly Schedule 21 22 with other Employees. For all Employees, the work schedule shall include any On-Call Shifts, where 23 applicable. If the Employer changes the work schedule after it is posted and/or transmitted, such 24 changes shall be subject to the notice and compensation requirements set forth in subsection (c) of this 25 *Section 3330G.4.*

| 1 | (c) Notice and Compensation For Schedule Changes. |

| 2 | (1) Notice Required. An Employer shall provide an Employee notice of any change to |
| 3 | the Employee's schedule that has been posted or transmitted pursuant to subsection (b) of this Section |
| 4 | 3300G.4. The Employer shall provide such notice by in-person conversation, telephone call, or email, |
| 5 | text message, or other electronic communication. This notice requirement shall not apply to any |
| 6 | schedule changes that the Employee requests, such as Employee-requested sick leave, time off, shift |
| 7 | trades, or additional shifts. |
| 8 | (2) Predictability Pay For Schedule Changes. Subject to the exceptions in subsection |
| 9 | (e) of this Section 3300G.4, an Employer shall provide an Employee with the following compensation |
| 10 | per shift for each previously scheduled shift that the Employer moves to another date or time or |
| 11 | cancels, or each previously unscheduled shift that the Employer requires the Employee to come into |
| 12 | <u>work:</u> |
| 13 | (A) With less than seven days' notice but 24 hours or more notice to the |
| 14 | Employee, one hour of pay at the Employee's regular hourly rate; |
| 15 | (B) With less than 24 hours' notice to the Employee, two hours of pay at the |
| 16 | Employee's regular hourly rate for each shift of four hours or less; and |
| 17 | (C) With less than 24 hours' notice to the Employee, four hours of pay at the |
| 18 | Employee's regular hourly rate for each shift of more than four hours. |
| 19 | Where the Employee is required to come into work, the compensation mandated by this |
| 20 | subsection (c)(2) shall be in addition to the Employee's regular pay for working that shift. This |
| 21 | subsection (c)(2) shall not apply to On-Call Shifts. |
| 22 | (d) Pay for On-Call Shifts. Subject to the exceptions in subsection (e) of this Section 3300G.4, |
| 23 | an Employer shall provide an Employee with the following compensation for each On-Call Shift for |
| 24 | which the Employee is required to be available but is not called in to work: |
| 25 | |

| 1 | (1) Two hours of pay at the Employee's regular hourly rate for each On-Call Shift of |

| 3 | (2) Four hours of pay at the Employee's regular hourly rate for each On-Call Shift of |
| 4 | more than four hours. |
| 5 | This subsection (d) shall not apply when the Employee is in fact called in for the On-Call Shift |
| 6 | or the Employer provides the Employee with 24 hours' or more notice that the On-Call Shift has been |
| 7 | cancelled or moved to another date or time. |
| 8 | (e) Exceptions. The requirements in subsections (c) and (d) of this Section 3300G.4 shall not |
| 9 | apply under any of the following circumstances: |
| 10 | (1) Operations cannot begin or continue due to threats to Employees or property, or |
| 11 | when civil authorities recommend that work not begin or continue; |
| 12 | (2) Operations cannot begin or continue because public utilities fail to supply |
| 13 | electricity, water, or gas, or there is a failure in the public utilities, or sewer system; |
| 14 | (3) Operations cannot begin or continue due to an Act of God or other cause not within |
| 15 | the Employer's control, for example, an earthquake or a state of emergency declared by the Mayor or |
| 16 | the Governor; |
| 17 | (4) Another Employee previously scheduled to work that shift is unable to work due to |
| 18 | illness, vacation, or employer-provided paid or unpaid time off where the Employer did not receive at |
| 19 | least seven days' notice of the absence; |
| 20 | (5) Another Employee previously scheduled to work that shift has not reported to work |
| 21 | on time and/or is fired or sent home or told to stay home as a disciplinary action; |
| 22 | (6) The Employer requires the Employee to work overtime (i.e., mandatory overtime); |
| 23 | <u>or</u> |
| 24 | (7) The Employee trades shifts with another Employee or requests from the Employer a |
| 25 | change in shift(s), hours, or work schedule. |

| 1 | (f) Nothing in this Section 3300G.4 shall be construed to prohibit an Employer from providing |
|----|---|
| 2 | greater advance notice of Employees' work schedules and/or changes in schedules than that required |
| 3 | by this Section. |
| 4 | (g) The requirements imposed by this Section 3300G.4 shall apply to Property |
| 5 | Services Contractors as to work performed in San Francisco at a Formula Retail |
| 6 | Establishment covered by this Article 33G, under a contract with an Employer. An Employer |
| 7 | shall include in any such contract executed on or after the operative date of this Article 33G, |
| 8 | (1) a provision requiring the Property Services Contractor to comply with this Article and (2) a |
| 9 | copy of this Article. The Employer shall retain copies of such contracts for a period of not less |
| 10 | than three years following the expiration or termination of the contract, and make such copies |
| 11 | available to the Agency for inspection upon request. In addition, Sections 3300G.6, 3300G.7, |
| 12 | 3300G.9, 3300G.10, and 3300G.11 of this Article shall apply to a Property Services |

| 16 | SEC. 3300G.5. EQUAL TREATMENT FOR PART-TIME EMPLOYEES. |
| 17 | (a) Hourly Wage. Employers shall provide Part-Time Employees with the same starting hourly |
| 18 | wage as that provided to starting Full-Time Employees who hold jobs that require equal skill, effort, |
| 19 | and responsibility, and that are performed under similar working conditions, provided that hourly pay |
| 20 | differentials between Part-Time and Full-Time Employees are permissible if such differentials are |
| 21 | based on reasons other than the Part-Time status of the Employee, such as a seniority system, merit |
| 22 | system, system which measures earnings by quantity or quality of production, performance or |
| 23 | responsibilities. This subsection (a) shall not affect the minimum hourly requirements for receipt of |
| 24 | benefits including but not limited to health care benefits. |

| 1 | (b) Access to Time Off. Employers shall provide Part-Time Employees with the same access to |

| 2 | Employer-provided paid and unpaid time off as that afforded to Full-Time Employees for the same job |
| 3 | classification. A Part-Time Employee's eligibility for Employer-provided paid or unpaid time off may |
| 4 | be pro-rated based on the number of hours that the Part-Time Employee works. This subsection (b) |
| 5 | shall not apply to Employers that are subject to the Minimum Compensation Ordinance, Administrative |
| 6 | <u>Code Chapter 12P.</u> |
| 7 | (c) Eligibility for Promotions. Employers shall provide Part-Time Employees with the same |
| 8 | eligibility for promotions as that afforded to Full-Time Employees for the same job classification, |
| 9 | provided that an Employer may condition eligibility for promotion on the Employee's availability for |
| 10 | Full-Time employment and on reasons other than the Part-Time status of the Employee, such as nature |
| 11 | and amount of work experience. |
| 12 | (g) The requirements imposed by this Section 3300G.5 shall apply to Property |
| 13 | Services Contractors as to work performed in San Francisco at a Formula Retail |
| 14 | Establishment covered by this Article 33G, under a contract with an Employer. An Employer |
| 15 | shall include in any such contract executed on or after the operative date of this Article 33G, |
| 16 | (1) a provision requiring the Property Services Contractor to comply with this Article and (2) a |
| 17 | copy of this Article. The Employer shall retain copies of such contracts for a period of not less |
| 18 | than three years following the expiration or termination of the contract, and make such copies |

| 24 | SEC. 3300G.6. NOTICE OF EMPLOYEE RIGHTS. |

| 1 | (a) The Agency shall, no later than the operative date of this Article 33G, publish and make |

| 2 | available to Employers, in English, Spanish, Chinese, Tagalog, and all languages spoken by more than |
| 3 | 5% of the San Francisco workforce, a notice suitable for posting by Employers in the workplace |
| 4 | informing applicants and Employees of their rights under this Article. The Agency shall update this |
| 5 | notice on December 1 of any year in which there is a change in the languages spoken by more than 5% |
| 6 | of the San Francisco workforce. |
| 7 | (b) Employers shall post the notice described in subsection (a) in a conspicuous place at every |
| 8 | workplace, job site, or other location in San Francisco under the Employer's control frequently visited |
| 9 | by its Employees who perform work at the Employer's Formula Retail Establishment(s). The notice |
| 10 | shall be posted in English, Spanish, Chinese, Tagalog, and any language spoken by at least 5% of the |
| 11 | Employees at the workplace, job site, or other location at which it is posted. |

| 13 | SEC. 3300G.7. REQUIREMENTS GOVERNING RETENTION OF RECORDS. |
| 14 | (a) Employers shall retain work schedules and payroll records pertaining to Employees for |
| 15 | three four years, and shall allow the Agency access to such records, with appropriate notice and |
| 16 | during business hours, to monitor compliance with the requirements of this Article 33G. |
| 17 | (b) The Director of the Agency or the Director's designee shall have access to all places of |
| 18 | labor subject to this Article 33G during business hours to inspect books and records, interview |
| 19 | employees, and investigate such matters necessary or appropriate to determine whether an Employer |
| 20 | has violated any provisions of this Article. |
| 21 | (c) Where an Employer does not maintain or retain adequate records documenting compliance |
| 22 | with this Article 33G or does not allow the Agency reasonable access to such records, it shall be |
| 23 | presumed that the Employer did not comply with this Article, absent clear and convincing evidence |
| 24 | otherwise. |

1 <u>SEC. 3300G.8. CONFLICT WITH FAMILY FRIENDLY WORKPLACE ORDINANCE.</u>

- 2 If there is an unavoidable conflict between any requirement of this Article 33G and any
- 3 <u>requirement of the San Francisco Family Friendly Workplace Ordinance, Chapter 12Z of the</u>
- 4 <u>Administrative Code, the requirements of this Article shall prevail.</u>
- 5

6 <u>SEC. 3300G.9. EXERCISE OF RIGHTS PROTECTED; RETALIATION PROHIBITED.</u>

- 7 (a) It shall be unlawful for an Employer or any other Person to interfere with, restrain, or deny
- 8 *the exercise of, or the attempt to exercise, any right protected under this Article 33G.*
- 9 (b) It shall be unlawful for an Employer to discharge, threaten to discharge, demote, suspend,
- 10 *or otherwise take adverse employment action against any Employee in retaliation for exercising rights*
- 11 *protected under this Article 33G. Such rights include but are not limited to:*
- 12 (1) the right to request a modification to the initial proposed work schedule provided
- 13 *under Section 3300G.4(a);*
- 14 (2) the right to inform any person about an Employer's alleged violation of this Article;
- 15 (3) the right to file a complaint with the Agency alleging a violation of this Article;
- 16 (4) the right to cooperate with the Agency or other persons in the investigation or
- 17 *prosecution of any alleged violation of this Article;*
- 18 (5) the right to oppose any policy, practice, or act that is unlawful under this Article;
- 19 <u>and</u>
 - (6) the right to inform any person of his or her rights under this Article.

22 <u>SEC. 3300G.10. INVESTIGATION AND ADMINISTRATIVE ENFORCEMENT BY THE</u> 23 <u>AGENCY.</u>

24 (a) Authority. The Agency is authorized to take appropriate steps to enforce and coordinate
25 enforcement of this Article 33G, including the investigation of any possible violations of this Article.

| 1 | (b) Determination of Violation and Penalties. |
|----|---|
| 2 | (1) Where the Agency has reason to believe that a violation has occurred, it may order |
| 3 | any appropriate temporary or interim relief to mitigate the violation or maintain the status quo pending |
| 4 | completion of a full investigation. |
| 5 | (2) After investigating a possible violation of this Article 33G, and providing the |
| 6 | Employer the opportunity to respond to the allegations, if the Agency determines that a violation has |
| 7 | occurred, it may issue a Determination of Violation. The Determination of Violation shall identify the |
| 8 | violation and the factual basis for the determination. The Agency shall serve the Determination of |
| 9 | Violation on the Employer by United States mail and the date of service shall be the date of mailing. In |
| 10 | the Determination of Violation, the Agency may order any appropriate relief, provided, however, that |
| 11 | during the first six months following the operative date of this Article 33G, the Agency must |
| 12 | issue warnings and notices to correct. Thereafter, the Agency may order relief including, but |
| 13 | not limited to, requiring the Employer to offer payment of lost wages to the Employee or person whose |
| 14 | rights under this Article were violated, and the payment of an additional sum as an administrative |
| 15 | penalty in the amount of \$50 to each Employee or person whose rights under this Article were violated |
| 16 | for each day that the violation occurred or continued. To compensate the City for the costs of |
| 17 | investigating and remedying the violation, the Agency may also order the violating Employer to pay to |
| 18 | the City an amount that does not exceed its enforcement costs. |
