3 **affirming the Planning Department's determination under the California Environmental**
4 **Quality Act.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Environmental Findings. The Planning Department has determined that the
14 actions contemplated in this ordinance comply with the California Environmental Quality Act
15 (California Public Resources Code Section 21000 et seq.). Said determination is on file with
16 the Clerk of the Board of Supervisors in File No. 140981 and is incorporated herein by
17 reference.

18 Section 2. The Administrative Code is hereby amended by adding Section 98.3, to read
19 as follows:

20 SEC. 98.3. SAN FRANCISCO STREET LIGHT POLICY

21 (a) The San Francisco Board of Supervisors finds that:

22 (1) Quality street lighting helps define a positive urban character and
23 supports nighttime activities.

24 (2) Nighttime lighting is critical for both traffic safety and pedestrian safety
25 and security.

(3) Functioning street lights are essential for maintaining high quality of life,
public safety, and economic activity in San Francisco.

1 (4) Roadway and pedestrian level lighting are both important aspects of
2 street lighting responsibilities.

3 (5) Pursuant to the Charter, the San Francisco Public Utilities Commission
4 has jurisdiction over the provision of City-owned street lighting.

5 (6) Ownership and maintenance responsibility of the City's streetlights is
6 currently divided primarily between the San Francisco Public Utilities Commission and a
7 private utility.

8 (7) The current division of ownership and maintenance responsibility of the
9 City's street lights between the San Francisco Public Utilities Commission and a private utility
10 does not best advance the interests of San Francisco residents.

11 (8) The ultimate development of a single, municipally-managed street light
12 program would benefit all San Francisco residents and the City shall strive to unify streetlight
13 management under a municipal program. As an initial step, the Board of Supervisors urges the
14 San Francisco Public Utilities Commission to perform a study of the costs, benefits and methods
15 of a single, unified municipal program.

16 (b) In furtherance of the Street Light Policy, it shall be the policy of the City

17 (1) That lighting should be designed not only for vehicular traffic on the
18 roadways, but also for pedestrians on sidewalks and pedestrian paths;

19 (2) That whenever at least 50% of the lighting along an existing street block
20 is upgraded, or lighting along a new street block is added, adequate pedestrian level lighting
21 should be evaluated and included, consistent with the Better Streets Policy and Plan, as funds
22 are available;

23 (3) That management of street lights and coordination with the private utility
24 to more effectively provide, maintain, and repair the City's street lights should include:

1 (A) Transitioning to light-emitting diode (LED) technology, with the
2 exception of those lights deemed inappropriate or not conducive to LED transition, as described
3 in the San Francisco Public Utilities Commission's Guide to San Francisco Street Lights;

4 (B) Further integrating the private utility's street light maintenance
5 operations into the City 311 system, and including more detailed and timely reporting of
6 completed repairs;

7 (C) Integrating up to date street light infrastructure information into
8 the existing City GIS database by December 1, 2014, and developing pedestrian scale lighting
9 standards by December 1, 2014;

10 (D) Establishing a uniform, shared standard for levels of service for
11 the repairs of all street lights, such that simple outages should be corrected within 48 hours of
12 being reported; and

13 (E) Whenever a street light is repaired or replaced, repairing or
14 replacing such street light should be in accordance with the Street Light Policy.

15 (4) That the City shall strive to unify streetlight management under a
16 municipal program.

17 (c) All public and private entities operating and maintaining street lights in the City shall
18 provide an annual report to the Board of Supervisors documenting their efforts to manage street
19 lighting in a manner consistent with the Street Light Policy.



1 Section 3. Effective Date. This ordinance shall become effective 30 days after
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4 of Supervisors overrides the Mayor's veto of the ordinance.

LEGISLATIVE DIGEST

[Administrative Code - Street Light Policy]

Ordinance amending the Administrative Code to provide a Street Light Policy; and affirming the Planning Department's determination under the California Environmental Quality Act.

Existing Law

The proposed ordinance would amend Administrative Code to provide a City wide unified Street Light Policy.

Amendments to Current Law

The Ordinance would adopt a Citywide Street Light Policy. In furtherance of the policy, lighting should be designed not only for vehicular traffic, but also for pedestrians on sidewalks and pedestrian paths. Whenever at least 50% of the lighting along an existing street is upgraded, or lighting along a new street is added, adequate pedestrian scale lighting should be evaluated and included as appropriate.

Further, the Policy urges management of street lights and coordination with San Francisco's private street light utility to more effectively provide, maintain, and repair the City's street lights; to transition to light-emitting diode (LED) technology; to further integrate the private utility's street light maintenance operations into the City 311 system; to create more detailed and timely reporting of completed repairs; to integrate up to date street light infrastructure information into the existing City GIS database by December 1, 2014; to develop pedestrian scale lighting standards by December 1, 2014; and to establish a uniform, shared standard for levels of service for the repairs of all street lights facilitating correction of outages within 48 hours of being reported. The Policy further provides that the City should strive to unify streetlight management under a municipal program.

Background Information

Pursuant to the Charter, the San Francisco Public Utilities Commission has exclusive jurisdiction and control over providing City-owned street lighting. Currently, ownership and maintenance responsibility of the City's streetlights is divided between the San Francisco Public Utilities Commission and a private utility. The proposed Street Light Policy urges more effective coordination of street light activities and functions and the creation of a single, municipally-managed unified streetlight program.

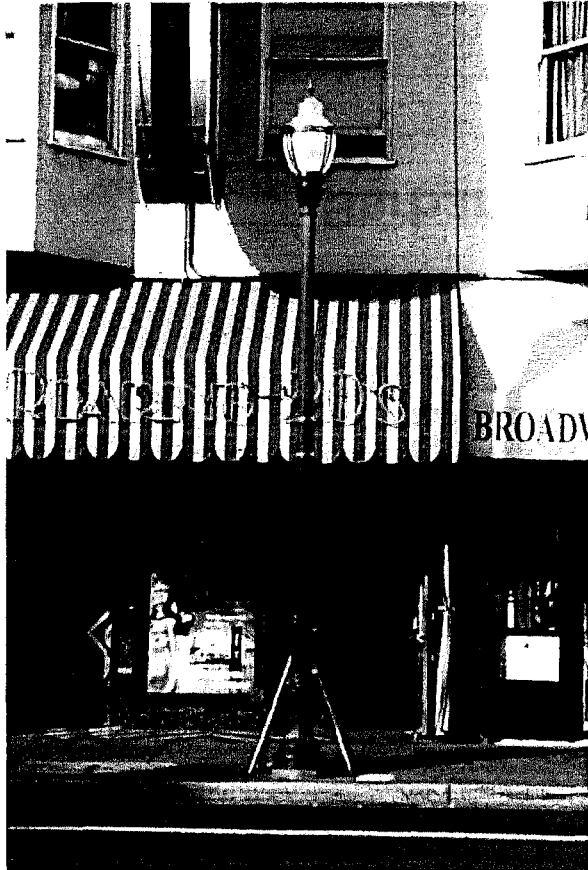

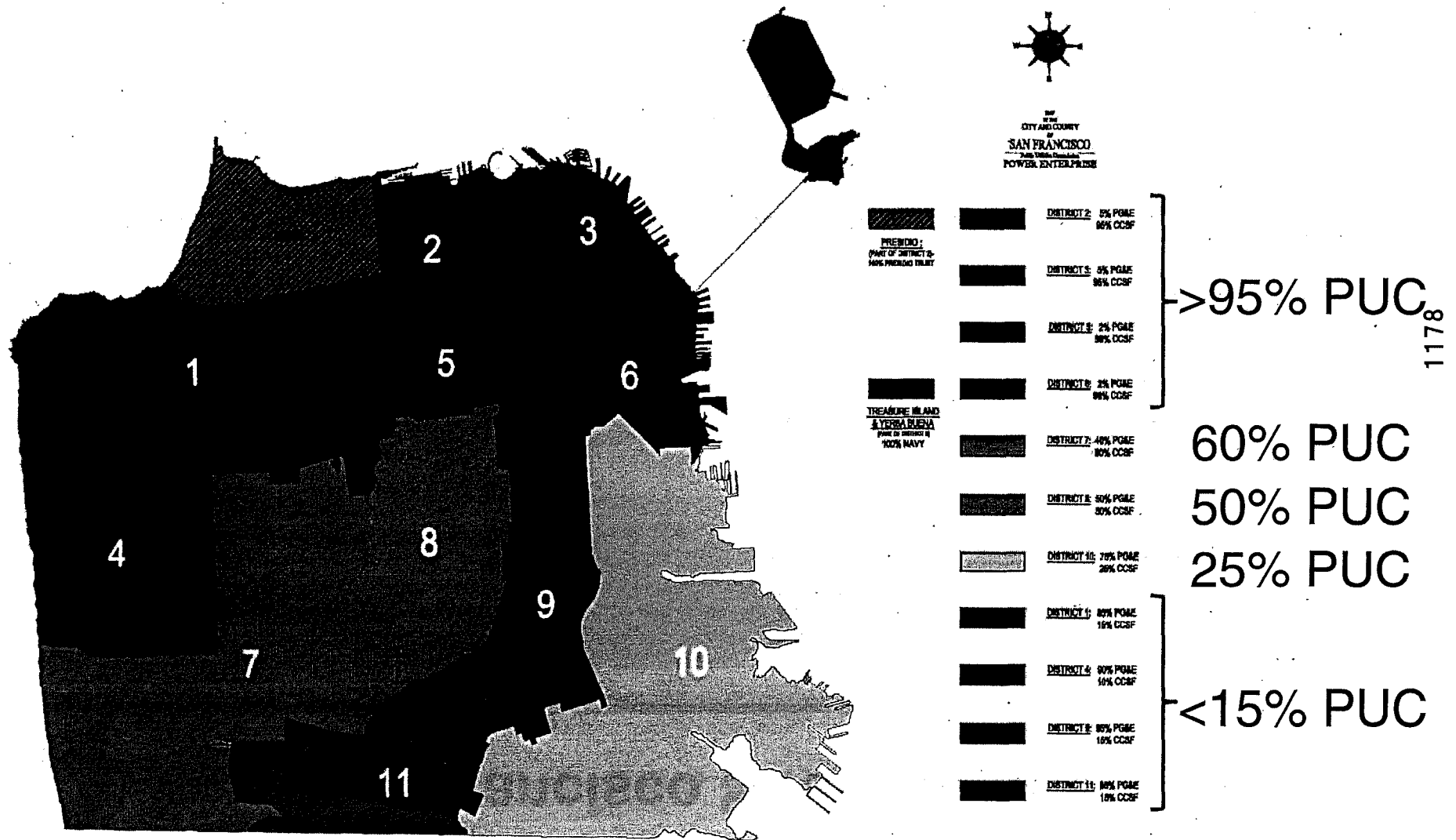

SFPUC Street Light Ownership By District





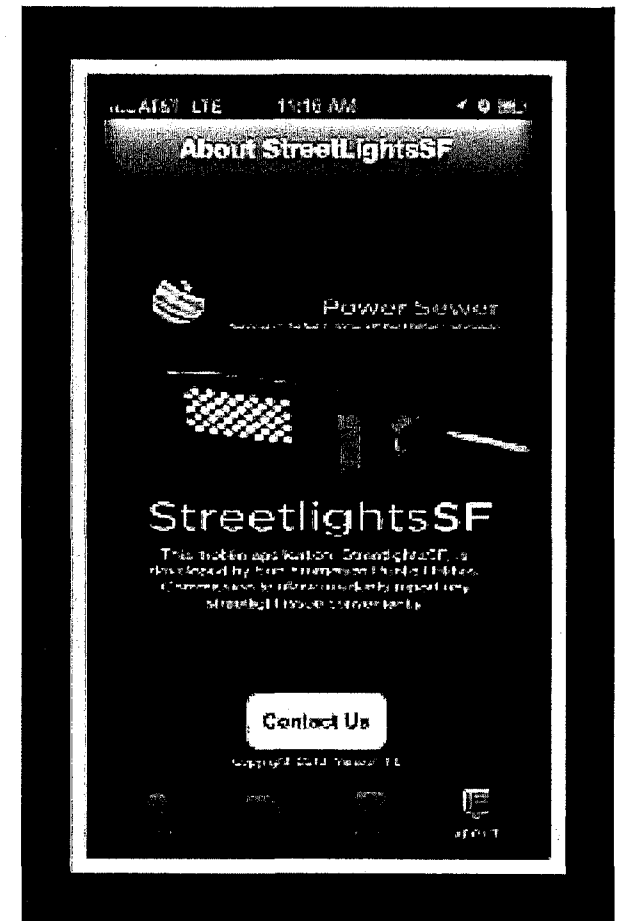
Street Light Problem Reporting

1. Residents report street light issues to 311.
2. 311 automatically relays street light issues to SFPUC via electronic file. Non-business hour street light emergencies are reported immediately by phone.
3. SFPUC reviews internal digital database to determine ownership.
4. PG&E has voluntarily coordinated with 311 since 1/2011.



Street Light Problem Reporting

1. Residents may also report street light problems via StreetlightsSF.
2. iPhone and Android owners can use this mobile application. The application automatically reports the outage to 311.
3. 311 serves as the “hub” and all outages are reported and repairs tracked there.

PG&E Street Light Levels of Service: New Requirements from CPUC

- In August, CPUC issued its final Decision in Phase 1 of PG&E's General Rate Case.
- City participation in the case included a focus on Street Light reliability issues.
- The Decision adopts PG&E's street light O&M revenue request, AND performance reporting and goals, specifically....

PG&E Street Light Levels of Service: New Requirements from CPUC

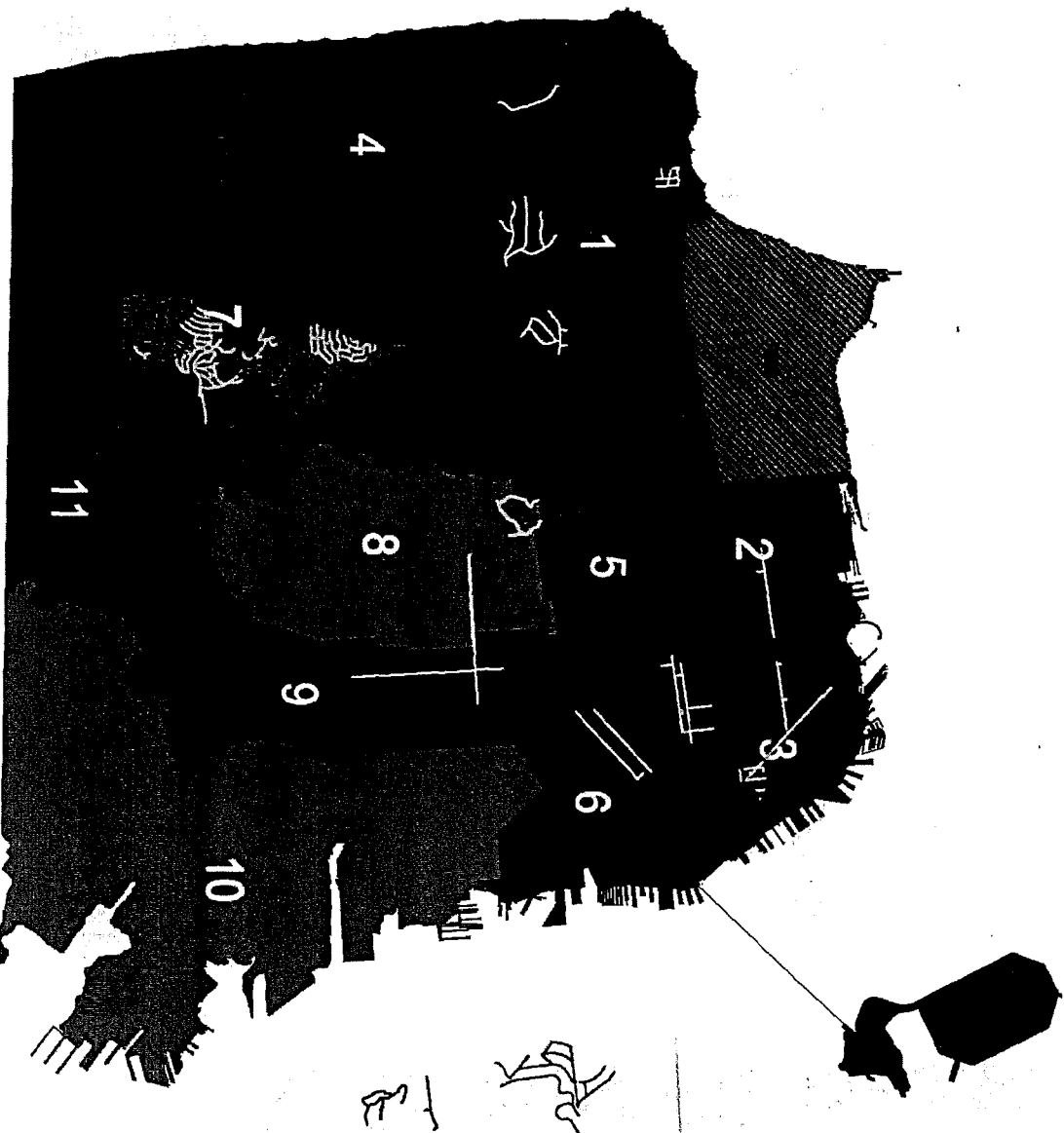
- PG&E required to produce formal written performance goals related to street lighting burnouts and replacements.
- PG&E required to report its performance regularly (on an annual basis) to the CPUC and requesting municipalities.
- PG&E required to “consistently meet its performance goals”. The CPUC “shall formally hold PG&E responsible for adhering to these goals.”
 - 90% of streetlight burnouts should be repaired within 5 days
 - 75% of underground and/or cable repairs should be completed within 30 days.



Maintenance Challenges – Series Loops

1. Replacement of series loops is a priority for SFPUC capital expenditures because series loops cause many street light outages.
2. SFPUC series loops:
 - 8 remaining series loops with 339 street lights.
 - Funding to convert included in SFPUC Capital Plan.
3. PG&E series loops:
 - PG&E series loops conversion project funded
 - CPUC required PG&E to track all spending on the project in a separate account and make every effort to complete the project in a timely manner.

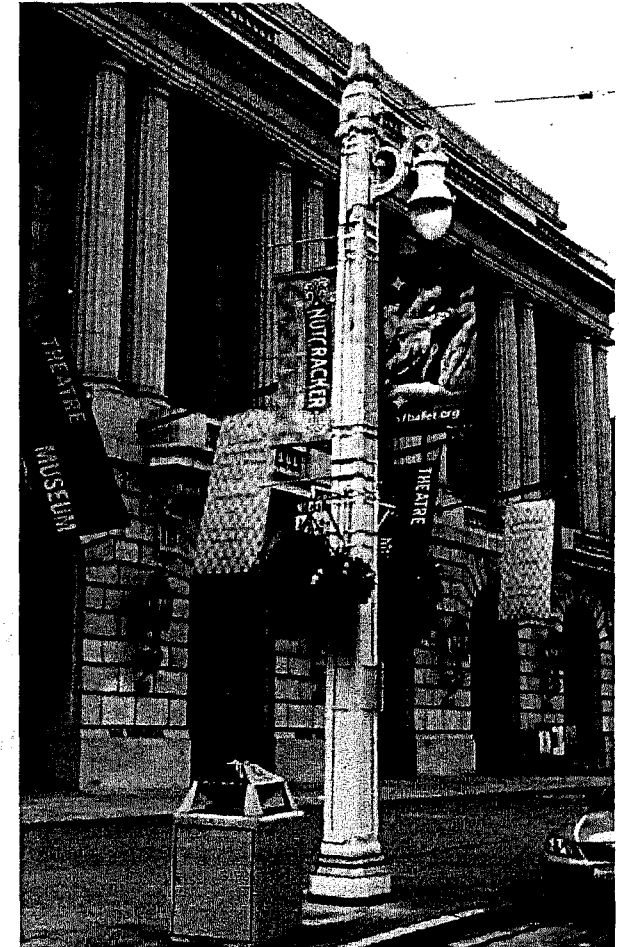
Map of Series Loops

Street Light Funding

1. Administrative Code, Chapter 25:
Street lighting must be paid for
by the sponsors of street
improvement projects.
 - Examples: Octavia Blvd., Mission
Bay, Hunters Point
2. Street Lights FY 14/16 Capital
Budget is \$26,016,000, including
pedestrian components
 - Replacement, Repairs, Improvements:
\$2,050,000
 - Other Street and Pedestrian Light
Capital Improvements: \$23,966,000





Funding Priorities

Priority 1	High crime rate in areas due to poor lighting.
Priority 2	Night time accidents due to unsafe street conditions such as sharp intersections, street curvature, or grade.
Priority 3	Cost of maintenance of street light systems are excessively high due to its age and condition.
Priority 4	High number of outages and complaints as reported by the general public.
Priority 5	Capital projects managed by other City departments generating requirements for street lighting upgrades.
Priority 6	Increased volume of vehicular and pedestrian street usage and/or non-conformance to roadway lighting IES (Illuminating Engineering Society) standards.
Priority 7	Public or Board of Supervisor requests to increase lighting levels or modify design elements to address specific area or neighborhood characteristics.

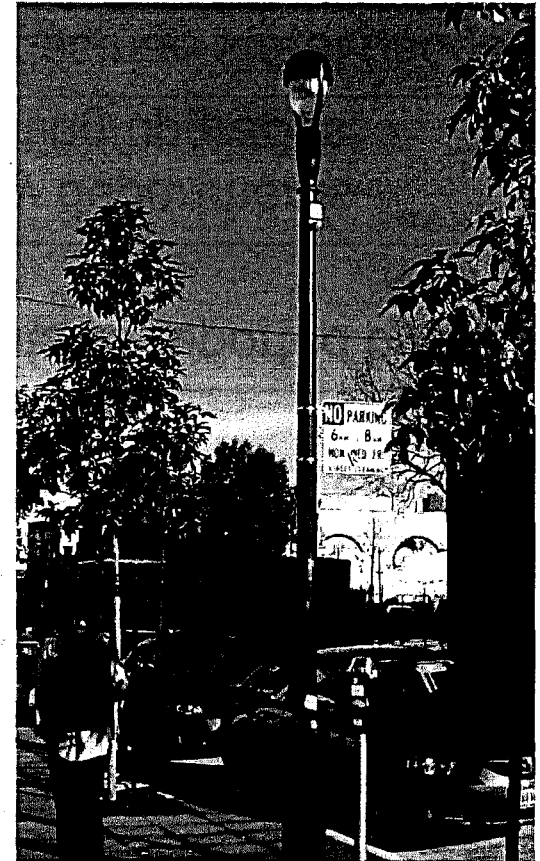
Pedestrian Lighting Policy

Better Streets Plan

- Provides guidance on how to design pedestrian friendly streets.
- Encourages street lighting design with adequate light levels for pedestrians.

SFPUC Pedestrian Lighting Policy

- Adopted in January 2012.
- SFPUC accepts ownership responsibility for future pedestrian lights in predefined conditions.
- SFPUC now requires sponsors of improvements to include pedestrian lights.
- Including pedestrian lighting in design of improvement projects.





Street Light Assessment

- Estimates urgent repair needs at \$1,585,000 to \$5,681,000.
 - Estimates 95-454 concrete streetlights are in need of urgent repair action for an estimated \$507,000 to \$2,431,000
 - Estimates 317-989 steel streetlights are in need of urgent repair action for an estimated \$1,075,000 to \$3,250,000
- Provides a uniform, comprehensive method for assessing assets in the field. Developing implementation plan.
- Capital Plan funds ongoing implementation of assessment efforts.

These costs are an estimate of the urgent repair needs.


