9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Heinz Hofmann and Thomas Buckley
12 v. City and County of San Francisco, et al., United States District Court for the Northern
13 District of California, Case No. 11-4016 CW, by the payment of \$200,000.

14 Section 2. The above-named action was filed in United States District Court for the
15 Northern District of California on May 7, 2012, and the following parties were named in the
16 lawsuit: Heinz Hofmann and Thomas Buckley, Plaintiffs; City and County of San Francisco,
17 Defendant.




