**Subject: SFPUC – Regional Groundwater & Recovery Project  
Supplemental Appropriation Request De-obligating \$1,400,000**

Ladies and Gentlemen:

Attached is a completed copy of the Request for Supplemental Appropriation de-obligating \$1,400,000 from the Water System Improvement Program (WSIP), Project CUW301-03 Regional Groundwater and Recovery Project.

The San Francisco Public Utilities through the Association of Bay Area Governments (ABAG) has applied for Proposition 84 Integrated Regional Water Management Grant from the State of California in the amount of \$1,400,000. These grant funds will replace a portion of the current funding for the Regional Groundwater and Recovery Project.

In accordance with Controller’s policy, the de-obligation of appropriated project funds must be approved by the Board of Supervisors either through the annual budget process or supplemental appropriation.

This is a companion measure to the grant agreement between the San Francisco Public Utilities Commission and the Association of Bay Area Governments submitted to the Board of Supervisors for approval.
