Honorable Board of Supervisors,

On October 30, 2014, the California Department of Alcoholic Beverage Control processed an application for SMARKET LLC, a gourmet market / grocery store, for a person to person and premises to premises transfer of a type 21, Off-Sale General license. The intended premises address in San Francisco is located in Supervisor District 6 at 201 Folsom Street, Suite 101. The location is within census tract #0615.00 which allows for eleven (11) off-sale type licenses within the census tract, based on the most recent estimated population count. At the present time, twenty-one (21) Off-Sale type licenses are issued within this census tract. The census tract is deemed to be over-concentrated at this time with Off-Sale type licenses.

Pursuant to the requirements of Section 23958.4 of the Business and Professions Code, SMARKET LLC, here-after known as "Applicant", is applying for a "PCN" review by the San Francisco Board of Supervisors. After review of all pertinent facts regarding this premises and the surrounding area, applicant hopes and wishes that the Board will find that the issuance of the applied-for type 21 Off-Sale General license will fulfill the public's convenience or necessity.

ABC LICENSE INFORMATION:

The type 21, Off-Sale General license is being purchased from a current licensee within Supervisor District #6. The current ABC application is requesting transfer of ownership from the current licensee to the Applicant and from the current licensee's location to the applicant's location at 201 Folsom Street. The new intended address for the license on Folsom Street is also located within Supervisor District #6. The transfer of this license will not add to the current number of off-sale licenses located within Supervisor District #6.

BUSIENSS OPERATION INFORMATION:

SMARKET LLC intends to operate a full service gourmet market / grocery store which will also have seven (7) types of prepared food venues within the store to provide on-site food preparation for on-site meal consumption and take-out prepared foods for off-site meal consumption. The applicant is applying to ABC for a person to person and premises to premises transfer (double transfer) of the type 21 Off-Sale General license for the grocery store operation of the business to provide patrons the opportunity to purchase beer, wine, and distilled spirits for off-premises consumption while shopping for groceries.

Applicant is also applying for an original type (41) On-Sale Beer and Wine Eating Place type license for the food venues within the subject grocery store to provide patrons the opportunity to complement their meal service with beer and wine if they wish. The type 41 On-Sale Beer and Wine license is not the subject of this request to the Board and the applicant will be providing substantiation to ABC as to how the premises will fulfill the public's convenience or necessity with the applied-for type 41 license. The food preparation and service at the grocery store is being mentioned so as to give the Board the full scope of services that will be offered at the grocery store for the benefit of the public.

The premises is part of the Lumina building complex located on Folsom Street between Main and Beale Streets comprised of two (2) buildings and two (2) towers. The premises will occupy suites #101, 102, 103 and 104 at 201 Folsom Street. The official business address will be 201 Folsom Street, Suite 101. The premises will occupy approximately 9,100 square feet of commercial space on the ground floor, level with street and pedestrian traffic. Copies of the premises diagrams, with measurements of each unit, are attached for the Boards review.

The proposed store hours will be from 7:00 am to Midnight, each day of the week. Estimated percentage of alcoholic beverage sales, as compared to food, meal, and non-alcohol items will be 7-10%. Copy of ABC form ABC-257, Licensed Premises Diagram and Planned Operation (Retail) is attached for your review.

SUBSTANTIATION FOR A POSITIVE FINDING OF PUBLIC CONVENEINCE OR NECESSITY:

1. Issuance of the applied-for license would benefit the existing 1,289 residential units located within 500 feet of the proposed premises location.

Currently there are 1,289 residential units in existing buildings located within 500 feet of the proposed premises location. The persons who reside in these units will benefit from a gourmet market / grocery store being located within walking distance of their residences which provides groceries, prepared foods for take-out and on-site consumption. It would be a convenience to these residents to have alcoholic beverages available for purchase to take back to their residences.

2. Issuance of the applied-for license would benefit the future 1,709 residential units located within 500 feet of the proposed premises location.

Within 500 feet of the proposed premises location there are approximately eight (8) buildings currently under construction which will contain an additional 1,709 residential units to the immediate area. With the addition of these residential units, the residential population in the immediate area will more than double, increasing the number of residents in need of a nearby gourmet market / grocery store which provides groceries, prepared food items for take-out and on-site consumption, and have the availability of off-sale alcoholic beverages that they could take back to their residences.

The current buildings under construction are as follows -

280 Beale Street - 479 residential units

288 Beale Street - 24 residential units

301 Beale Street - 285 residential units (Lumina Tower B)

333 Beale Street – 80 residential units (Lumina Plaza C)

255 Fremont Street - 85 residential units

399 Fremont Street - 452 residential units

318 Main Street – 59 residential units (Lumina Plaza A)

338 Main Street – 245 residential units (Lumina Tower D)

Total residential units under construction at this time - 1,709*

*Information based on the San Francisco Planning Department web-site, San Francisco Property Information Map, Building Permits.

3. The issuance of the applied-for off-sale license would benefit local workers and business people who work in the immediate area who are within walking distance of the premises.

4. The issuance of the applied-for off-sale license would benefit persons traveling through the area on their way home who shop at the premises for groceries and other items prior to boarding public transportation.

Current public transit that operates from boarding areas located across the street from the proposed premises are AC Transit, Golden Gate Transit, Greyhound, Municipal Railway, SamTrans, and WestCAT Lynx which serves the City, the North Bay and the East Bay.

The proposed premises will be near the proposed new Transbay Transit Center when it is completed.

- 5. The issuance of the applied-for off-sale license would benefit tourists and visitors to the City in general, the Embarcadero Area, and the nearby AT&T Park.
- The issuance of the applied-for license would benefit the public in general at this location for the premises is unique and there are no other like premises in the area that offers the groceries, prepared foods and meals, and other products that this premises offers.

SUMMARY:

The premises will be a full service gourmet market / grocery store which will provide unique food products for both on and off-premises consumption for approximately 3,000 residential units within the immediate area, and countless persons who work, visit and travel through the area. It would be a convenience to the public for the premises to be able to offer off-sale beer, wine and distilled spirits while they patronize the premises for its food / grocery products.

The Applicant wishes for the Board to consider the above facts and hopes that they find that the issuance of the applied-for Off-Sale type 21 Off-Sale General license would fulfill the public's convenience or necessity and allow the issuance of said license.




