10 WHEREAS, Matt Shelton is seeking the issuance of a Type 64 general theatre
11 license for Shelton Theater, located at 533 Sutter Street; and

12 WHEREAS, The Planning Department has verified that the area is properly
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero (0) protests with the
15 Department of Alcoholic Beverage Control under California Business and Professions
16 Code, Section 24013, and recommends that the Department of Alcoholic Beverage
17 Control issue the liquor license with the existing conditions placed on the premises on
18 September 22, 2009, which are on file with the Clerk of the Board of Supervisors in File
19 No. 140914 and are incorporated herein by reference; now, therefore, be it

20 RESOLVED, That in accordance with California Business and Professions Code,
21 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
22 hereby determines that the issuance of a Type 64 general theatre license to 533 Sutter
23 Street (District 3), to Matt Shelton for the Shelton Theater, will serve the public
24 convenience or necessity of the City and County of San Francisco; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
2 San Francisco hereby endorses and adopts the recommendations of the Police
3 Department listed above, and recommends that the Department of Alcoholic Beverage
4 Control issue the license with those conditions.


