 with experience that uniquely qualifies him to serve on the Local Homeless
 Coordinating Board.
- 3. The Local Homeless Coordinating Board has attempted to fill the position, for which Deleano Seymour was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Deleano Seymour is qualified to serve on the Local Homeless Coordinating Board.

After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Local Homeless Coordinating Board at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Deleano Seymour, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101, that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
