Be it ordained by the People of the City and County of San Francisco:


Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Elvis Taouil v. City and County of San Francisco, et al., United States District Court, Case No. C13-3674 DMR by the payment of \$50,000.

Section 2. The above-named action was filed in the United States District Court on August 8, 2013, and the following parties were named in the lawsuit: Plaintiff Elvis Taouil and Defendants City and County of San Francisco, Ross Mirkarimi, and Vincent Calvarese.


