Conditions: (1) The sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 2:00 p.m. and 2:00 a.m. each day of the week on the main (ground) floor. The lower floor (basement level) shall permit the sales, service, and consumption of alcoholic beverages Sunday through Wednesday 2:00 p.m. to 1:00 a.m. and 2:00 p.m. to 1:45 a.m. Thursday, Friday, and Saturday. The lower floor (basement level) may sell, service, and allow consumption of alcoholic beverages from 2:00 p.m. to 2:00 a.m. on New Year's Eve, Christmas Eve, Thanksgiving Eve, the Fourth of July, and the Sunday before Labor Day and Memorial Day only. (2) No noise shall be audible beyond the area under control of the licensee. (3) The sales, service and consumption of alcoholic beverages shall remain within the confines of the area depicted on the ABC form 257. (4) The sale of alcoholic beverages for consumption off the premises is strictly prohibited. (5) Petitioner shall not permit its patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. The orderly standing of patrons in line to enter the premises shall not be considered loitering or unlawfully congregating, (6) Petitioner shall not make structural changes in the premises interior without prior written approval from the Department.
