## Adult Probation Department Proposition 47 Review Method

- Provided data list of cases that appeared eligible under statute to District Attorney's Office and Public Defender
- APD Supervisors reviewed each case and made recommendations based on APD guidelines that heavily focused on supervision performance



## Status of Adult Probation Department Proposition 47 Case Review

- 888 cases potentially eligible for Proposition 47 relief have been reviewed
- 650 cases found to be ineligible for Prop 47 relief by statute or per APD's guidelines
- 103 cases are **recommended** for reduction and termination of probation
- 135 cases are **recommended** for reduction and to remain on misdemeanor probation

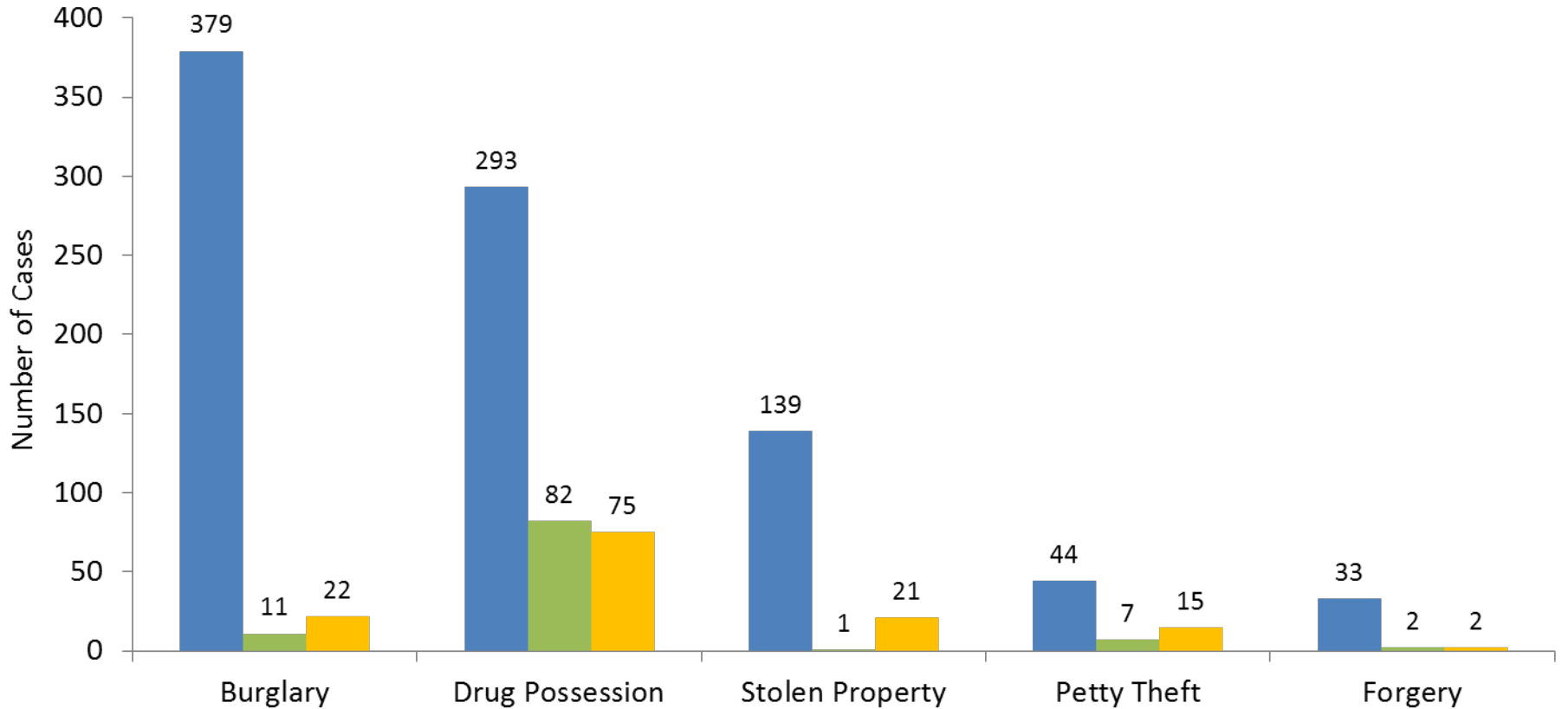

## Adult Probation Clients Granted Prop 47 Relief

- 102 individuals on probation have been granted some form of relief under Prop 47 pursuant to PC 1170.18
  - 49 (1% of all probation clients) remained on formal misdemeanor probation
  - 53 (1% of all probation clients) were terminated from probation
    - 30 successfully terminated from probation (2 of which were PC 1170h clients and 2 were PRCS clients)
    - 13 unsuccessfully terminated (1 of which was a PC 1170h clients)
    - 10 placed on court probation
