Section 1. Findings

Note:

(a) The Office of the District Attorney applied for funding from the State of
California Office of Traffic Safety for the "Alcohol and Drug Impaired Driver Vertical
Prosecution Program" and was awarded Two Hundred Eighty-Seven Thousand and Six
Hundred Twenty-Four dollars (\$287,624).

(b) The award period is from October 1, 2014 to September 30, 2015.

(c) The grant does not include any provision for indirect costs.

Section 2. Authorization to accept and expend grant funds.

(a) The Board of Supervisors hereby authorizes the Office of the District
Attorney to retroactively accept and expend, on behalf of the City and County of San
Francisco, California Office of Traffic Safety grant funds in the amount of \$287,624 to
