RESOLUTION J.

[Approval of a 120-Day Extension for Planning Commission Review of an Ordinance (File No. 141131) Amending the Planning Code - Formula Retail and Large-Scale Retail Controls]

Resolution extending by 120-days the prescribed time within which the Planning Commission may render its decision on an Ordinance (File No. 141131) amending the Planning Code, to exclude Financial Services, Limited Financial Services, and Personal Services above the ground floor from the definition of Formula Retail and require that where there has been a prior determination that a proposed project is a Formula Retail Use and the project sponsor subsequently removes one or more Formula Retail Use features, the project will remain subject to a Conditional Use Authorization; affirming the Planning Department's California Environmental Quality Act determination; and making findings consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1.

WHEREAS, On October 27, 2014, Board File No. 140844 was duplicated and amended in Committee to create Board File No. 141131 which would amend the San Francisco Planning Code to exclude Financial Services, Limited Financial Services and Personal Services above the ground floor from the definition of Formula Retail and require that where there has been a prior determination that proposed project is a Formula Retail Use and the project sponsor subsequently removes one or more Formula Retail Use features, the project will remain subject to a Conditional Use Authorization; and

WHEREAS, On or about December 3, 2014, the Clerk of the Board of Supervisors referred the proposed ordinance to the Planning Commission, which currently is reviewing the proposed ordinance; and

15	Section 1. Findings.
16	(a) The Planning Department has determined that the actions contemplated in this
17	ordinance comply with the California Environmental Quality Act (California Public Resources
18	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
19	Supervisors in File No and is incorporated herein by reference. The Board of
20	Supervisors hereby affirms this determination.
21	(b) On, the Planning Commission, in Resolution No, adopted
22	findings that the actions contemplated in this ordinance are consistent, on balance, with the
23	City's General Plan and eight priority policies of Planning Code Section 101.1. The Board
24	adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the

(c) Pursuant to Planning Code Section 302, this Board finds that this Planning Code 1 Amendment will serve the public necessity, convenience, and welfare for the reasons set forth 2 in Planning Commission Resolution No. _____ and the Board incorporates such reasons 3 herein by reference. 4 Section 2. The Planning Code is hereby amended by moving Subsection 303(i) to new 5 Section 303.1 and amending those provisions to read as follows, and revising Section 303 to 6 read as follows: 7 8 Section 303, CONDITIONAL USES. * * * * 9 (i) Formula Retail Uses. See Section 303.1 for Formula Retail uses. 10 (1) Formula Retail Use. A formula retail use is hereby defined as a type of retail sales 11 12 activity or retail sales establishment which has eleven or more other retail sales establishments located 13 in the United States. In addition to the eleven establishments, the business maintains two or more of the following features: a standardized array of merchandise, a standardized facade, a standardized decor 14 15 and color scheme, uniform apparel, standardized signage, a trademark or a servicemark. 16 (A) Standardized array of merchandise shall be defined as 50% or more of instock merchandise from a single distributor bearing uniform markings. 17 (B) Trademark shall be defined as a word, phrase, symbol or design, or a 18 combination of words, phrases, symbols or designs that identifies and distinguishes the source of the 19 goods from one party from those of others. 20 21 (C)-Servicemark shall be defined as word, phrase, symbol or design, or a combination of words, phrases, symbols or designs that identifies and distinguishes the source of a 22 23 service from one party from those of others. (D) Decor shall be defined as the style of interior furnishings, which may 24 25 include but is not limited to, style of furniture, wall coverings or permanent fixtures.

1	(E) Color Scheme shall be defined as selection of colors used throughout, such
2	as on the furnishings, permanent fixtures, and wall coverings, or as used on the facade.
3	(F) Facade shall be defined as the face or front of a building, including
4	awnings, looking onto a street or an open space.
5	(G) Uniform Apparel shall be defined as standardized items of clothing
6	including but not limited to standardized aprons, pants, shirts, smocks or dresses, hat, and pins (other
7	than name tags) as well as standardized colors of elothing.
8	(H) Signage shall be defined as business sign pursuant to Section 602.3 of the
9	Planning Code.
10	(2) "Retail Sales Activity or Retail Sales Establishment." For the purposes of
11	subsection (i), a retail sales activity or retail sales establishment shall include the following uses, as
12	defined in Article 7 and Article 8 of this Code: "Bar," "Drive-up Facility," "Eating and Drinking Use,"
13	"Liquor Store," "Sales and Service, Other Retail," "Restaurant," "Limited-Restaurant," "Take-Out
14	Food," "Sales and Service, Retail," "Service, Financial," "Movie Theater," and "Amusement and Game
15	Arcade."
16	(3) Conditional Use Criteria. With regard to a conditional use authorization
17	application for a formula retail use, the Planning Commission shall consider, in addition to the criteria
18	set forth in Subsection (c) above:
19	(A) The existing concentrations of formula retail uses within the district.
20	(B) The availability of other similar retail uses within the district.
21	(C) The compatibility of the proposed formula retail use with the existing
22	architectural and aesthetic character of the district.
23	(D) The existing retail vacancy rates within the district.
24	(E) The existing mix of Citywide-serving retail uses and neighborhood -
5	serving retail uses within the district.

1	(4) Conditional Use Authorization Required. A Conditional Use Authorization shall be
2	required for a Formula Retail use in the following zoning districts unless explicitly exempted:
3	(A) All Neighborhood Commercial Districts in Article 7;
4	
5	(C) All Urban Mixed Use Districts in Section 843;
6	
7	(E) Japantown Special Use District as defined in Section 249.31;
8	(F) Chinatown Community Business District as defined in Section 810.1;
9	
10	(H) Western SoMa Planning Area Special Use District as defined in 823;
11	(I) Residential Transit-Oriented Districts as defined in 206.4 and 206.5;
12	(J) Limited Conforming Use/Non-Conforming Use in RH-RM-RTO and RED
13	Districts.
14	(K) Third Street Formula Retail Restricted Use District, as defined in Section 786.
15	(5) Formula Retail Uses Not Permitted. Formula Retail Uses are not permitted in the
16	following zoning districts:
17	
18	
19	(C) Chinatown Visitor Retail District;
20	(D) Upper Fillmore District does not permit Formula Retail uses that are also
21	Restaurant or Limited-Restaurant uses as defined in Section 790.90 and 790.91;
22	
23	uses that are also Restaurant or Limited-Restaurant uses as defined in Section 790.90 and 790.91;
24	
25	

1	(F) Mission Street Formula Retail Restaurant Subdistrict does not permit Formula
2	Retail uses that are also Restaurant or Limited-Restaurant uses as defined in Section 790.90 and
3	790.91;
4	(G) Geary Boulevard Formula Retail Pet Supply Store and Formula Retail Eating
5	and Drinking Subdistrict does not permit Formula Retail uses that are also either a Retail Pet Supply
6	Store or an Eating and Drinking use as set forth in Section 781.4;
7	(H) Taraval Street Restaurant Subdistrict does not permit Formula Retail uses that
8	are also Restaurant or Limited-Restaurant uses as defined in Section 790.90 and 790.91;
9	(6) Neighborhood Commercial Notification and Design Review. Any building permit
10	application for a "formula retail use" as defined in this section and located within a Neighborhood
11	Commercial District in Article 7 shall be subject to the Neighborhood Commercial Notification and
12	Design Review Procedures of Section 312 of this Code.
13	(7) Change in Use. A change from one formula retail use to another requires a new
14	Conditional Use Authorization, whether or not a Conditional Use Authorization would otherwise be
15	required by the particular change in use in question. This Conditional Use Authorization requirement
16	also applies to changes from Formula Retail operator to another within the same use category. A new
17	Conditional Use Authorization shall not apply to a change in a formula use retailer that meets the
18	following criteria:
19	(A) the formula use operation remains the same in terms of its size, function and
20	general merchandise offering as determined by the Zoning Administrator, and
21	
22	purchased by another formula retail operator who will retain all components of the existing retailer,
23	including but not limited to the signage for the premises, the name of the premises and the general
24	merchandise offered on the premises.
`5	

1 The new operator shall comply with all conditions of approval previously imposed on the existing operator, including but not limited to signage programs and hours of operation; and shall 2 conduct the operation generally in the same manner and offer essentially the same services and/or type 3 of merchandise: or seek and be granted a new Conditional Use Authorization. 4 5 (8) Determination of Formula Retail Use. In those areas in which "formula retail uses are-prohibited, any building permit application determined by the City to be for a "formula retail use" 6 7 that does not identify the use as a "formula retail use" is incomplete and cannot be processed until the omission is corrected. Any building permit approved that is determined by the City to have been, at the 8 9 time of application, for a "formula retail use" that did not identify the use as a "formula retail use" is 10 subject to revocation at any time. If the City determines that a building permit application or building 11 permit subject to this Section of the Code is for a "formula retail use", the building permit application or holder bears the burden of proving to the City that the proposed or existing use is not a "formula" 12 retail use". 13 14 (jj) Large-Scale Retail Uses. With respect to applications for the establishment of 15 large-scale retail uses under Section 121.6, except for General or Specialty Grocery stores as 16 defined in Articles 2, 7 and 8, in addition to the criteria set forth in Subsections (c) and (d) 17 above, the Commission shall consider the following: 18 (1) The extent to which the retail use's parking is planned in a manner that creates or maintains active street frontage patterns; 19 20 (2) The extent to which the retail use is a component of a mixed-use project or 21 is designed in a manner that encourages mixed-use building opportunities; 22 (3) The shift in traffic patterns that may result from drawing traffic to the 23 location of the proposed use; and (4) The impact that the employees at the proposed use will have on the 24 demand in the City for housing, public transit childcare, and other social services -; and 25

1	(5) An economic impact study. The Planning Department shall prepare an economic
2	impact study using qualified eCity staff or shall select a consultant from a pool of pre-qualified
3	<u>consultants to prepare the economic impact study required by this Ssubsection. The analysis, in the</u>
4	form of a study, shall be considered by the Planning Commission in its review of the application. The
5	applicant shall bear the cost of paying the consultant for his or her work preparing the economic
6	impact study, and any necessary documents prepared as part of that study. The applicant shall also
7	pay an administrative fee to compensate Planning Department and City staff for its time reviewing the
8	study, as set forth in Section 359 of this Code. The study shall evaluate the potential economic impact
9	of the applicant's proposed project, including:
10	(A) Employment Analysis. The report shall include the following employment
11	information: a projection of both construction-related and permanent employment generated by the
12	proposed project,; an analysis of whether the proposed project will result in a net increase or
13	decrease in permanent employment in the impact area; and a discussion of whether the employer
14	of the proposed project will pay a living wage, inclusive of non-salary benefits expected to be provided,
15	relative to San Francisco's cost of living.
16	(B) Fiscal Impact. The report shall itemize public revenue created by the
17	proposed project and public services needed because of the proposed project, relative to net fiscal
18	impacts to the General Fund. The impacts to the City's public facilities and infrastructure shallshould
19	be estimated using the $e\underline{C}$ ity's current assumptions in existing nexus studies (including area plan,
20	transit, open space in-lieu fee and other impact fees), and should account for any contributions the
21	proposed project would make through such impact fee payments.
22	(C) Leakage Analysis Study. This portion of the report shall be twofold: both
23	quantitative and qualitative. The quantitative portion shall provide an analysis of whether the
24	proposed project will result in a net increase or decrease in the capture of spending by area residents
<u>`</u> 5	on items that would otherwise be purchased outside the area. The area to be studied for potential

1	economic impacts of the proposed project shall be determined by the City in consultation with the
2	expert conducting the study as different sizes of study areas would be pertinent depending on a
3	multitude of factors, including but not limited to, size and type of the proposed store. This quantitative
4	leakage analysis should be paired with a qualitative assessment of whether the proposed use would
5	complement existing merchandise selection in the area by adding greater variety of merchandise,
6	bolstering the strength of an existing retail cluster, or matching evolving consumer preferences.

BOARD OF SUPERVISORS

1	(1) Before the Planning Commission may consider an application for a
2	conditional use to relocate an existing lawfully permitted general advertising sign as
3	authorized by Section 611 of this Code, the applicant sign company must have:
4	(A) Obtained a current Relocation Agreement approved by the Board of
5	Supervisors under Section 2.21 of the San Francisco Administrative Code that covers the sign
6	or signs proposed to be relocated; and
7	(B) Submitted to the Department a current sign inventory, site map, and
8	the other information required under Section 604.2 of this Code; and
9	(C) Obtained the written consent to the relocation of the sign from the
10	owner of the property upon which the existing sign structure is erected.
11	(D) Obtained a permit to demolish the sign structure at the existing
12	location.
13	(2) The Department, in its discretion, may review in a single conditional use
14	application all signs proposed for relocation by a general advertising company or may require
15	that one or more of the signs proposed for relocation be considered in a separate application
16	or applications. Prior to the Commission's public hearing on the application, the Department
17	shall have verified the completeness and accuracy of the general advertising sign company's
18	sign inventory.
19	(3) Only one sign may be erected in a new location, which shall be the same
20	square footage or less than the existing sign proposed to be relocated. In no event may the
21	square footage of several existing signs be aggregated in order to erect a new sign with
22	greater square footage; provided however the square footage of one or more existing signs
23	may be disaggregated in order to erect multiple smaller signs with lesser total square footage.
24	(4) In addition to applicable criteria set forth in subsection (c) above, the
25	Planning Commission shall consider the size and visibility of the signs proposed to be located

(B) The factors set forth in this Subsection (B) shall weigh against the 21 Commission's approval of the proposed relocation: 22 23 (i) The sign or signs proposed for relocation are or will be obstructed, partially obstructed, or removed from public view by another structure or by 24 25 landscaping.

1	(ii) The proposed relocation site is adjacent to or visible from
2	property under the jurisdiction of the San Francisco Port Commission, the San Francisco
3	Unified School District, or the San Francisco Recreation and Park Commission.
4	(iii) The proposed relocation site is adjacent to or visible from an
5	Historic District or conservation district designated in Article 10 or Article 11 of the Planning
6	Code.
7	(iv) The proposed relocation site is within, adjacent to, or visible
8	from a zoning district where general advertising signs are prohibited.
9	(v) The proposed relocation site is within, adjacent to, or visible
10 [.]	from a designated view corridor.
11	(vi) There is significant neighborhood opposition to the proposed
12	relocation site.
13	(5) In no event may the Commission approve a relocation where:
14	(A) The sign or signs proposed for relocation have been erected, placed,
15	replaced, reconstructed, or relocated on the property, or intensified in illumination or other
16	aspect, or expanded in area or in any dimension in violation of Article 6 of this Code or without
17	a permit having been duly issued; or
18	(B) The proposed relocation site is not a lawful location under Planning
19	Code Section 611(c)(2); or
20	(C) The sign in its new location would exceed the size, height or
21	dimensions, or increase the illumination or other intensity of the sign at its former location; or
22	(D) The sign in its new location would not comply with the Code
23	requirements for that location as set forth in Article 6 of this Code; or
24	(E) The sign has been removed from its former location; or

(F) The owner of the property upon which the existing sign structure is
 erected has not consented in writing to the relocation of the sign.

(6) The Planning Commission may adopt additional criteria for relocation of general advertising signs that do not conflict with this Section 303(I) or Section 611 of this Code.

(Im) General Grocery Store Uses.

7 (1) With respect to a change in use or demolition of general grocery store use
8 as set forth in Sections 218.2, 703.2(b)(1)(B)(iii), 803.2(b)(1)(B)(iv) or 803.3 (b)(1)(B)(iii) which
9 use exceeds 5,000 gross square feet, in addition to the criteria set forth in Subsections (c) and

 not undermine the economic diversity and vitality of the surrounding neighborhood.

(1) With respect to a Tobacco Paraphernalia Establishment, as defined in

'2 (no) Massage Establishments. 13 (1) With respect to Massage Establishments that are subject to Conditional Use 14 authorization, as defined in Sections 218.1, 790.60, and 890.60 of this Code, in addition to the 15 criteria set forth in Subsection (c) above, the Commission shall make the following findings: 16 (A) Whether the applicant has obtained, and maintains in good standing, 17 a permit for a Massage Establishment from the Department of Public Health pursuant to Section 1908 of the San Francisco Health Code; 18 19 (B) Whether the use's facade is transparent and open to the public. Permanent transparency and openness are preferable. 5 open to perpendicular view and no more than six feet in height above grade;

6 (C) Whether the use includes pedestrian-oriented lighting. Well lit 7 establishments where lighting is installed and maintained along all public rights-of-way 8 adjacent to the building with the massage use during the post-sunset hours of the massage 9 use are encouraged:

(D) Whether the use is reasonably oriented to facilitate public access.
Barriers that make entrance to the use more difficult than to an average service-provider in
the area are to be strongly discouraged. These include (but are not limited to) foyers equipped
with double doors that can be opened only from the inside and security cameras.

(<u>op</u>) Eating and Drinking Uses.

(1) Conditional Use Criteria. With regard to a conditional use authorization
 application for a Restaurant, Limited-Restaurant and Bar uses in Neighborhood Commercial
 Districts or Mixed Use Districts, the Planning Commission shall consider, in addition to the
 criteria set forth in Subsection (c) above:

(A) The, the existing concentration of eating and drinking uses in the
 area. Such concentration should not exceed 25% of the total commercial frontage as
 measured in linear feet within the immediate area of the subject site. For the purposes of this
 Section of the Code, the immediate area shall be defined as all properties located within 300'
 of the subject property and also located within the same zoning district.

25 <u>SEC. 303.1. FORMULA RETAIL USES.</u>

1	(a) Findings.
2	(1) San Francisco is a city of diverse and distinct neighborhoods identified in large part
3	by the character of their commercial areas.
4	(2) One of the eight Priority Policies of the City's General Plan resolves that "existing
5	neighborhood-serving retail uses be preserved and enhanced and future opportunities for resident
6	employment in and ownership of such businesses enhanced."
7	(3) Retail uses are the land uses most critical to the success of the City's commercial
8	districts.
9	(4) Formula Retail businesses are increasing in number in San Francisco, as they are
10	in cities and towns across the country.
11	(5) San Francisco is one of a very few major urban centers in the State in which
12	housing, shops, work places, schools, parks and civic facilities intimately co-exist to create strong
13	identifiable neighborhoods. The neighborhood streets invite walking and bicycling and the City's mix of
14	architecture contributes to a strong sense of neighborhood community within the larger City
15	<u>community.</u>
16	(6) Notwithstanding the marketability of a retailer's goods or services or the visual
17	attractiveness of the storefront, the standardized architecture, color schemes, decor and signage of
18	many Formula Retail businesses can detract from the distinctive character and aesthetics of certain
19	Neighborhood Commercial Districts.
20	(7) The increase of Formula Retail businesses in the City's neighborhood commercial
21	areas, if not monitored and regulated, will hamper the City's goal of a diverse retail base with distinct
22	neighborhood retailing personalities comprised of a mix of businesses. Specifically, the unregulated
23	and unmonitored establishment of additional Formula Retail uses may unduly limit or eliminate
24	business establishment opportunities for smaller or medium-sized businesses, many of which tend to be
5	non-traditional or unique, and unduly skew the mix of businesses towards formula retailers in lieu of

unique or start-up retailers, thereby decreasing the diversity of merchandise available to residents and 1 visitors and the diversity of purveyors of merchandise. 2 (8) If, in the future, neighborhoods determine that the needs of their Neighborhood 3 Commercial Districts are better served by eliminating the notice requirements for proposed Formula 4 Retail uses, by converting Formula Retail uses into conditional uses in their district, or by prohibiting 5 Formula Retail uses in their district, they can propose legislation to do so. 6 (9) Neighborhood Commercial Districts are intended to preserve the unique qualities of 7 a district while also serving the daily needs of residents living in the immediate neighborhood; however 8 9 community members have reported loss of daily needs uses due to inundation of formula retailers that target larger citywide or regional audiences. The City strives to ensure that goods and services that 10 residents require for daily living are available within walking distance and at an affordable price. 11 12 Establishments that serve daily needs and formula retail establishments are neither mutually exclusive 13 nor completely overlapping. 14 (10) The San Francisco retail brokers' study of 28 nNeighborhood c-Commercial Districts conducted in 2014 found that the healthiest and most viable retail environments offer a mix 15 of retailers who vary in size and offerings; including a mix of conventional and cutting edge retailers as 16 17 well as established players and newcomers. (11) Formula retailers are establishments with multiple locations and standardized 18 features or a recognizable appearance. Recognition is dependent upon the repetition of the same 19 characteristics of one store in multiple locations. The sameness of Formula Retail outlets, while 20 21 providing clear branding for consumers, counters the general direction of certain land use controls and 22 General Plan Policies which value unique community character and therefore need controls, in certain areas, to maintain neighborhood individuality. 23 24 (12) The homogenizing effect of Formula Retail, based on its reliance on standardized branding, is greater if the size of the Formula Retail use, in number of locations or size of use or 25

1	branded elements, is larger. The increased level of homogeneity distracts from San Francisco's unique
2	neighborhoods, which thrive on a high level of surprise and interest maintained by a balanced mix of
3	uses and services, both independent and standardized.
4	(13) Due to the distinct impact that Formula Retail uses have on a neighborhood, these
5	uses are the evaluated for concentration as well as compatibility within a neighborhood. As
6	neighborhoods naturally evolve over time, changes and intensifications of Formula Retail uses should
7	also be re-evaluated for concentration and compatibility within a neighborhood.
8	(14) According to an average of ten studies done by the firm Civic Economics and
9	published by the American Independent Business Alliance in October of 2012, spending by independent
10	retailers generated 3.7 times more direct local spending than that of Formula Retail chains.
11	(15) Money earned by independent businesses is more likely to circulate within the
12	local neighborhood and City economy than the money earned by Formula Retail businesses which
13	often have corporate offices and vendors located outside of San Francisco.
14	(16) According to a 2014 Sstudy by the San Francisco Office of Economic Analysis
15	(OEA) report "Expanding Formula Retail Controls: Economic Impact Report" the uniqueness of San
16	Francisco's neighborhoods is based on a combination of unique visual characteristics and a sense of
17	community fostered by small merchants and resident relationships. A Formula Retail establishment is
18	determined by its recognizable look which is repeated at every location, therefore, detracting from the
19	unique community character.
20	(17) The OEA Report found that in general, chain stores charge lower prices and
21	provide affordable goods, but may spend less within the local economy, and can be unpopular with
22	some residents because they can be seen to diminish the character of the neighborhood. At the same
23	time, this OEA Report found that excessively limiting chain stores can reduce commercial rents and
24	raise vacancy rates.

1	(18) Through a 2014 study commissioned by the Planning Department, titled "San
2	Francisco Formula Retail Economic Analysis," staff and consultants conducted one-on-one interviews
3	and worked with small groups including independent retailers, small business owners, merchants
4	associations, formula retailers, commercial brokers, neighborhood representatives and other
5	<u>stakeholders. The Study found that landlords often perceive a benefit in renting to large established</u>
6	<u>chains, which landlords believe typically have better credit and can sign longer leases than local,</u>
7	independent retailers, lowering the risk that the tenant will be unable to pay its rent. The existing land
8	use controls for Formula Retail may create a disincentive for formula retailers to locate where the
9	formula retail controls apply.
10	(b) Definition. A Formula Retail use is hereby defined as a type of retail sales or service
11	activity or retail sales or service establishment that has nineteen <u>eleven or more other retail sales</u>
12	establishments in operation, or with local land use or permit entitlements already approved, located
13	anywhere in the world. In addition to the nineteeneleven establishments either in operation or with
14	local land use or permit entitlements approved for operation, the business maintains two or more of the
15	following features: a standardized array of merchandise, a standardized facade, a standardized decor
16	and color scheme, uniform apparel, standardized signage, a trademark or a servicemark.
17	(1) Standardized array of merchandise shall be defined as 50% or more of in-stock
18	merchandise from a single distributor bearing uniform markings.
19	(2) Trademark shall be defined as a word, phrase, symbol or design, or a combination
20	of words, phrases, symbols or designs that identifies and distinguishes the source of the goods from one
21	party from those of others.
22	(3) Servicemark shall be defined as word, phrase, symbol or design, or a combination
23	of words, phrases, symbols or designs that identifies and distinguishes the source of a service from one

1	(4) Decor shall be defined as the style of interior furnishings, which may include but is
2	not limited to, style of furniture, wall coverings or permanent fixtures.

5	(6) Facade shall be defined as the face or front of a building, including awnings,
6	looking onto a street or an open space.
7	(7) Uniform Apparel shall be defined as standardized items of clothing including but
8	not limited to standardized aprons, pants, shirts, smocks or dresses, hat <u>s</u> , and pins (other than name
9	tags) as well as standardized colors of clothing.

(f) Notwithstanding the foregoing provisions of this Section 178, a structure occupied 6 - by a permitted conditional use that is damaged or destroyed by fire, or other calamity, or by 7 8 Act of God, or by the public enemy, may be restored to its former condition and use without the approval of a new conditional use application, provided that such restoration is permitted 9 by the Building Code, and is started within 18 months and diligently pursued to completion. 10 Except as provided in Subsection (g) below, no structure occupied by a permitted conditional 11 use that is voluntarily razed or required by law to be razed by the owner thereof may 12 thereafter be restored except upon approval of a new conditional use application pursuant to 13 14 the provisions of Article 3 of this Code.

(g) None of the provisions of this Section 178 shall be construed to prevent any 15 measures of construction, alteration or demolition necessary to correct the unsafe or 16 17 dangerous condition of any structure, other feature, or part thereof, where such condition has 18 been declared unsafe or dangerous by the Superintendent of the Bureau of Building Inspection or the Chief of the Bureau of Fire Prevention and Public Safety, and where the 19 proposed measures have been declared necessary, by such official, to correct the said 20 21 condition; provided, however, that only such work as is absolutely necessary to correct the unsafe or dangerous condition may be performed pursuant to this Section. 22

Section 4. The Planning Code is hereby amended by revising Sections 182, 183 and
186.1 to read as follows:

SEC. 182. NONCONFORMING USES: CHANGES OF USE.

2 The following provisions shall apply to nonconforming uses with respect to changes of 3 use:

(b) Except as limited in this Subsection, a nonconforming use may be reduced in size,
extent or intensity, or changed to a use that is more widely permitted by the use districts of the
City than the existing use, subject to the other applicable provisions of this Code. Except as
otherwise provided herein, the new use shall still be classified as a nonconforming use.

16 (1) A nonconforming use in a Residential District (other than a Residential-Commercial Combined District), which use is located more than 1/4 mile from the nearest 17 Individual Area Neighborhood Commercial District or Restricted Use Subdistrict described in 18 Article 7 of this Code, may change to another use which is permitted as a principal use at the 19 20 first story and below in an NC-1 District, or it may change to another use which is permitted as 21 a conditional use at the first story and below in an NC-1 District only upon approval of a 22 conditional use application pursuant to the provisions of Article 3 of this Code. If the 23 nonconforming use is seeking <u>a</u> to change in use to a retail sales activity or retail sales 24 establishment which is also a *F*formula *R*retail use, as defined in Section 703.3303.1 of this 25 Code, it shall comply with the provisions of Section 703.3303.1 of this Code. The

nonconforming use shall comply with other building standards and use limitations of NC-1
 Districts, as set forth in Sections 710.10 through 710.95 of this Code.

If the nonconforming use is located within 1/4 mile from any Individual Area 3 Neighborhood Commercial District or Restricted Use Subdistrict described in Article 7 of this 4 5 Code, the nonconforming use may change to another use which is permitted as a principal use at the first story and below in an NC-1 District and in the Individual Area Neighborhood 6 Commercial District or Restricted Use Subdistrict or Districts within 1/4 mile of the use, or it 7 8 may change to another use which is permitted as a conditional use at the first story and below in an NC-1 District and in the Individual Area Neighborhood Commercial District or Districts 9 within 1/4 mile of the use only upon approval of a conditional use application pursuant to the 10 11 provisions of Article 3 of this Code. If the nonconforming use is seeking to change in use to a retail sales activity or retail sales establishment which is also a Fformula Rretail use, as '2 13 defined in Section 703.3303.1 of this Code, it shall comply with the provisions of Section 14 703.3 303.1 of this Code. The nonconforming use shall comply with other building standards and use limitations of NC-1 Districts and any Individual Area NC District or Districts located 15 within ¹/₄ mile of the use, as set forth in Article 7 of this Code. 16

17 (2) A nonconforming use in a Residential-Commercial Combined District may
18 be changed to another use listed in Articles 2 or 7 of this Code as a principal use for the
19 district in which the existing use would first be permitted as a principal or conditional use.

20 (3) A nonconforming use in a Neighborhood Commercial District may be
21 changed to another use as provided in Subsections (c) and (d) below or as provided in
22 Section 186.1 of this Code.

(4) A nonconforming use in any district other than a Residential, Downtown
 Residential, or Neighborhood Commercial District may be changed to another use listed in

Articles 2 or 7 of this Code as a principal use for the district in which the existing use would
 first be permitted as a principal use.

3 (5) A nonconforming use in any South of Market Mixed Use District may not be

5 hotel, motel, inn, hostel, or movie theater use in any district where such use is otherwise not
6 permitted or conditional, except as provided in Subsection (f) below.

(c) A nonconforming use may be changed to a use listed in Articles 2 or 7 of this Code
as a conditional use for the district in which the property is located, subject to the other
applicable provisions of this Code, without the necessity of specific authorization by the City
Planning Commission except where major work on a structure is involved, and the new use
may thereafter be continued as a permitted conditional use, subject to the limitation of Section
178(b) of this Code.

(d) A nonconforming use may be changed to a use listed in Articles 2, 7 or 8 of this
Code as a principal use for the district in which the property is located, subject to the other
applicable provisions of this Code, and the new use may thereafter be continued as a
permitted principal use.

17 (e) A nonconforming use in an R District subject to termination under the provisions of 18 Section 185 of this Code may be converted to a dwelling unit without regard to the requirements of this Code with respect to dwelling unit density under Article 2, dimensions, 19 20 areas and open space under Article 1.2, or off-street parking under Article 1.5, provided the 21 nonconforming use is eliminated by such conversion, provided further that the structure is not 22 enlarged, extended or moved to another location, and provided further that the requirements 23 of the Building Code, the Housing Code and other applicable portions of the Municipal Code 24 are met.

(f) Once a nonconforming use has been changed to a principal or conditional use 1 permitted in the district in which the property is located, or brought closer in any other manner 2 to conformity with the use limitations of this Code, the use of the property may not thereafter 3 be returned to its former nonconforming status, except that: 4

(1) Any area which is used as a live/work unit shall be allowed to return to its 5 former nonconforming status. 6

(2) Within any South of Market Mixed Use District, any area occupied by a 7 nonconforming office use which is changed to an arts, home and/or business service use 8 falling within zoning categories 102.2 or 816.42 through 816.47 or a wholesale, storage or 9 light manufacturing use falling within zoning categories 816.64 through 816.67 shall be 10 allowed to return to its former nonconforming office use. 11

12 (3) Upon restoration of a previous nonconforming use as permitted by Subsection (1) or (2) above, any modification, enlargement, extension, or change of use, from 13 circumstances which last lawfully existed prior to the creation of the live/work unit, or prior to 14 the change from office use, shall be subject to the provisions of this Article, and the restored 15 nonconforming use shall be considered to have existed continuously since its original 16 establishment, prior to the live/work unit or change to office use, for purposes of this Article. 17 18 (g) If a nonconforming use has been wrongfully changed to another use in violation of any of the foregoing provisions, and the violation is not immediately corrected when required 19 by the Zoning Administrator, the wrongful change shall be deemed to be a discontinuance or 20 21 abandonment of the nonconforming use under Section 183 of this Code.

(h) If a nonconforming use is a Formula Retail use in a District that prohibits Formula Retail 22 uses, the Formula Retail use is deemed abandoned if it is discontinued for a period of 18 months or

23 more, or otherwise abandoned. The Formula Retail use shall not be restored. 24

The following provisions shall govern with respect to nonconforming uses and features 1 located in Neighborhood Commercial Districts to the extent that there is a conflict between the 2 provisions of this Section and other Sections contained in this Article 1.7. 3

A nonconforming use may expand: (1) in floor area as provided in Subsection (b) below, but may not expand beyond the lot which it occupies, nor may the 5 boundaries of such lot be expanded for purposes of expanding the use; nor may the use 6 expand upward above the story or stories which it lawfully occupies, except as provided in 7 Section 186.2 below. 8

(b) Enlargements or Alteration.

- 23 (c) Changes in Use. A nonconforming use may be changed to another use or feature 24 as described below.

- (1) A nonconforming use may be changed to a use listed in Article 7 of this

(C) Any use described in zoning categories .57, .58 or .59, as defined in
Sections 790.14, 790.17 and 790.15 respectively, may be demolished and reconstructed as
the same use or may change to another use described in zoning categories .57, .58 or .59,
even though such other use is not permitted in that Neighborhood Commercial District.

(D) With regard to Formula Retail uses, a change of owner or operator of a 5 Formula Retail establishment is determined to be an intensification of use and a new Conditional Use 6 authorization shall be required as provided in Section 178(c) of this Code. if one or more of the 7 following occur: 8 (i) Change of use category, including a change from one use to 9 another within the sub-categories of uses set forth in Planning Code Section 790.102 and 10 Section 890.102: 11 (ii) Expansion of use size; 12 (iii) Change to a Formula Retail establishment that has more 13 locations than the existing Formula Retail establishment, which results in an increase in visual 14 homogeneity; 15 16 (iv) Installation of a commercial kitchen, including but not limited to: ovens, open ranges or stoves, fryers, oven hoods or kitchen ventilation systems, heating 17 18 stations, steam tables or cabinets, cold food storage, increased food preparation areas or self-19 service drink dispensers; (v) A pre-existing Formula Retail use which had not previously 20 21 been authorized via a Conditional Use from the Commission. 22 (4) In the North Beach Neighborhood Commercial District, any use that exceeds the use size provisions of Section 121.2(a) or 121.2(b) may be changed to a new use only 23 upon the approval of a new conditional use application. Section 6. The Planning Code is hereby amended by revising Section 145.2 to read as 15 follows: 16

SEC. 145.2. OUTDOOR ACTIVITY AREAS AND WALK-UP FACILITIES IN NC DISTRICTS. 17

18 The following provisions governing outdoor activity areas and walk up facilities shall

apply in NC Districts. 19

(a) Outdoor Activity Areas. In order to provide for limited commercial outdoor activity 20

21 areas, which promote active street life, but do not detract from the livability of surrounding

- 22 uses, outdoor activity areas, as defined in Section 790.70 of this Code, in NC Districts shall be
- regulated below, except in the Outer Clement Street Neighborhood Commercial District, 23
- where outdoor activity areas shall be a principal permitted use if they existed prior to 1985. 24

These provisions shall not apply to those uses excepted from the requirement for location in
an enclosed building, as set forth in Section 703.2(b) of this Code.

3 (a) (1) An outdoor activity area operated by a commercial use is permitted as a
 4 principal use if located outside a building and contiguous to the front property line of the lot on
 5 which the commercial use is located.

In NC-S Districts, an outdoor activity area is permitted as a principal use if located
within the boundaries of the property and in front of the primary facades which contain
customer entrances and if it does not obstruct pedestrian traffic flow between store entrances
and parking facilities.

(b)---(2) An outdoor activity area which does not comply with the provisions of
 Paragraph 1 of this Subsection is permitted as a conditional use, subject to the provisions set
 forth in Sections 316 through 316.8 of this Code.

In addition to the criteria of Section 303(c) of this Code, the City Planning Commission
 shall find that:

15 (1)—(4) The nature of the activity operated in the outdoor activity area is
 16 compatible with surrounding uses;

17 (2) (B) The operation and design of the outdoor activity area does not
